VGB Update

Anecdotal reports that we have received from local inspection agencies indicate that compliance with Iowa VGB rules is quite high. Most smaller swimming pools have been able to obtain the appropriate drain covers and SVRS and have them installed. Larger pools, including a number of municipal facilities, have had to wait for large drain covers to be available and for pool service companies to schedule installation. We expect most of these will be brought into compliance during the off-season.

A few pools have been temporarily closed. Usually the necessary parts have been purchased and installed quickly. Other facilities have disabled the main drain to get back into operation.

Spa Fittings

As of this writing we do not know of any direct replacement covers for most of the spa suction fittings previously installed (the round ones with all the holes, usually installed on the side of the foot well). In some circumstances, a spa will have more than one suction fitting for each pump, but the fittings are less than 3 feet apart on the same surface (technically, a single drain). Fittings for new installations are available, but replacing an existing fitting with a full new fitting usually would involve cutting into the spa wall, an expensive and potentially damaging procedure.

Existing spa fittings were tested and listed against a previous version of the ASME standard. The fittings passed tests for the prevention of hair and body entrapment. The new version of the standard requires increased fitting strength and UV resistance, but existing fittings typically are not subject to a heavy load and are normally indoors where there is little or no UV exposure.

IDPH will offer temporary variances for spas meeting specific criteria so that they can continue to operate until replacement fitting covers become available. The conditions for this variance are the following:

- 1. Each pump must draw from 2 or more fittings that are less than 3 feet apart.
- 2. The flow rating of the fittings must meet the design flow rate.
- 3. The fittings must be marked with a listing mark (NSF, UPC, UL) and the standard number (ASME A112.19.8M).
- 4. Each pump must be equipped with an SVRS.

A letter requesting the variance must be sent to the local inspection agency that will forward it to our office. The following information must be included:

- 1. The facility name and the spa registration number
- 2. The volume of the spa
- 3. The brand and model of the spa pump(s)
- 4. The brand, model and flow rating of the suction fittings
- 5. A drawing of the spa showing the location of the fittings
- 6. A schematic showing the spa plumbing
- 7. The brand and model of SVRS installed

We will respond as quickly as possible to these requests.

Shutting Off the Main Drain

If you are considering disabling a pool or spa main drain for VGB compliance, the rules, effective July 8, 2009, require that you request approval from IDPH

before you proceed. The information you must send to the IDPH is at 641 IAC 15.4(4)"h"(4) on numbered page 19 (PDF page 22) in the rules on the IDPH Web site at

http://www.idph.state.ia.us/eh/swimming_pools.asp (We are in the process of printing new booklets). Most pools built in the last 10 years or so could probably operated satisfactorily without an active main drain unless the pool has a spray or play feature or water slide that uses the main drain or surge tank as the water source.
