## **2008 legislative season gets underway**

During his January 15 [Condition of the State Address](#), Governor Culver introduced his FY 2009 budget recommendations and emphasized the need to address a number of health issues in 2008. The Governor proposed expanding health care for children, making health care more affordable and accessible, setting the standard for electronic medical records and telemedicine, increasing pay for nurses, and promoting healthy lifestyles. He also said that he would sign a bill to ban smoking at the local level. Governor Culver's final comment on the issue of health during his speech was one of "walking the walk;" in this case, encouraging state employees to participate in the 100-Day Culver/Judge Lighten Up Iowa Challenge. Thanks to the Governor's leadership, 1,541 State employees are now competing with one another in 221 weight loss and/or physical activity teams.

In terms of the Governor's budget for public health, Governor Culver has outlined \$75,000 in new funding for the Governor's Physical Fitness Challenge; accepted IDPH's request of \$900,000 in reallocated funds for healthy communities grants; proposed \$1 million of new funding for immunizations; and outlined \$400,000 to implement HF908 passed last session, which requires IDPH to establish a Plumbers and Mechanical Professionals licensing board. The new funding represents approximately a 4 percent increase in FY 2009 for IDPH compared to the previous year.

## **Calls to Quitline Iowa in 2008 already close to surpassing last year's total**

On January 1, IDPH began offering free nicotine patches and gum to Iowans who called Quitline Iowa (1-800-QUIT-NOW) for help breaking their addiction to cigarettes and spit tobacco. I am happy to say that in the first three weeks of 2008, Quitline Iowa has already received 5,031 calls, which is nearly the total number received during the entire 2007 fiscal year. More than 2,500 of those who called Quitline Iowa for help have requested the free nicotine patches or gum. Even more encouraging is that nearly 4,300 callers have enrolled in coaching services through Quitline Iowa, thereby greatly increasing their chances for success. Congratulations to the thousands of Iowans who have decided to make 2008 the year they say no to tobacco and yes to improved health.
