Modernization update

Thanks to the groundwork laid by the Iowa Public Health Modernization [Code Implementation Committee](#), Iowa stands poised to make the most significant changes to Iowa Code Chapter 137 since 1967. Recently the IDPH Executive Team reviewed a [draft proposal](#) for changes to this chapter, which governs local public health activities. Please look for your opportunity to provide feedback later this month. The department is also considering updates to Chapter 136, which governs the State Board of Health, to ensure integration with the [Public Health Modernization Act](#).

I recently sent out information regarding nominations to the Iowa Public Health Advisory Council and the Iowa Public Health Evaluation Committee. If you received an invitation as a member of a local board of health, the Iowa Public Health Association, the Iowa Environmental Health Association or the Iowa Counties Public Health Association, I encourage you to submit nominations by Aug. 12. Members will be announced later this month and meetings will begin in September.

Data Warehouse Update

The Iowa Public Health Data Warehouse has recently reached two major milestones. After spending many months gathering information from the [Data Warehouse Lead User Group](#), planners finalized a document in July that spells out the requirements of a new public Web interface. This interface will be designed to enable the public to view and access public health data more easily. New functionality will include the ability to generate reports on a particular health indicator in a specific county, and the ability to make comparisons with other counties or the state as a whole. With this step now complete, the technical team can now start designing and building the actual data warehouse system.

Working as a quality improvement mini-collaborative funded by the Robert Wood Johnson Foundation, [Data Warehouse User Group](#) members drafted several county health profiles that included the health indicators and demographic information needed to assess their community's health. Examples of health indicators might include the percentage of individuals who are overweight or obese, the percentage of lead poisoned children, or the rate of sexually transmitted diseases. Last month, representatives from each county involved in this important project came to a consensus on the content of the health profile, agreeing on demographic information and an initial set of 31 health indicators. Following a feasibility study these indicators will be made available for public comment.

IDPH program recognized by National Criminal Justice Association

Congratulations to the IDPH [Jail-Based Substance Abuse Treatment](#) project for being named the 2009 Outstanding Criminal Justice Program in the Midwestern Region. The award comes from the [National Criminal Justice Association](#), which cited the Iowa program's solid record of effectiveness in reducing criminal recidivism and substance abuse. The NCJA also called the program an outstanding example of using federal funds to establish a program and local funding to sustain it. The Jail-Based Substance Abuse Treatment provides treatment and follow-up case management to offenders in Polk, Scott, Story and Woodbury counties through close collaboration by those counties' sheriffs, jail staff, and community-based substance abuse treatment providers.
