New Formula in IWIN

Carnation Breakfast Essentials – No Sugar Added Ready to Drink was added to IWIN this week. It is a milk-based-reduced-carbohydrate liquid food for oral feeding. It is a diabetic formula for adult participants with a medical condition such as HIV or cancer when the use of a conventional food is precluded or restricted. This product comes packaged in 4 - 11 oz containers. Twenty – 4 packs are

WIC Help Desk Staff Announcement

EBT Update

The Iowa Department of Public Health Iowa WIC program has completed an analysis of the feasibility, alternatives, and costs of acquiring an EBT System. On February 27th, 2012 IDPH submitted the Iowa WIC EBT Feasibility Study Report produced by planning contractor Burger, Carroll and Associates (BCA), for Food and Nutrition Service (FNS) review in accordance with FNS requirements governing WIC program systems development and acquisition.

The Iowa WIC EBT Feasibility Report identified three EBT alternatives that could be affordable within the Iowa WIC Nutrition Services and Administration budget, including both online and offline platforms. It is clear from the feasibility study that a hosted system, rather than an in-house system, is more compatible with the Iowa WIC State Office staffing resources and budget. Therefore, it is the intent of IDPH to pursue a WIC EBT procurement approach based on system and support requirements rather than either an online or offline platform. By taking a platform –neutral approach to procurement, IDPH will determine the best EBT solution for distribution of Iowa WIC benefits based on the offerings of both platforms available in the open market.

Don't forget...



1) In the February 24th edition of Friday Facts, the "Don't Forget" article reminded all agencies that reasonable proof and documentation of current address at the initial and subsequent certification appointments is required. Don't forget that proof is only required at certification appointments but not at other appointments. Requiring proof at other appointments creates an undue burden and barrier to WIC participation.

2) Always create a <u>new</u> breastfeeding status each time a conversation takes place with a breastfeeding mom. This should always happen whether or not the food package is changed for the infant.
