Executive Director Update

Wow, it's hard to believe that April is here already. March has gone by very quickly and before I knew it Karith, e-Health's Communication Coordinator, was reminding me it's time to get the April edition of the e-Health Connection out.

This past month, Public Health Director Dr. Miller-Meeks, Deborah Thompson and I, along with many of Iowa e-Health's stakeholders, have worked with legislators at the Iowa House and Senate. The Iowa e-Health bill passed out of the Human Resources Committee and Ways and Means Committee in both the House and the Senate. On March 19, SF 2318 passed out of the full Senate and that version has since been taken up by the House for consideration. Amendments to reconcile both the Senate and House versions of the bill will be developed and we are hopeful that both chambers will agree on the details, allowing the bill to be sent to the Governor.

Iowa e-Health By the Numbers

lowa has been a national leader in the EHR incentive payment program. As of March 31, 2012, Iowa Medicaid has paid out \$40,569,459 to qualifying eligible professionals and hospitals. These payments represent 866 providers across the state who are benefiting from Iowa Medicaid's EHR incentive payment program. As of February 29, 2012, 373 Iowa providers have received incentive payments from the Medicare meaningful use program for \$26 million.

The Iowa Medicaid Enterprise is looking forward to continuing this momentum into 2012 by approving payments to providers applying for Year Two Meaningful Use payments beginning April 2. Providers have until 2016 to initiate participation in the incentive payment program. To find out if you qualify for incentives, contact Kelly Peiper, Iowa Medicaid HIT Coordinator,

Iowa e-Health's Privacy and Security Workgroup, led by Susan Brown (Telligen) and Tracy Donner (IDPH), has started meeting again. The group is holding biweekly calls to learn more about preferences for implementing a process by which patients may opt-out of having their health information exchanged through the IHIN. The group is considering ramifications of a global opt-out policy and an organizational/visit level opt-out policy with careful consideration to how either option would impact both providers and patients. Our goal is to minimize the burden of the opt -out process for everyone, while maintaining complete, confidential patient records.

The Iowa e-Health team continues work to develop contracts, policies and procedures needed to fully operationalize the IHIN. Under development are contracts such as the IHIN Participation Agreement, policies like those for interstate data sharing and information access, and many detailed procedures as well. We continue to examine our e-Health evaluation plan and how to evaluate the IHIN's role as a tool to improve health outcomes. Work continues also with our Early Adopters to gather technical information to prepare for IHIN connectivity. While several project milestones and deadlines are behind us, many still lie ahead and we must move forward effectively and efficiently with all of our partners to ensure

Training to Support Electronic Health Record Implementation

Des Moines Area Community College (DMACC), a member of the Midwestern Community College Consortium, has been granted an extension to provide training targeted for 100 individuals with previous medical or technical experience for roles that support the installation, implementation or management of EHR systems. A national curriculum, developed by five universities, and complemented by access to an EHR lab for hands-on experience, is designed to be completed in 6 months or less and leverages previous professional experience. Enroll now to be eligible for grant funding.
