Iowa HSEMD sends additional personnel to East Coast following Hurricane Sandy

Through the Emergency Management Assistance Compact (EMAC), the State of New Jersey recently requested the assistance of 35 qualified Public Assistance (PA) personnel to assist with PA operations in response to Hurricane Sandy. Iowa HSEMD was able to provide four personnel from the Recovery Bureau: Leon Freeman, Jim Grandquist, Jordan Moser and L.T. Smith.

The four were on the ground in New Jersey on Sunday, Nov. 25, and reported to their office location on Monday, Nov. 26.

Freeman, Grandquist, Moser and Smith will each be assigned to one of the following locations:



- Cumberland/Salem County (Bridgeton, NJ)
- Gloucester/Camden Counties (Clayton, NJ)
- Hunterdon/Warren Counties (Flemington, NJ)
- Sussex/Passaic Counties (Wayne, NJ)

State Hazard Mitigation Team Meets

On Nov. 15, 2012, The State Hazard Mitigation Team (SHMT) met to continue the process of updating lowa's State Hazard Mitigation Plan. Iowa Homeland Security and Emergency Management (HSEMD) is the lead agency in developing and writing the plan along with the SHMT, which is

an interagency team that provides input and technical assistance during this process.

The emphasis for this meeting was to review threat/hazard profiles and rankings identified in the plan. The team will meet again in early 2013. Ω

Public assistance funding in Iowa reaches nearly \$2 billion

Since 2007, Iowa has received 14 Presidential Disaster Declarations. As a result, local jurisdictions, the State of Iowa, and private relief organizations have incurred millions of dollars in emergency protection measure costs, and Iowans have suffered severe damage to our infrastructure.

Through its Public Assistance (PA) program, FEMA provides grants to aid public entities and certain pri-

vate nonprofit organizations in their effort to recover. The PA program allows for reimbursement—subject to a cost share—for emergency work performed to reduce or eliminate an immediate threat to life, protect public health and safety, and to protect improved property that is threatened as a result of the disaster. The PA program also allows for reimbursement—again, subject to a cost share—for the restoration of facilities to pre-disas-

ter design, function and capacity including upgrades necessary to meet current adopted codes and standards.

Since 2007, FEMA has awarded funding for 16,791 projects in lowa totaling more than \$1.7 billion. HSEMD Public Assistance staff continue to work with FEMA to approve and fund projects for open disasters. Ω

HSEMD's PA staff are not the only employees helping out on the East Coast. On Nov. 9, HSEMD Operations Specialist Frank Klier traveled to New Jersey following a request through EMAC. Klier is now back in lowa but continues to assist officials in that state.

In addition, Joyce Flinn, HSEMD's Readiness and Response Bureau Chief, has been actively engaged in daily EMAC conference calls since Oct. 27. On these calls, Flinn and representatives of other EMAC member states receive situational updates, learn of any resource shortfalls, and identify resources to fill the needs of the impacted states.

EMAC is administered by the National Emergency Management Association and facilitates the effective and efficient sharing of resources among member states when they are impacted by catastrophic disaster events.
