For the past several weeks, major influenza surveillance indicators have been decreasing; however, influenza activity is expected to continue until late March or April. School outbreaks are still occurring around the state. Please continue to promote the use of the Three Cs (Clean hands frequently; Cover coughs and sneezes; and Contain germs by staying home when ill) as the flu activity decreases and remember, it is never too late to vaccinate.

CDC advisory about Carbapenem-Resistant Enterobacteriaceae (CRE)

CREs are untreatable or difficult-to-treat multidrug-resistant organisms emerging in the U.S. Iowa laboratories have identified at least 20 CRE isolates in the last three years.
