Policy

From the WIC Certification Policy and Procedure Manual – Policy 215.30 – New Today Terminations

New Today terminations automatically set the effective date to today's date. This date cannot be changed by the user.

New Today terminations are appropriate for these reasons:

- Moved out of state (as evident from returned mail or a request for VOC data)
- Deceased
- Provisionally certified participants who returned within 30 days with proof of income and were found to be over the income guidelines
- Change from Breastfeeding or Not breastfeeding to Pregnant status

The last example is not a program termination. It is the data system procedure required to change the woman's categorical status to certify her as a pregnant woman.

Follow the steps below when completing a New Today Termination in IWIN.

Step	Action				
1	Click on the New Today button in the Termination group box.				
2	Select the appropriate termination reason from the drop down list.				
3	Save.				
4	 If the reason for termination was provisionally certified participant who was found to be over income upon returning with proof, Click on the Print Term Notice button in the Terminations group box. Print a second copy of the notice. Fill in the effective date of the termination on both copies using a month/day/year format. Check the appropriate reason for termination on both copies. Give one copy to the participant or parent/guardian. File the second copy by the month the participant will be terminated. 				

It is not necessary to print notices if the participant moved out of state or is deceased; the termination reason in the data system is adequate documentation.

Did you know

Is that formula USDA Approved?

Before the state office can authorize a formula to be issued by the local agency for a WIC participant the formula manufacturer must receive approval from the USDA. If the formula company has not done this or the USDA denied approval then we as a state cannot issue WIC benefits for that formula.

If you have a formula script presented to you and you do not see the formula available in IWIN your first step should be to see if it is USDA approved. This information can be found at the WIC Works website

(<u>http://wicworks.nal.usda.gov/</u>). Click on the Databases hyperlink and then select the

Formula Database hyperlink. From there you can search for the formula by Keyword, Manufacturer, Physical form, Participant Category, or even Use in WIC. This is also the place to look to verify the participant type the formula has been approved for, i.e. some formulas are approved for infants, some for children etc. If you have a situation in which a formula that is in the IWIN system will not verify and you are getting an error message that there is not a food rule it could be because that formula is not approved for that participant type.

Once you determine it is approved for the participant type you are seeking it for the next step would be to complete a <u>lowa WIC Formula Application</u> that can be found on the WIC web portal under "Resources" and submit it to your nutrition consultant for authorization.

This information includes the manufacturer, description, indication of use, container size, reconstitution amount and maximum allowable cans per FI. If you are printing this for use in disconnected clinics, please remember to check back frequently to make sure you have the most current products and information.
