Policy

From the WIC Services Policy and Procedure Manual -215.72 Blood-Drawing Techniques

Collect blood from the applicant's ring or middle finger. The following tips may help you collect a sufficient blood sample:

- Apply a warm cloth or compress to the applicant's finger before cleaning it.
- Ask the applicant to hold hand down and make a fist several times.
- Poke the fleshy part of the finger; the side is usually best.

Two methods for holding the applicant's hand comfortably and safely are:

- Hold the applicant's entire hand with a firm palm-to-palm grip, or
- Hold the applicant's selected finger with your thumb and forefinger.

Within the pages of this website you will find instructions for the most efficacious use of the Toolkit, additional resources and links, as well as interactive components such as quizzes and models.


Sexual Assault Prevention Campaign

A new sexual assault prevention campaign targeting American Indian and Alaska Native Youth is now available. It is titled "My Body, Mind, and Spirit Are Sacred. Prevent Sexual Assault". The goal of the campaign is to empower community members to stand up against sexual assault.

In many American Indian (AI)/Alaska Native (AN) communities, sexual assault rates are at epidemic levels. It's reported that one in three AI/AN women will be sexually assaulted in their lifetime and one in eight men will be sexually assaulted in his. The My Body, Mind, and Spirit Are Sacred campaign was developed by the Northwest Portland Area Indian Health Board (NPAIHB) and the Indian Health Service's Division of Behavioral Health to help communities address this concern.

ESSENTIAL FUNCTIONS:

Responsible and accountable as the competent professional authority for determination of Women, Infants, and Children (WIC) Program eligibility and certification based on nutritional risk. Provide nutrition assessment, education, referral, and care coordination services. Provide nutrition services to Maternal Health and other SDHD public health programming. Reports directly to Nutrition Director.

APPLICANTS MUST MEET THE FOLLOWING REQUIREMENTS:

Must possess Bachelor's Degree in nutrition, dietetics, food systems management or closely related field. Must possess Dietitian License as issued by the lowa Board of Dietetic Examiners, or able to obtain license within 6 months of employment. Current Dietetic registration preferred through the Commission on Dietetic Registration for the Academy of Nutrition and Dietetics or eligible to take the registration exam, which must be completed within 6 months of employment. A minimum of 1 year experience in general dietetics is desired with experience in maternal/child nutrition preferred. Computer skills required. Must be a resident of lowa or willing to relocate; must have valid Driver's License, ability to obtain car insurance at agency specified liability level, & reliable transportation. Physical ability to lift 50 lbs. A completed County application form, a resume, a copy of transcripts or diploma, and a copy of current Dietitian License (if applicable) are required.
