BACKGROUND AND INTRODUCTION

Brief Overview

The issue of effectively holding juveniles accountable for criminal behavior is a topic of public concern and debate. Congress created the Juvenile Accountability Incentive Block Grant (JAIBG) program and appropriated new federal funds through the Office of Juvenile Justice and Delinquency Prevention (OJJDP). The goals of the program are to reduce juvenile delinquency, improve the juvenile justice system, and increase accountability for juvenile offenders.

The State of Iowa has received a JAIBG award in the amount of \$2,895,700. The Division of Criminal and Juvenile Justice Planning (CJJP) is the state-designated agency to receive the federal funds. This report explains the process developed to allocate the funds to communities, and describes the programs developed and implemented by the communities to address their juvenile accountability issues.

Congress has appropriated funding for JAIBG's second year (2000 – 2001). Iowa's allocation will be \$2,898,200.

Background

The Juvenile Accountability Incentive Block Grant (JAIBG) program is based on Title III of H.R 3, The Juvenile Accountability Block Grants Act of 1997, as passed by the House of Representatives on May 8, 1997. Congress authorizes the Attorney General to provide grants under the JAIBG program for use by the States and units of local government to promote greater accountability in the juvenile justice system. The Office of Juvenile Justice and Delinquency Prevention (OJJDP), one of five program bureaus in the Office of Justice Programs, has been delegated the authority to administer the JAIBG program.

What is "Accountability for Juvenile Offenders"?

According to Juvenile Accountability: News & Views (March/April, 1999), "Accountability in juvenile justice means assuring that as a result of their wrongdoing, juvenile offenders face individualized consequences that make them aware of and responsible for the loss, damage, or injury perpetrated upon the victim. This is best achieved through a system of graduated sanctions which are imposed surely and swiftly. Graduated sanctions are defined in relation to the nature and seriousness of the offense, moving from limited interventions and treatment to more restrictive actions and increasing levels of treatment if the juvenile offender continues delinquent activities."

Program Purpose Areas

To address the spectrum of needs in developing programs that promote greater accountability in the juvenile justice system, JAIBG funds are available in the following 12 program purpose areas.

- **Purpose area 1:** Building, expanding, renovating, or operating temporary or permanent juvenile correction or detention facilities, including training of correctional personnel.
- **Purpose Area 2:** Developing and administering accountability-based sanctions for juvenile offenders.
- **Purpose area 3:** Hiring additional juvenile judges, probation officers, and court-appointed defenders, and funding pre-trial services for juveniles, to ensure the smooth and expeditious administration of the juvenile justice system;
- **Purpose area 4:** Hiring additional prosecutors, so that more cases involving violent juvenile offenders can be prosecuted and backlogs reduced;
- **Purpose area 5:** Providing funding to enable prosecutors to address drug, gang, and youth violence problems more effectively;
- **Purpose area 6:** Providing funding for technology, equipment, and training to assist prosecutors in identifying and expediting the prosecution of violent juvenile offenders;
- **Purpose area 7:** Providing funding to enable juvenile courts and juvenile probation offices to be more effective and efficient in holding juvenile offenders accountable and reducing recidivism;
- **Purpose area 8:** The establishment of court-based juvenile justice programs that target young firearm offenders through the establishment of juvenile gun courts for the adjudication and prosecution of juvenile firearms offenders;
- **Purpose area 9:** The establishment of drug court programs for juveniles so as to provide continuing judicial supervision over juvenile offenders with substance abuse problems and to provide the integrated administration of other sanctions and services;
- **Purpose area 10:** Establishing and maintaining interagency information-sharing programs that enable the juvenile and criminal justice system, schools, and social services agencies to make more informed decisions regarding the early identification, control, supervision, and treatment of juveniles who repeatedly commit serious delinquent or criminal acts;
- **Purpose area 11:** Establishing and maintaining accountability-based programs that work with juvenile offenders who are referred by law enforcement agencies, or which are designed, in cooperation with law enforcement officials, to protect students and school personnel from drug, gang, and youth violence; and,
- **Purpose area 12:** Implementing a policy of controlled substance testing for appropriate categories of juveniles within the juvenile justice system.

State Eligibility Requirements

- In order to be eligible for these funds, the Governor must certify that Iowa is actively considering, has actively considered within the last three years, or will consider within one year, legislation, policies or practices to ensure that:
 - a) Juveniles who commit a serious violent crime after the age of 15 are treated as adults for purposes of prosecution or that the prosecutor has the authority to determine whether to prosecute such juveniles as adults;
 - b) Sanctions are imposed for every adjudicated delinquent act or violation of probation, and that such sanctions escalate in severity with each subsequent, more serious delinquent act or violation of probation;
 - c) Delinquent history information must be maintained on juveniles adjudicated for a felony crime subsequent to a prior adjudication for a felony crime such information is to be maintained in a system equivalent to criminal history records systems for adults; and
 - d) State laws must not prevent court orders or sanctions against parents regarding the supervision of a juvenile offender.

Iowa has met these mandates. Current law addresses some of the mandates. To address the remaining mandates, during the 1999 legislative session, CJJP prefiled a bill, which was presented to the Iowa legislative leadership for consideration. The bill addressed the issues, and if passed would have modified the Iowa Code to assure implementation of the above issues. According to the federal guidelines for this grant program, consideration by the legislative leadership constitutes "active consideration."

• In addition, the state must have implemented (not just actively considered) a policy of controlled substance testing for appropriate categories of juveniles within the juvenile justice system by January of 1999.

Iowa has met this mandate. CJJP submitted a *Controlled Substance Testing Policy of Appropriate Categories of Juveniles within the Juvenile Justice System*, which in essence is a summary of practices, policies, and laws that were in existence prior to the federal mandate. A summary of the submitted policy is as follows:

- a. The State Training School has a policy to test all juvenile returning from an unsupervised leave from the Training School.
- b. Iowa Code, section 321J.6, states in part that all persons operating a motor vehicle are deemed to have given consent to the withdrawal of specimens of their blood, breath, or urine for the purpose of determining alcohol concentration or presence of drugs, when circumstances give peace officers reasonable grounds to believe that the person has been operating a vehicle while under the influence of alcohol or a drug. The law applies to all persons who operate a motor vehicle, including juveniles.
- c. Juvenile Courts have the discretion to order drug testing on adjudicated offenders and juveniles alleged to have committed an offense. This is a discretionary practice.

OJJDP has recognized the above policy. No new legislation or policy changes were necessary.

• A 10% cash match is required for these federal funds. The State has provided the match with the increased funds for the expansion of the State Training School in Eldora and the Iowa Juvenile Home, Girls State Training School in Toledo.

Local Pass-Through of Funds

JAIBG guidelines specify that a percentage of the funds will pass-through directly to units of local government (cities and counties). OJJDP has approved 27% of the funds to be distributed to units of local government, based on financial analysis demonstrating the State's financial burden for the administration of juvenile justice as 73%. The distributions to units of local government are based on a formula of the combination of law enforcement expenditures and the annual number of Uniform Crime Report part 1 violent crimes reported by each unit of local government for the most recent year for which data are available. Units of local government whose allocations are at least \$5,000 qualify for a direct allocation. A total of 28 units of local government qualify. Units of local government receiving these funds must form Juvenile Crime Enforcement Coalitions and submit plans that address one or more of the JAIBG Program Purpose Areas. A total of \$498,060 has been allocated to the 28 units of local government. The States' distribution of funds (see below) shall include services provided in lieu of a subgrant award to local units of government that do not qualify for at least \$5,000 in any fiscal year.

State JAIBG Plan

The State portion (73%) has been expended in a manner consistent with the Congressional intent of being responsive to the particular needs of local communities. The following approach has been developed with input from the chief juvenile court officers, decategorization coordinators, Iowa League of Cities, Iowa State Association of Counties (ISAC), Iowa Association of Sheriffs and Deputies, and the Iowa Association of Chiefs of Police, along with the Juvenile Justice Advisory Council, and the Criminal and Juvenile Justice Planning Advisory Council.

- \$1,850,000 has been allocated to the 39 Decategorization (decat) Governance Boards and to Ida County. The entities submitted plans to CJJP for approval and for authorization of allocations. The allocations to the decats is based on the formula of child population ages 5-17, as used for Department of Human Services (DHS) delinquency funds, and must be expended in one or more of the 12 program purpose areas. The decat governance boards were required to invite representatives from law enforcement, county attorney's office, and city government within their decat area to participate in the planning for the JAIBG funds, in addition to the required juvenile court, DHS, and county representatives. For the decat governance boards, the JAIBG plan will become part of their annual child welfare and delinquency plan. The decats have the option to combine funds with a unit of local government or another decat and develop one JAIBG plan.
- \$249,869 was awarded through the existing Juvenile Justice and Prevention Programs request for application (RFA) process specifically for a juvenile drug court. The recipient of that grant is the Polk County Attorney's office. The RFA is part of the Coordinated Juvenile Justice and Prevention Programs available through CJJP.

The State Plan has been adopted and filed as a Rule in the Iowa Administrative Code (428 - 5).

Who Qualified for JAIBG Funds?

A total of 69 entities qualified for \$2,597,955 of JAIBG funds based on the federal guidelines and the State Plan. Of the 69 entities, 39 are decategorization (decat) projects, one (1) is a county (Ida County) that is not participating in the decategorization process, 28 are the qualified units of local government (18 cities and 10 counties), and one (1) competitive grant recipient for a pilot juvenile drug court (Polk County). The decat projects represent 98 of the 99 counties in Iowa. An allocation is also being awarded to Ida County (non-decat), which allows the JAIBG funds to be distributed statewide.

Projects Funded by JAIBG

The JAIBG program provides both new challenges and new opportunities for the juvenile justice system. The challenge is to rethink the mission of the system, develop and implement new programs, and coordinate and collaborate with others. Success will require strong leadership, additional staff resources and training, and an increased focus on monitoring services and evaluating outcomes.

The State Plan has allowed great flexibility for the local planning of these additional resources for the juvenile justice system. Below are descriptions of the types of projects created and enhanced with JAIBG funds.

School-Based Programs – Purpose Area #11 Total JAIBG funds: \$458,647

Fourteen (14) JAIBG recipients prioritized school-based services in a variety of ways. More JAIBG funds are allocated for school-based services than any other category. The majority of the school-based services are in one of the three following areas:

- School-Based Juvenile Court Liaison Officers JAIBG Total: \$90,032 Expansion of the partnerships between schools and juvenile court services by placing liaison officers in more schools. The officers provide supervision and monitoring of juvenile offenders in the school setting.
- School Resource Officers JAIBG Total: \$39,983 Uniformed police officers provide educational programs, additional patrolling on school grounds, enhanced communication with school personnel, develop positive rapport with students, and respond to situations requiring law enforcement intervention.
- School Intervention Programs JAIBG Total: \$328,632 Communities have struggled with appropriate interventions for students who are juvenile offenders and not making an effort in school; act violently; create an atmosphere of intimidation, harassment, or fear; and juvenile offenders transitioning back to the community from out-of-home placement. Programs to address these issues include:
 - 1. Several communities are creating or enhancing an off-site setting to supervise, tutor, and provide life skill opportunities for suspended students.
 - 2. After School Tutoring for juvenile offenders.
 - 3. Case manage juvenile offenders transitioning back to the community from out of home placement.
 - 4. Case manage elementary students exhibiting aggressive and delinquent behaviors in school.

Inter-Agency Information Sharing – Purpose Area #10 Total JAIBG funds: \$382,984

Twelve (12) recipients are developing better ways to communicate among community agencies to share information. A need to share juvenile offenders' information between law enforcement, juvenile court services, schools, and social service providers has been identified as necessary to provide a more efficient method of delivery of services. Computer and technological equipment will be purchased to assist the implementation of the information sharing initiatives. In addition, to address some of the issues surrounding this issue, recipients are conducting feasibility studies to identify needs and requirements, to clarify purposes of shared information, to take inventory of existing systems, and to identify potential interfaces between systems.

Substance Abuse Issues – Purpose Area #7

Total JAIBG funds: \$372,552

Fifteen (15) JAIBG recipients prioritized substance abuse issues in one of three areas listed below:

- <u>Substance Abuse Testing JAIBG funds: \$50,034</u> Trackers, school liaison officers, and juvenile court services will administer "random" or "as needed" alcohol and/or drug tests on juvenile offenders on probation or informal adjustment. The following equipment/supplies are necessary for alcohol and controlled substance testing:
 - 1. Preliminary breath test (PBT) can determine if alcohol is presently being consumed;
 - 2. A refractometer determines if a person attempted to flush a drug from one's system, in an effort to give a false negative drug screen result.
 - 3. Drug screens (urinalysis) and diagnostic laboratory results.
- <u>Substance Abuse Treatment</u> <u>JAIBG Total:</u> \$72,649 Juvenile offenders and their families with substance abuse issues will receive chemical dependency evaluations, individual therapy sessions, and group therapy sessions, relevant to their specific needs.
- <u>Juvenile Drug Court</u> JAIBG Total: \$249,869 Polk County Attorney's Office was awarded the contract for the pilot juvenile drug court. The application process was competitive. The Polk County Plan is a holistic approach of blending existing treatment components with constant judicial monitoring, immediate consequences, intensive probation supervision, and lengthy aftercare. Drug court staff coordinate community resources to meet cultural and gender-specific needs. By graduation (12-18 months), juvenile offenders will have the skills and support system to remain drug free. In addition, CJJP has received a Bureau of Justice Statistics grant to initiate a process and outcome evaluation for the project.

Restorative Justice Programs – Purpose Area #2 Total JAIBG funds: \$368,794

Many of the JAIBG applicants prioritized services that will hold juvenile offenders accountable while restoring the victims' loss and benefiting the community. The following types of programs are being implemented or enhanced:

- <u>Community Service/Restitution Programs JAIBG Total: \$242,599</u> Fourteen (14) JAIBG recipients have developed community service and restitution programs. Either the services are contracted to a private agency or staff will be retained to supervise the youth at their work sites completing community service and/or earning restitution for their victim, and to recruit additional work sites.
- <u>Victim-Offender Mediation</u> JAIBG Total: \$126,195 Seven JAIBG recipients have developed victim-offender mediation programs, which allows victims to share their perspective of the crime committed against them by the juvenile. In addition, an agreement is sought between the victim and offender on the actions necessary to restore the victim and community. Staff will be retained to coordinate the activities.

Tracking, Intensive Supervision, Day Treatment, Probation Violation Programs Purpose Area #2 JAIBG funds: \$365,757

Nine JAIBG recipients are expanding existing community based graduated sanctions. The following programs are currently serving juvenile offenders. However, additional need has been identified for these services:

- <u>Day Treatment</u> JAIBG Total: \$130,635 Provides a community-based supervised setting, typically 7:00 a.m. to 8:00 p.m., for juvenile offenders unable to function in school, at home, and/or in the community. This model is a graduated sanction prior to out of home placement.
- <u>Tracking and Electronic Monitoring JAIBG Total: \$212,032</u> Maintain control of juvenile offenders whereabouts without using detention or shelter care. The tracker has daily contact with the juvenile offenders. Provides intensive supervision of juvenile offenders.
- Weekend Supervision Programs JAIBG Total: \$23,090 Juvenile offenders who have been in violation of their probation will experience timely and appropriate consequences by being required to attend a 3 5 hour supervised, restricted setting on Friday and Saturday evenings (6:00p.m. to 11:00 p.m.). Staff will engage the offenders in life skill activities.

Juvenile Detention and/or Correctional Facilities – Purpose Areas #1 and #2 Total JAIBG funds: \$279,219

Ten (11) recipients are utilizing JAIBG funds for juvenile detention or correctional facility issues. The two major areas are:

- <u>Construction #1 JAIBG Total: \$148,022</u> Brick and mortar for juvenile detention or correctional facilities. Includes renovation, expansion, and improvement of existing facilities.
- **Buy-in to Juvenile Detention Consortiums** #2 JAIBG Total: \$115,302 To ensure availability of detention beds for juvenile offenders.

Other projects for juvenile detention centers include training of correctional personnel and indigent medical care/prescription drug expenses, with JAIBG total of \$15,895.

Early Intervention – Purpose Areas #7 and #11 Total JAIBG funds: \$186,119

Four recipients have implemented early intervention projects. Intervention services provide immediate short-term services for young juvenile offenders and their families, referred by and/or liaisons with law enforcement agencies. Another project has ACTION teams that identify service gaps for neighborhood juvenile offenders and design the appropriate services.

Life Skills – Purpose Area #7

Total JAIBG funds; \$79,943

Seven (7) recipients have enhanced or implemented life skill projects for juvenile offenders. The themes of the projects include:

- Anger Management
- Shoplifting Diversion
- Job Skills
- Self-Esteem / Responsibility / Goal Setting / Social and Inter-Personal Skill Development

After-Care Services – Purpose Area #7

Total JAIBG funds: \$75,600

Two (2) sites are creating services for juvenile offenders returning to the community from out of home placements. The two approaches are:

- One recipient has initiated a project coordinating services for female juvenile offenders returning to the community from the State Training School for Girls in Toledo and other residential facilities. Gender Specific activities are included in the services.
- Another recipient is utilizing a support center approach, which includes tutoring services and a computer center for the juvenile offenders transitioning home from out of home placement.

Prosecution Assistance – Purpose Area #6

Total JAIBG funds: \$10,000

One recipient is purchasing equipment to allow for the enhancement of evidence presentations for juvenile court evidentiary hearings.

Staff Training – Purpose Area #7

Total JAIBG funds: \$9,620

Two recipients are providing training for juvenile court services officers, social workers, mental health practitioners, educators, substance abuse counselors, law enforcement, and juvenile detention staff on the subjects of Character Education and Truthoughts corrective thinking.

All of the projects are described in the JAIBG Project Summaries section of this document.

The attached summaries are listed alphabetically by county and/or by decategorization area. Use the County Index (next page) to find the page numbers for the respective counties. The summaries will specify the recipient of funds, the contact person, the amount of the JAIBG award, the purpose area, and a description of the project(s). For the multi-county decats (clusters), the counties will remain as a cluster in the listing.

Several of the qualifying entities chose to combine their funds with another qualifying unit of government or decat, to coordinate the local efforts. In communities where JAIBG funds are combined, the entity chosen to be the recipient for these funds will be listed as the lead entity of the project. The collaborating entities and the individual allocations will be listed, along with the total funds for the local project(s).

This three county decat cluster is under the supervision of two separate juvenile court services offices. The JAIBG Plan is divided to coincide with the juvenile court services areas.

- Adams and Union Counties are part of an eight county juvenile court services area. One JAIBG Plan was developed for the eight county area. The other counties are Clarke, Decatur, Lucas, Ringgold, Taylor, and Wayne. The Plan has two main components:
 - 1. <u>Community Service / Victim Restitution #2</u> Community Service Supervisors will oversee the juvenile offenders as they complete required community service work and the additional hours required to repay the victim.

The juvenile court officers will refer 15-17 year old juvenile offenders, who are at-risk of dropping out of school and/or do not have the skills to obtain and maintain a job. The JAIBG allocation for this project is \$28,140.

Electronic Monitoring and Tracking #2 – A sanction for juvenile offenders on probation, who have violated probation; and to monitor juvenile offenders, who are home on a visit from a residential treatment facility. Also, trackers will be used to monitor the youth. The JAIBG allocation for this project is \$7,500.

A Polk County Community Planning Board was formed to establish a Juvenile Drug Court and identify youth that would otherwise suffer from a gap of services. The approach blends existing treatment with constant judicial monitoring, immediate consequences, intensive probation supervision, and aftercare. Drug court staff coordinate community resources to meet cultural and gender-specific needs. It is estimated that 30 juvenile offenders, between the ages of 12 and 16 years, will receive services during the first year. The Comprehensive Strategy for Polk County Youth, which has recently been completed, served as the guiding framework for the development of the JAIBG Plan. As a result of the approaches recommended in the Comp Strategy plan, Polk County Decat will concentrate the efforts of the JAIBG Plan towards the following two areas:

Managed Information System #10 – Development of a county-wide computer information system that establishes links between Juvenile Court, law enforcement, Department of Human Services, education, and providers. The primary focus of the first year will be to conduct a feasibility study to identify needs and

requirements, purposes of shared information, inventory of existing systems, potential interfaces between existing systems, determine data elements and parameters of a system, and develop system design. It is anticipated that equipment needs, both hardware and software, will be identified through the process. The associated costs to support the infrastructure will also be identified. The feasibility study should be completed within a 9-10 month timeframe, in order to allow for implementation of the recommendations of the study during the last few months. The JAIBG allocation is \$158,794.

- Southwest Iowa Juvenile Detention Center #1 The decategorization projects in the 4th Judicial District have agreed to pool their JAIBG funds for the purpose of expanding the Southwest Iowa Juvenile Detention Center. The current facility houses up to 10 juveniles. The expansion will add 15 beds to the facility. The JAIBG allocation is \$126,848. This is the total allocation from the Cass/Mills/Montgomery, Monona/Harrison/ Shelby, and Pottawattamie Decats. The Fremont/Page/Taylor Decat split their allocation. Fremont and Page County portions are part of the funds for the detention center. In addition, the Audubon County portion of JAIBG funds (\$4,087) will be expended for the detention center, which results in a total of \$130,935. The JAIBG guidelines require that when funds are used to construct, renovate, or expand a juvenile detetention or correctional facility, that the State or local entity must provide at least 50% of the total cost of the project. Pottawattamie Co. will document the requirement.
- Taylor County is part of an eight county juvenile court services area. One JAIBG Plan was developed for the eight county area. The other counties are Adams, Clarke, Decatur, Lucas, Ringgold, Union, and Wayne. The Plan has two main components:
 - 1. <u>Community Service / Victim Restitution #2</u> Community Service Supervisors will oversee the juvenile offenders as they complete required community service work and the work required to repay the victim.
 - 2. <u>Alcohol and Drug Testing #7</u> Trackers, school liaison officers, and juvenile court services will administer "random" or "as needed" alcohol and/or drug tests on juvenile offenders on probation or informal adjustment. The testing that will be available is:
 - A. Preliminary breath test (PBT) can determine if alcohol is presently being consumed;
 - B. A refractometer determines if a person attempted to flush a drug from one's system, in an effort to give a false negative drug screen result.
 - C. Drug screens (urinalysis) and diagnostic laboratory results.

The total eight county JAIBG allocation for this initiative is \$35,129. The Taylor County portion is \$4,552.

• <u>Juvenile Gang Task Force #10</u> – Will provide all law enforcement agencies with data and information necessary to track juvenile gangs. This will enhance the ability to charge juvenile gang participation crimes, and related offenses. The JAIBG funds will purchase computer equipment and software to start and maintain the database, and will train staff to use the equipment. The coordinated effort has been jointly

The Scott County Decategorization JAIBG Plan is based on the "Kids and Community Together", the Scott County Juvenile Justice Plan, which was completed in April 1999. Each of the projects funded with JAIBG funds has been prioritized in the planning process.

- <u>Crisis Intervention Services Fund #7</u> Will provide short-term services for juveniles and their families that are not covered under the Department of Human Services or any other program. These services would be of brief duration targeted to specific areas of need for the juvenile and family. The anticipated result of these services is the prevention of any further involvement with law enforcement or the juvenile justice system. The JAIBG allocation is \$64,257.
- <u>Juvenile Court / Police Liaison #7</u> To expand the existing program from one liaison to two. The liaison will be assigned to the Davenport Police Department. - <u>Victim Offender Reconciliation Program #2</u> Juvenile offenders, who victimized others, will be referred to this accountability-based sanction. The juveniles will participate in education group sessions about victimization. The parents of the juveniles will participate in a group session on how the parents can reinforce the learning. The final session is between the victim and the juvenile. The victim is given an opportunity to express the real and emotional effects the juvenile's actions had on the victim. The JAIBG allocation for this project is \$32,228, 100% of the budget.
- Police/School/Juvenile Court Liaison #11 The officer will provide education programs for students on Drugs, Gangs, and Violence Prevention. Through the Comprehensive Strategy process gaps in services for juvenile offenders were identified. The following initiatives were prioritized by the local Juvenile Crime Enforcement Coalition (JCEC).

• School to Work Program #11 – The Woodbury County Alternative Education Center provides education for 9th – 12th graders who are habitual juvenile offenders, exhibit violent behaviors at school, have been expelled from school, and/or are in the juvenile detention center. The school to work concept will be implemented the Alternative School curriculum. Work sites for students will be developed and maintained.

Mentor students will be recruited, and staff will facilitate the transition from the Alternative School. The coordinator will participate on the social health teams within individual schools to serve high-risk students that have not been assigned to the Alternative School. \$15,868 of the JAIBG funds will be used for this project. Other funds will come from schools and a School to Work Grant.

- After-Care Coordinator #11 Will target juvenile offenders age 5 12, who have been reported and documented as having aggressive and delinquent behaviors in the elementary schools. Oftentimes, the behaviors are left untreated until escalation of behavior. The after-care coordinator will intervene with these children and families. JAIBG funds allocated for this project is \$32,500, 100% of the cost.
- Siouxland Human Investment Partnership (SHIP) Executive Director #10 SHIP has been instrumental in the completion of the Comprehensive Strategy Plan for Woodbury County. SHIP will continue the community assessment process, which will provide the opportunity for the continued collection of data and the maximization of the various funding streams for program needs, including graduated sanctions for juvenile offenders. JAIBG funds for this project is \$20,000, about 20% of the total cost.
- <u>Neighborhood ACTION Teams #7</u> The ACTION teams are a cooperative effort to identify service gaps, design services to meet specific needs to their neighborhood. The ACTION Teams will develop services for the needs of the juvenile offenders in their neighborhoods. JAIBG funds allocated to the six (6) ACTION Teams is \$69,467.
