Policy

From the WIC Certification Policy and Procedure Manual – 235.01 Administrative Adjustments and Nutrition Tailoring - Nutrition Tailoring

Nutrition tailoring includes changes or substitutions to the food package to better meet the nutrition needs of participants. Nutrition tailoring includes changes or substitutions to:

- Food types
- Forms, and
- Quantities

The following nutrition tailoring decisions were made to achieve consistency with published nutrition recommendations and guidelines:

- Single flavor baby fruits and baby vegetables to promote the introduction of one new food at a time.
- 1% low fat and fat-free skim milk for all healthy participants 2 years and older to promote low fat milk instead of reduced fat milk. The only exception is for sweet acidophilus milk. Participants will be allowed to choose between 1% and 2% sweet acidophilus milk at the point of purchase. This is allowed because the two major in-state dairies market products with different levels of milk fat.
- Cheese allowed only for fully breastfeeding women and those with medically documented need.
- Beans for all children 12-17 months of age to prevent choking on peanut butter.
- Whole wheat bread without added fruit, nuts or seeds to prevent choking in young children and to address potential food allergies.

The model food packages in the data system provide the regulatory maximum quantities unless a model homeless food package is selected. The additional limitations on package sizes and forms of product in these models make it nearly impossible to provide the regulatory maximum quantities for every food item.

Note: The amount of formula for partially breastfed infants and the amount of supplemental foods for children and women with qualifying conditions must be individually tailored based on the medical documentation and the participant's needs.

Directions from Interstate 35 Follow these directions if you will be traveling to Ankeny on Interstate 35.

Step	Action
1	Exit the interstate at Exit 90 and turn west onto Oralabor Road (also known as Highway 160). <u>Note:</u> This exit is marked for the community college.
2	Move to the right lane and continue on Oralabor Road to the intersection with Highway 69.
3	Turn north (right) onto Highway 69 and move to the left lane.
4	Continue on Highway 69 to the first stoplight and turn west into the campus.
5	Watch for signs to the Conference Center.

Directions from Interstate 80 Follow these directions if you will be traveling to Ankeny from Interstate 80.

Step	Action
1	Exit the interstate at Exit 136 and turn north onto Highway 69.
2	Move to the left lane and continue north on Highway 69 approximately three miles. At the intersection with Highway 160, you can see the campus across the intersection and to the left.
3	Continue north through the intersection. Turn west (left) at the next stoplight to enter the campus.
4	Watch for signs to the Conference Center.
