Meskwaki Settlement Holds Ceremony



High-speed Internet is on its way to the

Meskwaki Tribe, which will assist in providing the necessary technology advancements for the community.

Earlier this spring, the Meskwaki Settlement held a groundbreaking ceremony for the monumental achievement relating to their federal broadband project, which will bring high-speed Internet service to the Meskwaki Settlement School, tribal center, the health clinic, and homes when finished.

The ceremony was open to the public and included remarks from Joseph Cassis representing ICN, and also comments from Frank Blackcloud, the Sac and Fox Tribal Chair. Janice Eagle Hawk, IT Director for the Meskwaki

Tribe, was credited for her great leadership in the project.

The Meskwaki Settlement is ICN's sub-recipient partner. The initiative is part of ICN's federal Broadband Technology Opportunities Program (BTOP) project received in July 2010.

Since the ICN is not authorized to provide residential services, ICN's portion of the project will provide the middle mile access path to connect the tribes' community anchor institutions (school, tribal center, and clinic). The

Meskwaki Settlement's segment of the project provides access for Fiber-to-the-Home (FTTH) for approximately 196 different residential connections.

The overall project has a completion date of June 2013, which has been ahead of schedule.


Fiber cable to be routed underground to provide for high-speed access throughout the Meskwaki settlement.

ICN's Federal Broadband Project Update

ICN has surpassed its end of July target numbers, and we are 50% completed with the BTOP project.

We have completed the upgrade of our core optronics, which now makes the ICN the network that is considered to have the most bandwidth and the most current technology of any network in Iowa, and perhaps the United States. This advancement provides the technology opportunities to rural schools, so they are not islands unto themselves. The largest value of the ICN to rural schools is our ability to connect them to each other thru the aggregation provided to the Area Education Agencies (AEAs). The bandwidth and technology that we provide to the AEAs cannot, in most cases, be replicated by the private telcos and is instrumental for rural schools to be successful.

College Graduate, then High School Graduate

Loryn Brinkopf graduated this year from Hawkeye Community College with an Associates of Arts degree in Liberal Arts, before graduating from Sumner-Fredericksburg High School (S-F High School). Loryn, a senior at S-F High School, started taking college credit courses during her sophomore year, and continued to do so throughout her high school career.

For the past three years, Loryn has enrolled in dual-credit courses (classes that count for high school and college credit) where she earned a total of 62 college credits. She enrolled in history, composition, literature, biology, and diversity courses. Some

of these courses were made available through the ICN. While participating in courses via the ICN, she experienced education not only from the instructor, but also her peers located throughout the state at remote sites. Loryn stated she felt the ICN technology, whether at the instructor or remote site, was "effortless" to use.

This August, Loryn will enter the University of Northern Iowa with junior status. She stated, "The ICN allowed her to learn and experience something truly unique that will lead to further success in academia." Throughout this unique experience, Loryn expressed that the most important lesson

taken away from her experiences was time management. When asked to give advice to students regarding the possibilities the ICN provides, Loryn stated, "All high school students should utilize the educational opportunities at least once." She feels the ICN experience allows high school students the opportunity to get their feet wet within a college classroom.

Loryn is well on her way to success due to her dedication, and the dual credit courses. Loryn felt a desire to thank everyone who helped her achieve her goals during high school. Most notably she wanted to thank Mr. Allen Eckelman, S-F High School Principal, for his support and dedication to ICN classes.

Change in Program Oversight for RTCs

There has been a change in program oversight and appropriation management of the Regional Telecommunications Council's (RTCs) allocated funding. The support provided by the RTCs has been transferred to the Iowa Telecommunications and Technology Commission (ITTC), which will

administer the pass-through allocation. The Commission approved the process in May 2012.

The process for requesting funding will be similar to previous years, with a few modifications. There are new guidelines, which will assist in providing guidance and transparency within the allocation process. In addition, a new tracking

element is added to provide details on how the allocation and support are benefiting video sites located throughout Iowa.

ICN's 2012 Legislative Session Review

The Legislature adjourned on May 9, after completing work on the Fiscal Year 2012-2013 budget and several significant policy issues. The following were ICN's bills of interest:

Senate File 2313 included the appropriation to be allocated to the Regional Telecommunications Councils (RTCs) for maintenance of video classrooms, regional scheduling, and Local Area Network/Wide Area Network technical support. The bill included an appropriation for just under \$1 million to the ITTC, and



will be a pass through to the community colleges. In previous years, the appropriation was administered by Iowa Public Television. The bill was reviewed by the Governor, and signed on May 25. Visit www.icn.state.ia.us/RTC for additional information.

Senate File 2316 included an appropriation of \$2,727,000 for Part III lease payments to the Department of Education,

and an appropriation of \$2,198,653 for equipment replacement, which is a reduction of \$50,000 from last year. The bill was signed by the Governor on June 7. Governor Branstad vetoed the section within SF 2316 that required ICN to conduct an audit for appraisal prior to any sale or lease of the ICN. He wrote, "An audit and appraisal is premature and unnecessary. If such an audit is needed in the future one could be conducted at that time."

The ICN, a state agency, is the country's premier fiber-optic Network, committed to continued enhancement of distance learning and providing lowans with convenient, equal access to education, government, and healthcare.

The site contained the oldest human remains, as well as the oldest known structures ever found in Iowa. They called it the Palace Site.

Bring your students (with their imaginations) to participate in this engaging presentation and discussion about the site with staff from the OSA. They'll talk about the artifacts they found and how they use that evidence to paint a picture of the people who lived there and the lives they lived.
