Message from Dave Lingren, ICN's Executive Director

Sometimes I am told that government should not be in the telecommunications environment, since those individuals believe that ICN should not be competing with local companies. The discussion should not be government verses the private industry, but whom and how are the individuals benefiting from the services provided. The focus should be about ensuring that the services are offered in the most cost effective way for the taxpayers of Iowa. A partnership between the private sector and government has proven to be the most cost effective way for services to be delivered to the taxpaying community. The ITTC has supported the ICN's efforts to pursue this type of money saving initiative, and we continue to move in this direction.

Healthcare Facility Receives Top 25 Honor

Radiology Consultants of Iowa (RCI) was recently selected as one of the *Top 25 Connected Healthcare Facilities* by Health Imaging & IT. RCI is a participant in the Iowa Rural Healthcare Telecommunications Program (IRHTP), which has its private fiber-optic network, hosted by the ICN.

The program has improved RCI's ability to provide critical services to its rural hospital partners. Prior to RCI's involvement with the program, their Internet connections were inadequate for the performance their doctors demanded.

Radiology is now expected to be a 24x7 service, and in many



cases, complex imaging exams require a radiologist with subspecialty training for particular types of exams. With the connections provided by IRHTP, specialists can read exams from any of the locations that are connected to the project, just as easily if they were on site.

"The impact of IRHTP is most evident in the emergency rooms," stated Joe Moore, RCI's Chief Information Officer. "We are now able to report our findings much faster than

before, by as much as 30 minutes or more. This helps the rural ER doctor in the middle of the night make better, faster decisions, so they can determine if the patient should stay there or be transported to a larger urban facility."

IRHTP is a joint partnership between Iowa Hospital Association and ICN. IRHTP's healthcare facilities utilize private Ethernet services and Internet, provided by the ICN, to exchange medical information including radiology studies, electronic medical records, and remote ICU monitorina. IRHTP's overall goal is to deploy a secure, statewide, highspeed network connecting rural hospitals to vital healthcare resources.

Clarifying an Inaccurate Message about ICN

There has been an incorrect message communicated to our customers and partners. The inaccurate message is that the ICN is up for sale, and will be sold soon. What IS true is that the Iowa Telecommunications and

Technology Commission (ITTC), ICN's governing body, was instructed by the legislature through House File 45, during the 2011 legislative session, to write a request for

proposal (RFP) to determine if there is interest in purchasing the ICN. The ITTC has two years to complete the RFP process, which provides a timeframe of June 30, 2013 (extension made by House File 646).

If it is determined that there is interest to purchase the Network, customers' rates will be maintained, since bidders of the RFP will be required to offer services currently provided by the ICN at lower overall long-term cost.

To our customers and partners, it is important to clarify this inaccurate message that is circulating. The ICN is not currently up for sale. If it is determined that there is a viable candidate, through the RFP process, all bidding information will be required to be reviewed by the legislature and Governor prior to a commencement of a sale or lease agreement of the Network.

ICN Releases Customer Survey Results

This year ICN changed the methodology utilized in surveying authorized users regarding their satisfaction with ICN services and staff business conduct. ICN utilized a two-step customer survey process to obtain FY 2011 customer satisfaction measures. The 'Step One Survey' was conducted in late April to verify contact information and gather general perceptions from key authorized user decision-makers regarding ICN services. The 'Step Two Survey' was released in May to those authorized user contacts who dealt with specific aspects of ICN's business conduct


and support functions including account contacts, billing contacts, technical support contacts, and video scheduling contacts. The timely responses are helpful to ICN management and provide a more accurate assessment of the agency's performance.

Both surveys indicated an overall satisfaction score with ICN services (authorized users were either very or somewhat satisfied) of 90 percent. This indicates higher satisfaction than was indicated in FY 2010. The 'Step Two Survey' aggregate satisfaction

score of 82 percent with ICN services was consistent with the previous year's responses. Other items learned from the survey were:

- ICN customers want more information about services.
- ICN customers want more training when it comes to our electronic billing.
- ICN customers want to know about the future of the Network.
