An initial investigation has been conducted, and initial logs do not indicate any breach of data. Checklist for Requesting Service Records

IDVA's Records Specialist, Bob Betz, has suggested that to make the research and queries process more streamlined, the following checklist will help. Here is the information he asks to have at hand before making a phone call to his desk:

- 1. Last, First, Middle Name (Exact spelling)
- 2. Date of birth (Day, Month, Year)
- 3. Place of birth if known (City, County, State)
- 4. Social Security number and/or Service number
- 5. Iowa veteran (Yes or No)
- 6. Approximate service period
- 7. Service Component/Branch
- 8. Where information is to be sent

Midwinter Homeless Veteran Stand Down

The 2010 Winter Veterans Stand Down was held on Saturday, February 27, 2010. Approximately 300 homeless veterans were seen at the Polk County Senior Center in Des Moines. The function was hosted by Goodwill Industries.

Participating veterans were furnished with breakfast, lunch, and a sack lunch to take with them. The program included a host of providers, including dental and medical services, Social Security and IRS assistance, and Drake Law School legal advisors led by Judge Celeste Bremer.

Both Iowa Workforce Development and the Vet Center provided counseling assistance. The VA Regional office, the VA Medical Center, the Iowa Department of Veterans Affairs, and representatives from the American Legion offered benefits and service information. New and used clothing and hair cuts were also donated.

2010 ISFAC

IDVA Director Patrick Palmersheim and Outreach Coordinator Jill Joseph attended the first 2010 Inter-Service Family Assistance Committee (ISFAC) meeting in February at the JFHQ. ISFAC is a voluntary military cooperative partnership organized to provide multi-service networking for training and assistance to ensure Total Force Family Readiness. Their purpose is to provide assistance to families regardless of service component. The goal of the ISFAC is to strengthen existing family assistance delivery systems in the event of mobilization, deployment, or natural disaster through the interaction of committee members.

ISFAC provides a forum for various Federal, State, and local agencies, care and service providers, and other organizations to network and identify opportunities, and to eliminate duplication of effort. Division of Services include: Working for Families; Working with Communities; Working with Military Units; and Working with Employers.

The Back Story...

During the Second World War, Fort Des Moines hosted the formation of the first Women's Army Auxiliary Corps (WAAC), later renamed the Women's Army Corps (WAC), training 72,000 troops and commission-

ing the first female officers for noncombat duty between 1942-1945. Among the 436 initial WAAC officers were 39 black women who graduated as 3rd Officers (2nd Lieutenants) on 29 August 1942 and served in England and France in 1945. Fort Des Moines produced 118 black female officers and 3,656 enlisted women by war's end, representing 4% of all WAC troops. The success of the WACs freed 250,000 male soldiers for combat duty in Europe and the South Pacific.

Spotlight on Iowa Veteran Partners: The Des Moines Vet Center

The Des Moines Vet Center provides readjustment counseling services to eligible veterans and their families in a caring manner. Services include counseling and psychotherapy for individuals, couples, and families. If you have been to the Vet Center, you probably noticed that it's a place of action. Vet Center staff is trained to counsel the impact of psychological trauma on the veteran and readjustment issues faced by veterans returning from war.

The Des Moines Vet Center provides individual and group readjustment counseling free of charge, and pays extreme attention to confidentiality and privacy of veterans and family members. The Center has a variety of counseling/support services to meet a variety of needs. Some of the groups offered are: OIF/OEF educational groups, OIF/OEF combat related issues, PTSD support groups for all war eras, Grief and Loss groups, Anger Management, Relaxation/Wellness, and Recreational Therapy.

The Des Moines staff includes: Katina Mach, Team Leader; John DeVolld, Counselor; Steven Leonard, Counselor; Brian Wrightsman, GWoT Outreach; Joseph Biver, GWoT Outreach; and Christine Francis, Office Manager.

Currently, March 8th marks the beginning of a 6-week Anger Management Group and a 6-week Wellness Group. Please call for dates and times.

News Briefs

Gulf War Illness

The Associated Press has reported that the Department of Veterans Affairs will re-examine the disability claims of what could be thousands of Gulf War veterans suffering from ailments they blame on their war service. This will be the first step toward compensating them.

VA Secretary Eric Shinseki said the decision is part of a "fresh, bold look" his department is taking to help veterans who suffer from "Gulf War illness." Gulf War veterans have long felt that the government has done little to help them.

The VA said it also plans to improve training for clinic staff who work with Gulf War veterans to make sure they do not tell the vets that their symptoms are imaginary. These changes may reflect a significant shift in how the VA may ultimately care for the 700,000 veterans who served in the Gulf War.

FedsHireVets.gov

The Office of Personnel Management (OPM) has announced the launch of <u>FedsHireVets.gov</u>, a "critical component" of President Obama's Veterans Employment Initiative. This website will help ensure that "veterans, transitioning military service members, their families, HR professionals, and hiring managers receive accurate and consistent information regarding veterans employment in the Executive Branch."

John Berry, Director of OPM, explained that, "<u>FedsHireVets.gov</u> will be a one-stop gateway to Veterans employment resources throughout the government. On March 3, 2010, more than 1,000 women who flew military planes during World War II will be honored with the Congressional Gold Medal. They were known as WASP, Women Air Force Service Pilots, and at the time of their service, they were civilians. They waited three decades to be granted military status. And history nearly forgot them.

Service-Connected Illness Update I

The Department of Veterans Affairs is amending its adjudication regulations to establish a presumption of service connection for osteoporosis for former POWs who were detained or interned for at least 30 days and whose osteoporosis is at least 10 percent disabling. This presumption is based, in part, on the likely nutritional deprivation experienced during longer periods of captivity.

Service-Connected Illness Update II

Relying on an independent study by the Institute of Medicine, Secretary of Veterans Affairs, Eric Shinseki has decided to establish a service-connection for Vietnam veterans with three specific illnesses presumed to have been caused by Agent Orange.

The illnesses affected by the recent decision are B cell leukemias (such as hairy-cell leukemia), Parkinson's disease, and ischemic heart disease.

In practical terms, veterans who served in Vietnam during the war and who have a "presumed" illness, don't have to prove an association between their illnesses and their military service.

The Secretary's decision brings to 15 the number of presumed illnesses recognized as being caused by exposure to herbicides during the Vietnam War.

National Resource Directory

The federal departments of Veterans Affairs, Labor, and Defense have unveiled an improved website for wounded warriors. The National Resource Directory is a comprehensive, free, online tool for wounded, ill, and injured service members, veterans, and their families.

The updated website has been enhanced to provide a single point of access to a wealth of information from more than 10,000 sites.

Iowa Veterans Task Force – Mental Health

Many of lowa's veterans are faced with the challenges of mental health issues such as depression and post traumatic stress disorder (PTSD) as well as substance abuse issues including alcoholism and drug abuse. Left untreated, these issues can become severely worse, creating problems within a veteran's family or community - or worse - putting a veteran's life at risk. As a state, we must do all that is possible to ensure our veterans have access to adequate mental health and substance abuse services. The lowa Veterans Task Force is working hard to address these challenges.

In 2007 the lowa General Assembly passed House File 909 calling for a study to identify the needs of lowa's veterans. The lowa Department of Veterans Affairs contracted with State Public Policy Group (SPPG), an lowa-based nonpartisan policy consulting firm to engage stakeholders to complete the study and make recommendations to improve benefits and services to veterans. The lowa Veterans Benefit Study Report was completed in September 2008 and identified eighteen recommendations to improve benefits and services to lowa veterans. The lowa Department of Veterans Affairs and the lowa Commission of Veterans Affairs have utilized many of these recommendations in developing legislative agendas and identifying priorities for the Department and Commission to address.

One key recommendation from the lowa Veterans Benefit Study Report was to convene a broad stakeholder advisory group to address additional veterans benefits issues, gaps in services and unmet needs. In response to this recommendation, the lowa Veterans Task Force has been convened to address the mental health and substance abuse needs of lowa veterans. The lowa Veterans Task Force is comprised of a diverse group of stakeholders who make up lowa's veterans mental health service system. The Task Force is currently working to develop a list of veterans mental health and substance abuse priorities that will be addressed through a series of recommendations and implementation strategies. Task Force meeting facilitation, staffing, and support is being provided by SPPG.
