## Focusing on Outcomes for Young Children



The Iowa Empowerment Board met on January 7<sup>th</sup>. We were fortunate to have First Lady Christie Vilsack present about her recent trip to study the early education system in France. She provided an overview of practices observed in that country and shared thoughts on how we could learn or incorporate some strategies into practice in our state.

In the spring of 2004 an empowerment data work group was formed with four local coordinators and a state technical assistance team member to guide the development of a common set of performance measures and the collection of this data at the state and local level to show the impact Community Empowerment has on the lives of young children and their families.

The data work group surveyed all 58 areas to assess what performance data is being collected, determine common measures, and make recommendations for what data is to be collected beginning in fiscal year 2006. Fifty-one of the areas responded. The Iowa Empowerment Board approved the inclusion of the following local performance measures as a part of the Community Empowerment Area FY'06 annual report process.

- Unduplicated count of children participating in funded home visitation programs
- Unduplicated count of families participating in funded home visitation programs
- Number of face-to-face visits
- Percent of participants who did not have a confirmed child abuse report while in the program
- Percent of children, 0 - 3 years old, referred to Early ACCESS services

The Data workgroup will soon be providing definitions for each of these measures to guide the collection of data on the local level, as well as proposing models for local data collection and the model and framework to be used for state-wide collection of the data.

## Update on the Iowa Department of Public Health's Early Childhood Comprehensive Systems (ECCS) Building Grant

Iowa will be applying for a three year implementation grant through Health Resource Service Administration (HRSA). The implementation grant will start July 2005-July 2008. The Early Childhood Comprehensive System Project is spearheaded through the Community Empowerment State Technical Assistance Team. The Early Childhood Iowa Stakeholders serve in an advisory role for the project.

Iowa will also be applying for a competitive one year enhancement grant (July 2005-June 2006). The grant will focus on improving quality family support and parenting education programs and services.

## Update on the work of Early Childhood Iowa Stakeholders

The Early Childhood Iowa (ECI) Stakeholders have finalized an Early Care, Health, and Education Strategic Plan. The Strategic Plan includes result areas, goals, and strategies for an Early Care, Health, and Education System. The Strategic Plan will serve as the action plan for the ECI and their work in the next three years.

Recent activities of the ECI Group and individual component workgroup include:

- developing a financing strategy, (through partnership with the Urban Education Network);
- developing a public awareness campaign, (through multiple partnerships, including Every Child Counts);
- convening statewide family support leadership programs and services to explore establishment of a family support network; (developing a common terminology of family support, next steps)
- developing indicators for the goals identified in our strategic plan; and
- compiling an inventory of early childhood programs for children ages 0-5 in Iowa.

ECI stakeholders along with Iowa Access have been working on developing a website for ECI information. The website will serve as a hub for the Early Childhood Iowa stakeholders and system building activities. The basic format for the website will include an overview and what's new on the homepage, with other pages to include:

- Early Childhood Iowa Stakeholder Information
- Iowa Grant Initiatives
- Components of the System/Achievements and Products
- Advocacy Calendar of Events
- How You Can Get Involved
- History
- Early Childhood Links

The website will be live at the end of February.

## Grants Awarded to Child Protection Centers

A children's advocacy/protection center provides a comfortable, private, child-friendly setting that is both physically and psychologically safe for diverse populations of children and their families who are victims of suspected abuse and neglect. The centers offer a new way of serving abused children through a comprehensive approach to services. A team of specialists at the centers work together in the investigation, treatment, and prosecution of child abuse cases. The goal of the child advocacy/protection centers is to ensure that children are not re-victimized by the very system designed to protect them.

In 2004, IA Legislation appropriated \$100,000 to be awarded for the purpose of establishing new centers or for the support of existing CPCs that meet, or are in the process of implementing, standards established by the National Children's Alliance (NCA). NCA is a nationwide not-for-profit membership organization whose mission is to promote and support communities in providing a coordinated investigation and comprehensive response to victims of severe child abuse.

Through an application process, four Child Protection Centers in Iowa were awarded grants in the amount of \$23,000 to assist in supporting existing services within the centers. The grants will be used to support forensic interviews and family support. The four centers that were awarded grants are as follows:

## *Healthy Smiles*

The Head Start Association recently received a grant from Delta Dental and the Mid-Iowa Health Foundation to fund *Healthy Smiles*, a home based family education and training program designed to build the confidence and competence of parents to play their part in keeping their young children cavity-free. Oversight of the program will be provided by Tom Rendon, Coordinator of the Iowa Head Start State Collaboration Office and by the Iowa Head Start Association (IHSA). The Collaboration Office will provide a single point of contact in connecting state services to Head start grantees and IHSA will provide the support and cooperation of individual grantees.

Recently, the position of Project Coordinator, a contracted position, was filled by Marcia Manter and Nina Jones with Flint Associates. Their primary responsibilities will be to design and implement the project, develop and implement an ongoing communication process, design and implement outcomes documentation system, prepare reports, and coordinate trainings and conferences.

The goal of *Healthy Smiles* is to increase by 50% the targeted parents' involvement in their child's oral health care by focusing on increased family involvement in prevention, early identification, and establishment of a dental home. Targeted families include those enrolled in Early Head Start, Head Start or participating in a variety of home visitation and parent education programs including WIC, HOPES, Title V Clinics, and those funded by Iowa Community Empowerment.

Twenty co-trainers, making up a team of four for each of five regions, will conduct regional sessions to orient home visitors and other interested people to oral health for pregnant women and children, birth to five. They will also be conducting skill-building workshops at local sites for home visitors. A *Healthy Smiles* Home Visitor Toolkit containing parent education materials, oral health reference materials, and age-appropriate hygiene supplies and teething and weaning supplies will be given to home visitors that attend the workshops in their community. Ongoing assistance will then be provided to all participating home-based agencies by the Project Coordinators through e-mail and phone communication.

The *Healthy Smiles* program will be implemented between March and August, 2005 starting with the regional meetings. Notification of those meetings will be forthcoming.

## **Every Child Counts – Update**

*As 2004 ends, we begin 2005 with enthusiasm and strength to promote a child's agenda during the upcoming legislative session. We look forward to working with you to accomplish this task.*

December was a busy month for staff at Every Child Counts. Two new reports were released, one focusing on child care in Iowa, the second on Medicaid and hawk-i.

The child care report, "Financing Child Care in Iowa: How Far Is Too Far Behind?," details how Iowa's child care affordability and quality lag behind other states. Iowa is a leader among states with the numbers of working parents, therefore, leaving children to be cared for in an out-of-home setting. Iowa spends \$28.94 per child in the Child Care Subsidy Program, compared with the \$44.53 national average.

Quality of child care in Iowa is another issue outlined in the report. According to a report, completed by the Midwest Child Care Research Consortium, only 20% of licensed child care settings would be considered "good" quality, followed by 58% considered "mediocre", and 22% considered "poor."

In order for Iowa to raise their state expenditures to the national average, an additional investment of \$13.84 million is needed.

The Medicaid and hawk-i report, "The Iowa Health Care Crisis Without Medicaid – The Role of Medicaid and hawk-I in Covering Children," outlines the continued need for subsidized medical insurance in Iowa.

Between 1999 and 2004, the number of Iowa children served by these programs has grown by 80,000 children, nearly doubling the percentage of Iowa children covered by either Medicaid or hawk-I (from 12.6% to 24.5%).

The increase in the numbers of children enrolled in Medicaid and hawk-i could be attributed to a number of factors, including a growth in the number of children who qualify for the program guidelines. Parental unemployment and the rise in health care premiums could also attribute to this increase.

When the General Assembly resumes on January 10th, they will be faced with appropriating an addition \$52 to \$85 million to continue the Medicaid program through the end of this fiscal year.

# Iowa Program for Infant & Toddler Caregivers (IA PITC) Trainings

## PITC Demonstration Site in California

This past December, I and three other IA PITC representatives had the remarkable opportunity to visit the Children's Center at San Francisco State University. Louis Torelli, Designer (and PITC faculty), and Sarah Johnson, Executive Director of the center, shared how the philosophy of PITC is reflected within this amazing setting. I would like to share with you a few of the impressive qualities of this facility.

Just inside the wide entrance and past the check-in desk is a cozy little cove which mimicks a small living room, perfect for families to sit for a few minutes. To the left is the preschool wing. To the right, a wide angled interior hallway leads to the infant and toddler rooms, each with its own window seat opposite the program door. The doors and windows look like ones that we would see in our homes, and therefore create a sense of familiarity. The front (and back - to the play yard) doors of each room are a specific color so that the children will associate it with their room.

The spaces and materials are open yet defined in efficient while still inviting ways that are important to young children and the adults working with them. The colors are soft, corners are rounded and there are comfortable nooks and even hammocks to retreat to. Conducive to developing skills, the infant rooms have low sinks (with adult height valves on the wall behind them). Lots of natural lighting and low windows create a calm aura.

A common kitchen with half walls sits in between the infant and toddler rooms with sliding wood and plexiglass gates so the children can see in and across. Staff share a desk and resources in here as well.

Entering into the play yard feels like a common back yard or neighborhood park. Each room has its own gabled roof with a covered porch like area and underneath there are blocks and art nooks with sinks and clothes line for hanging artwork. Further into the yard there are sand boxes, flower beds, a riding surface, a greenhouse, grassy knolls, trellises, small wooden cabins, and climbing equipment.

I have always hoped that some day we will have demonstration sites in Iowa which reflect the PITC relationship-based philosophy of care. It should be obvious from the quality of the staff:child interactions through the design of the entire setting! You know the saying, "A picture is worth ...". Well, being there was even better. ## Teen Health Insurance Information

Covering Kids and Families has partnered with the Healthcare Coverage for Kids Coalition (HCKC) to conduct outreach to teens. Through their collaboration they developed a teen health insurance information packet titled, “*What the Health? – Answers & Information.*” The packet is a teen version of the Insured Success/Family Education packet and was developed using student feedback. It defines health insurance, describes what medical care costs, displays an insurance options chart, and provides a health care coverage glossary. The packet is very teen friendly and is a great outreach tool for describing health insurance and the *hawk-i* program to teenagers.

HCKC staff presented the value of health insurance to a local health occupations class using the packet. The packet was well received with positive comments and suggestions.

HCKC is also collaborating with a local audio/visual class to create an educational outreach video about health insurance. The purpose of the video is to drive home the importance of health insurance and make students better future consumers. HCKC staff met with the class to discuss the students developing a partnering video to accompany the “*What the Health?*” packet. The video is expected to be completed at the end of January, 2005. Future plans are to create a curriculum component on health insurance based from the packet and video for use in middle and high schools. The “*What the Health?*” packet can be accessed at:

## **Early Childhood Associate Degree Scholarship Program for Child Care Center Directors**

### **Who is eligible for a scholarship?**

Any director who would like to attend a community college to earn an associate degree in Early Childhood Education and is employed full-time (30 hours/week minimum) in a licensed child care center is eligible to apply for a scholarship. Scholarships are awarded on the basis of need and commitment to the Early Childhood Education field, as shown through information on the application. If a staff person works more than 20 hours a week providing direct care and education for children, a different T.E.A.C.H. scholarship (Associate Teacher) will apply, even if they have some administrative responsibilities.

What kind of support does the scholarship program provide?

T.E.A.C.H. Early Childhood® IOWA pays for 50-80% of tuition and books, provides a travel stipend each semester and offers counseling and administrative support. T.E.A.C.H. awards a \$300 bonus to each director who completes the 9-18 semester hours within a contract year, except for director/employees receiving raises on option one.

### **Can directors from any center apply?**

Yes. Directors can be from any DHS-licensed for-profit, church, not-for-profit, public or Head Start program. Any center wishing to make a commitment to director education and compensation by meeting the terms of the program can participate. Are the requirements different for directors who are employees and directors who are also center owners?

Yes. Options One and Two describe the program requirements for directors who are employees of the centers where they work. Option Three describes the program requirements for directors who are also owners of the centers where they work.



## **Iowa Named As State of Promise**

Those five promises are: caring adults, safe places, healthy start, marketable skills, and opportunities to serve. ## What's New: Johnson County

### Johnson County Early Learning Initiative

The Neighborhood Centers of Johnson County (NCJC) and the Johnson County Empowerment Board have been awarded a \$486,000 Early Learning Opportunities grant from the U.S Department of Health and Human Services. The grant is supporting the **Johnson County Early Learning Initiative (JCELI)**. JCELI targets children birth to 5 years and their families in three high need neighborhoods in Johnson County.

The project goal is to improve educational and health outcomes for young children and prepare them for a successful school experience by inspiring a genuine love of reading and learning. Our approach will integrate community-based and family focused strategies, while improving the overall community's awareness of the importance of early education. JCELI will emphasize the role and importance of parents as the first teachers of their children while creating opportunities for professionals in child care to enhance their capacity as providers and partners with parents.

The JCELI will feature a "Yearn to Learn" community campaign to raise awareness on early learning and school readiness. The campaign will offer community events like "First Books" read-ins, "Make-and-Take" story box activities and neighborhood-based pediatric health services. These are events and activities that promote good health, reading and learning all the while emphasizing the importance of parents as the first teachers of their children. These types of activities are fun and help parent build relationships with other parents and early child hood providers.

In addition, the project will create a new intensive classroom for preschoolers. Preschoolers Reaching Educational Potential (PREP) emphasizes communication, pre-academic and social skills needed for school success. It is designed for children who face special challenges such as children with developmental delays, children who have never been in a group program and children who are recent immigrants to the community.

"Johnson County is in the midst of a dramatic demographic transformation," stated Johnson County Empowerment Board President, Charlie Eastham. "We have had dozens of low-income families make Johnson County their home as they seek community and educational and economic opportunity." This trend has been associated with some decreased educational outcomes in the target neighborhoods. "Our goal is to reach children early to insure the best attainable educational achievement for every student," Eastham added.

## IOWA'S QUALITY PRESCHOOL PROGRAM STANDARDS

During the 2003-04 school year the Iowa Department of Education's (DE) Early Learning Team was given the charge to develop Quality Preschool Program Standards (QPPS) for Iowa's early care and education programs that had ties to the Iowa Department of Education. These programs would include preschools that are operated by local school districts (Title 1, ECSE, etc.) and those programs where preschoolers' IEPs are being implemented. The Early Learning Team selected all ten of the National Association for the Education of Young Children (NAEYC) program standards and 45% of the NAEYC program criteria. They also developed a self- assessment to go with the criteria.

In June of 2004 the DE was notified that it had received a three year State Improvement Grant (SIG) that was funded by the Federal Office of Special Education Programs. This grant is allowing the QPPS to be rolled out in a systematic way taking into consideration best practices for adult learning and program change.

In January sixty-five facilitators, representing area education agencies, local school districts, community empowerment areas, community colleges, and Child Care Resource & Referral were trained on the QPPS. These facilitators will each work with 8 staff members from two community based early childhood programs. The programs will complete the self-assessment, which will lead to a quality improvement plan. At the same time five community colleges are involved in the training so that they can infuse the QPPS in their course curriculums.

Iowa State University will be compiling the information from the self- assessments to determine what the statewide needs are in regards to improving the quality of Iowa's early care and education programs. Technical assistance for the next two years will be linked to the outcomes of the self -assessments.
