



# A Note from the State Long-Term Care Ombudsman:

I am pleased to announce that on July 2, Governor Branstad signed <u>Senate File</u> <u>505</u> into law, authorizing funding for long-term care advocacy programming through June 30, 2016.

The Health and Human Services budget bill appropriates funding to executive branch human service agencies, including the Office of the State Long-Term Care Ombudsman (OSLTCO). Although the governor did exercise veto authority in some portions of the bill, the sections directly impacting the OSLTCO remained in place, resulting in a \$1,276,783 appropriation for the program.



Highlights from the bill include the following:

- In addition to receiving the full amount requested for its 2016 operational budget, the OSLTCO was appropriated \$220,000 to provide additional local long-term care ombudsmen to focus on Medicaid Managed Care.
- The OSLTCO and the Iowa Department of Human Services were directed to collaborate in developing a cost allocation plan to claim Medicaid administrative funds for assistance and advocacy services provided by the OSLTCO that directly benefit the state's Medicaid program.
- The OSLTCO was directed to collaborate with the lowa Department on Aging, the Office of Substitute Decision Maker, the Iowa Department of Veterans Affairs, the Iowa Department of Human Services, the Iowa Department of Public Health, the Iowa Department of Inspections and Appeals, Disability Rights Iowa, the Civil Rights Commission, the Senior Health Insurance Information Program, the Iowa Insurance Consumer Advocate, Iowa Legal Aid

and other consumer advocates and consumer assistance programs to develop a proposal for the establishment of a Health Consumer Ombudsman Alliance. The Alliance will provide a permanent, coordinated system of independent consumer supports to ensure that consumers, including those covered under Medicaid managed care, are able to obtain and maintain essential health care services; are provided unbiased information regarding coverage models; and are assisted in resolving problems regarding health care services, coverage, access and rights.

Overall, these items suggest the lowa Legislature recognizes the importance of providing long-term care ombudsman services to lowans and sees the significance of strengthening partnerships and working collaboratively to protect the health, safety, welfare and rights of residents and tenants living in the state's nursing facilities, residential care facilities, assisted living programs and elder group homes.

Together we are making a difference!

# Fact Sheet of the Month: Capacity vs. Competency

The Office of the State Long-Term Care Ombudsman has created a new fact sheet for consumers and their families. "Capacity vs. Competency" is designed to educate the public about the difference between capacity (the ability to understand the nature and effect of one's acts) and competency (a legal finding that determines an individual's mental capacity).

Although these terms are often used interchangeably, under lowa law - and specifically within the context of an individual's rights to make his/her own decisions, there is a very important difference between the two words.
