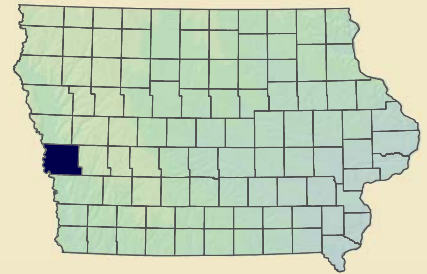
2004 ANNUAL COUNTY PROFILE

Executive Summary

As of 2003, Harrison County's largest private sector was Trade, representing 21.05 percent (807) of the county's total covered employment of 3,833. Over 70 percent of this sector's employment is in the Retail Trade industry. The county's total employment decreased by 1.36 percent since 2002, but the average annual wage increased by 1.89 percent to \$22,723 for all industries.

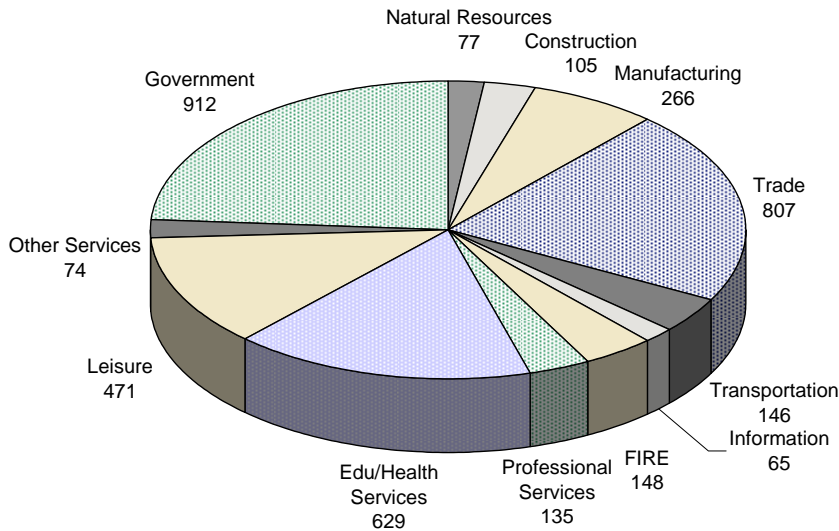
Harrison County's average weekly wage for all industries was \$437 for 2003. This was an increase of 1.86 percent since 2002. The highest average weekly wage for a private sector was Wholesale Trade, averaging \$585 with gross total wages of \$6.9 million. The Transportation & Utilities had the largest percentage increase in average weekly wage of 7.74 percent (\$40) between 2002 and 2003.

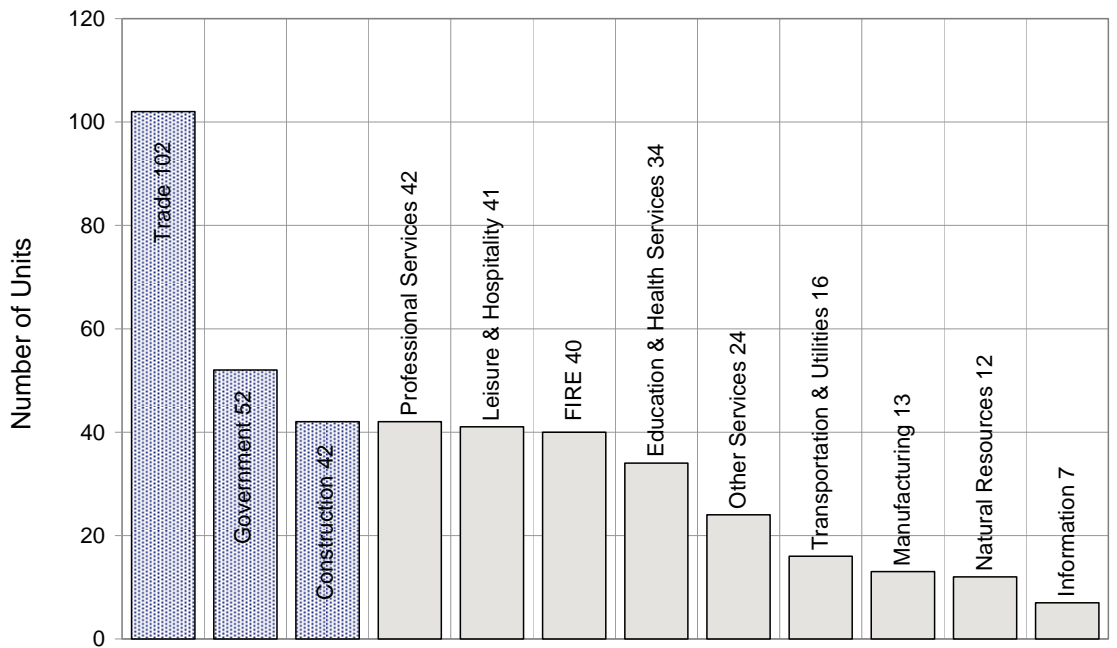

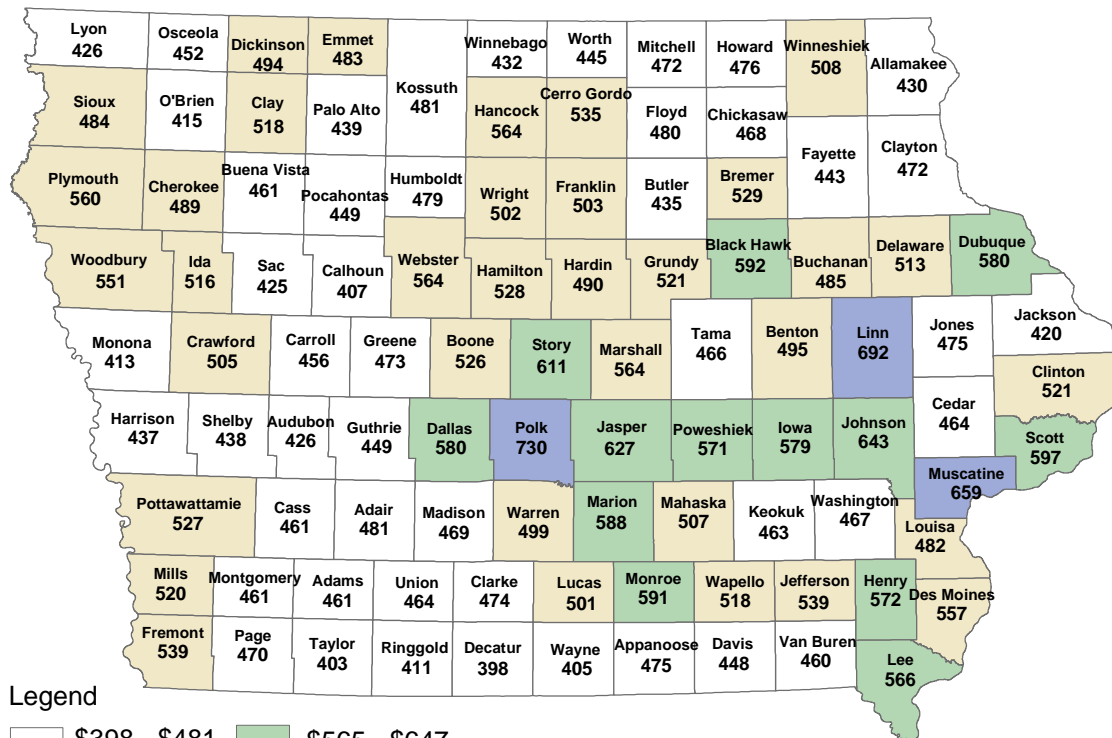

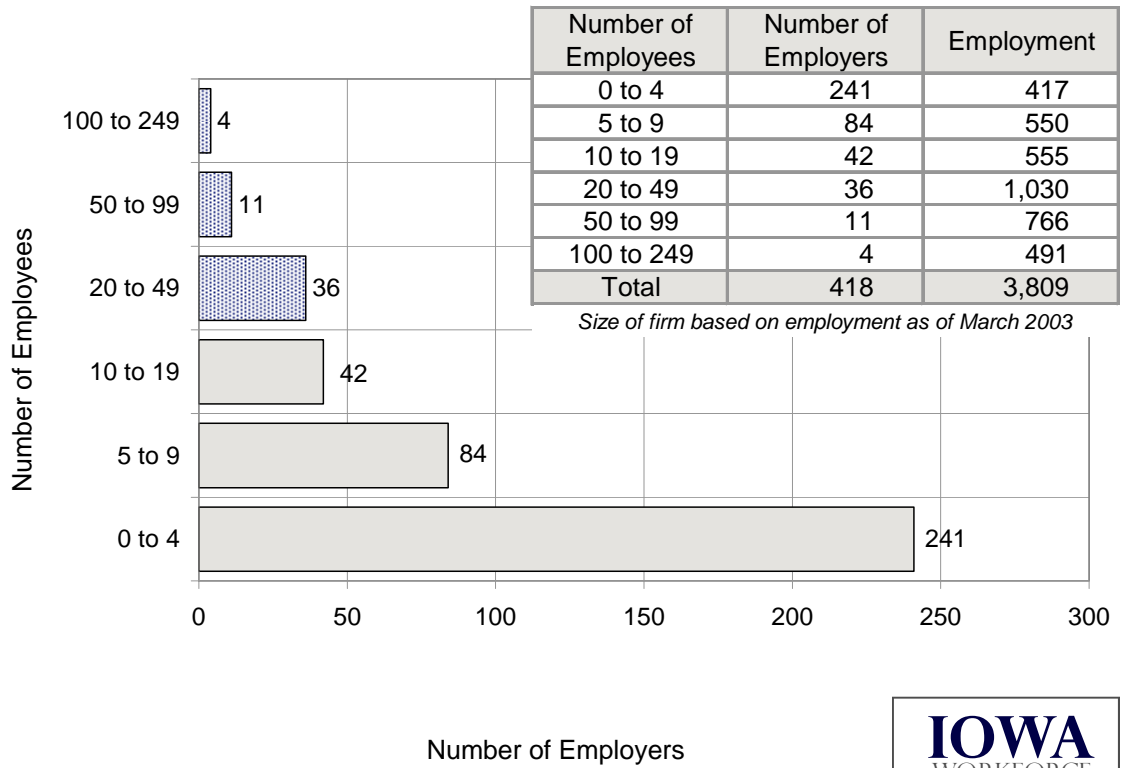
