Partnership Development Workshop Registration

There are two remaining partnership development workshops scheduled in late June. The purpose of the workshops is to bring together public health and hospital preparedness representatives, EMS services and providers, trauma coordinators and emergency managers to present BETS' vision for how a shared system of Time Critical Conditions, coalition building and shared funding could look. New Air Medical Service Authorized in NE Iowa

The Bureau of Emergency and Trauma Services authorized a new air medical service covering northeast Iowa June 10. Gunderson Health Systems and MedLink Air added a second helicopter to their fleet on a trial basis. This expansion will place an aircraft at the Decorah airport each day from 8 a.m. to 8 p.m. Health system officials say the helicopter will help provide better service to their coverage area, shorten response times, and will help to improve patient outcomes for time-critical conditions like cardiac arrest and stroke. The trial will run through December 2016.

EHRT Members Receive Food Safety Training

Disasters such as floods, tornadoes, fires, or the loss of power from high winds, snow, or ice can jeopardize the safety of food. Knowing how to determine if food is safe and how to keep food safe helps minimize the potential loss of food and reduces the risk of foodborne illness. On June 2, 2016 several members of the Environmental Health Response Team (EHRT) received ServSafe training. The ServSafe training covers the food delivery system from basic handwashing to foodborne pathogens and how to prevent foodborne illness and food contamination or spoilage. Disaster-affected people eating food from unknown/unapproved sources or from centralized kitchens that are not properly equipped or poorly run are extremely vulnerable to outbreaks of foodborne illnesses. By receiving this training, members of EHRT may be called upon to provide environmental health consultation and assistance at mass feeding centers to assure safe food handling during disasters.

Active Shooter Response Training for First Responders

The Iowa Homeland Security and Emergency Management Department and the Government Training Institute are offering seven three-day day training classes for active shooter response both during and after the event. This training is **free** for all first responders from fire, EMS, and Law Enforcement who are called to an incident involving an active shooter, a blast or a terrorist act.

The three courses available are:

- ALERRT - Active Shooter Response Level I
- ALERRT - Active Shooter Response Level II
- Post Active Shooter – A Unified Response by Law Enforcement, Fire, and EMS
