#### **Early Childhood Iowa (ECI) Public Engagement Component Group Seeks *Child at Heart* Nominations (Due January 30)**

Early Childhood Iowa is seeking nominations for its 2015 ***Child at Heart*** award, to be presented on March 5<sup>th</sup>. This award is given annually to one individual who advocates for early childhood at the local level, and one individual who advocates for early childhood at the state level.

Nominations are due by close of business on January 30<sup>th</sup>. ***Instructions for submitting a nomination are attached to the email, as well as an optional toolkit for Early Childhood Iowa Boards or other organizations to use in promoting local recognition.***

Please be aware that nominations can be submitted by anyone; however, this year nominations must include a letter of support from the local ECI Director or Chairperson. ECI Directors/Chairpersons may submit letters on behalf of multiple individuals. The purpose of this new requirement is to promote awareness and communication between the community and ECI Boards.



The awards will be presented during ECI's annual Day on the Hill event. Please take advantage of this opportunity to recognize those who work diligently to advocate for young children.

**Annual Condition of Education report is available**

The Iowa Department of Education released the latest edition of the Annual Condition of Education report.

The report provides a wide range of state-level data, including shifts in student populations and demographics, teacher salaries and characteristics, student achievement results and school financial information.

"Data and information are vital in education," Iowa Department of Education Director Brad Buck said. "They help us determine our needs, map out goals and action steps, and then evaluate our progress. We also depend on good data to help guide our improvement efforts, from the local classroom to the state level."

The Condition of Education report contains the most recent data through the 2013-14 school year, unless otherwise noted.

## Federal Information: Helping Working Families with Young Children



Helping working Americans meet the needs of their jobs and their families is a key part of the President's plan to bolster and expand the middle class. Access to high-quality child care and early education not only promotes a child's development, but it also helps support parents who are struggling to balance work and family obligations. A safe, nurturing environment that enriches children's development is critical to working families and is one of the best investments we can make in our economy. Yet today, a year of child care costs higher than a year of in-state tuition at most colleges – putting a significant strain on parents.

Last week, President Obama outlined his plan to make affordable, quality child care available to every working and middle-class family with young children. His plan includes:

- Making a landmark investment in the Child Care and Development Fund that helps every eligible family with young children afford high-quality child care.
- Tripling the maximum child care tax credit to \$3,000

per young child.

- Creating a new innovation fund to help states design programs that better serve families that face unique challenges in finding quality care, such as those in rural areas or working non-traditional hours.
