Dear Governor Reynolds:

I am pleased to submit the 2019 Annual Report on behalf of the Iowa Racing and Gaming Commission (the "Commission"). The Commission is committed to maintaining a vibrant racing and gaming industry that provides economic growth and development for the State of Iowa while continuing to promote responsible gaming and ensuring continued participation in the "Buy Iowa First" program. As always, the integrity of the racing and gaming industry in Iowa remains our highest priority.

Gaming revenues at the facilities in 2019 remained stable with 2018. In 2019, the industry generated more than \$322 million in overall gaming taxes. In addition, over \$42 million was contributed this year to the non-profit licensees. In short; the gaming industry continues to provide significant revenue to the state and has helped fund numerous projects and programs at the local level.

2019 was truly a historical year in the Iowa gambling industry due to the passage of Senate File 617 which authorized sports wagering in retail casinos and through mobile devices via advanced deposit sports wagering operators. SF 617 also authorized fantasy sports contests offered through mobile devices by licensed fantasy sports operators. The Commission took swift action to implement SF 617 including drafting and implementing administrative rules related to sports wagering and fantasy sports contests, accepting and reviewing applications and licensing companies qualifying to offer sports wagering and fantasy sports to Iowans. The first sports wagers in Iowa were placed on August 15 with a handful of operators launching retail sports wagering just 94 days after the bill was signed into law. Mobile sports wagering and ten casinos utilizing five unique advanced deposit sports wagering companies offering mobile sports wagering. 2019 also closed with two companies offering daily fantasy sports contests. All in all; in four and one-half months, sports wagering has generated an additional \$1.3 million in tax revenue, not factored into the gaming tax previously mentioned.

Capital investment into the gaming facilities was vigorous in 2019 with 15 facilities taking on remodeling projects to outfit their facilities for sports wagering. The industry set aside space for retail sports wagering at their facilities and updated those spaces with other amenities such as food service and lounge style environments. Total investment in the facilities related to sports wagering exceeded \$14 million. It should also be noted that routine capital expenditures continued to take place by all gaming facilities in addition to the expenditures related to sports wagering. Lastly, the commission approved one other material project at the June meeting for Grand Falls Casino Resort. This \$8.5 million project adds 63-hotel rooms overlooking the outdoor pool and pool deck and also includes a new 25-stall RV park. These projects showcase the industry's continued reinvestment and dedication to doing business in Iowa.

Capital investment into the gaming facilities was vigorous in 2019 with 15 facilities taking on remodeling projects to outfit their facilities for sports wagering. These projects showcase the industry's continued reinvestment and dedication to doing business in Iowa.

With respect to horse racing, Prairie Meadows and the Iowa Horsemen's Benevolent and Protective Association and the Iowa Quarter Horse Racing Enterprise Inc. extended their racing agreement through 2021 with options to renew through 2024. The new agreement is for 84-racing days and will bring back a mixed meet to Prairie Meadows which has not occurred for a number of years. The mixed meet is projected to increase field size in races, increase racing opportunities, and improve Iowa foal counts.

The Commission wishes to commend its staff for their continued hard work and dedication. We appreciate our Administrator, Brian Ohorilko, along with his staff, the DCI and the Attorney General's Office for providing the commissioners, the racing and gaming industry, and the public, thorough, timely, and accurate information and analysis. The challenges facing the Commission in 2019 were daunting with the authorization of sports wagering and aggressive timelines requested by the industry in creating a regulatory structure for the State of Iowa. The Commission's staff did extraordinary work in meeting deadlines and producing a clear regulatory framework allowing for wagers to be accepted in the State of Iowa prior to the sports wagering industry's busiest season.

It continues to be a pleasure and privilege for me and the other commissioners to serve at your request on the Commission.

Iowa Qualified Sponsoring Organizations

All of the commercial gaming operations in Iowa have an agreement with a qualified sponsoring organization (QSO) licensed to conduct gambling games. QSOs are nonprofit corporations and receive a portion of their respective **operator's gaming revenue as set forth in each agreement.** These nonprofit license holders reinvest in numerous charitable and civic needs in and outside of their communities. A listing of each QSO can be found on the Iowa Racing and Gaming Commission's website.

Additionally, pursuant to Iowa Code 99F.11(3)"c", eight-tenths of one percent of the adjusted gross receipts is deposited in the county endowment fund under the control of the Department of Revenue. The money is distributed to the 84 counties without casinos.

Lastly, pursuant to Iowa Code 99F.11(2), each QSO receives three-quarters of one percent of sports wagering net receipts.



Iowa's QSOs were projected to distribute \$37,462,105.15 in CY19. The County Endowment Fund distributed \$11,741,496.

Advance Deposit Wagering (ADW)

Advance Deposit Wagering (ADW) is a method of pari-mutuel wagering in which an individual may establish an account, deposit money into the account, and use the account balance for pari-mutuel wagering.

ADWs are authorized under Iowa Code Chapter 99D.11, and have been operating in Iowa since 2016. There is currently only one active ADW licensee in Iowa: ODS Technologies L.P. d/b/a/ TVG Network.

Voluntary Self-Exclusion Program

he first form for the Iowa Voluntary Self-Exclusion Program was signed on October 08, 2004. Since then, more than ten thousand individuals have enrolled in the program, excluding themselves from wagering with or entering the gaming areas of state licensed casinos and racetracks.

Many things have changed for the program over the years. At its inception, individuals were able to enroll for only a lifetime term. Beginning July 01, 2017, the program expanded to allow individuals to enroll for five years or lifetime. The program also allowed individuals who enrolled prior to July 01, 2017 to revoke their enrollment if they had been enrolled for five or more years.

Sports wagering and fantasy sports were included in the Self-Exclusion Program when they became legal in Iowa.

Economic Impact

Historical Timeline

1984-2018

1983	•	Iowa Legislature passed the Pari-Mutuel Wagering Act, allowing qualified sponsoring organizations to apply for a license to conduct pari-mutuel wagering on horse and dog racing.
	•	The Governor appointed the first Racing Commission.
1985	•	Greyhound and harness racing began.
	•	Horse racing began.
1000	•	Legislation allowed pari-mutuel wagering on simulcast races received by a licensed pari- mutuel facility conducting a minimum number of live performances.
1989	•	Legislation allowed the Commission to license qualified sponsoring organizations to conduct gambling games on excursion gambling boats in a county where the electorate approved a proposition by referendum.
1991	•	First riverboat casino began operation in Dubuque.
1992	•	Legislation removed the live performance requirement for simulcast wagering at pari- mutuel facilities.
	•	Significant changes were made to gaming law including the following:
		 Simulcast legislation was amended requiring at least sixty performances of nine live races each day of the season in order for simulcasting to occur.
		 Raised the gambling age from 18 to 21.
1994		 Allowed certain gambling games at racetrack enclosures existing on January 1, 1994 subject to a local referendum.
		◊ Eliminated the prohibition against gambling while dockside.
		 Allowed licensees to conduct gambling on a 24 hour a day basis.
		 Removed the \$200/day loss and the maximum \$5 hand/wager.
1995	•	Legislation required the Commission to cooperate with the Iowa Gambling Treatment Program and incorporate information regarding the program in printed materials.

Historical Timeline

1984-2018

I	 Legislation created the County Endowment Fund in which one-half of one percent of adjusted gross revenue from the gaming tax is distributed to counties that do not have a regulated facility. Legislation established a voluntary self-exclusion program whereby individuals may
2004	voluntarily ban themselves from all facilities for life.
	Change in legislation allowed for racetrack enclosures to offer table games.
	• Change in legislation allowed excursion gambling boats to be located or operated on a natural or man-made lake or reservoir.
2007	• Legislation enacted allowed gambling structures to be land based and removed the requirement to be over water.
2011	Advance deposit wagering was allowed by the legislature.
2014	• Legislation enacted allowed Iowa West Racing Association and Dubuque Racing Association to maintain a license to conduct gambling games without the requirement of scheduling performances of live dog races, allowed the Iowa Greyhound Association to apply for a parimutuel license to race greyhounds at Dubuque, and established the Iowa greyhound parimutuel racing fund under the control of the Commission.
	• Iowa Greyhound Association began live racing at the Iowa Greyhound Park in Dubuque.
2015	• Live greyhound racing ceased at Bluffs Run Greyhound Park in Council Bluffs.
2017	• Legislation allowed patrons who had been voluntarily excluded for life from gambling facilities to request revocation of the exclusion if the exclusion had been in place for a minimum of five years.
2018	• Legislation transferred management of the self-exclusion program to the Commission.

Legislation enacted during 2019 Legislative Session

Legislation signed authorizing sports wagering and fantasy sports contests in the state under the regulation of the Racing and Gaming Commission.

Changes were made to the requirements for some qualifying sponsoring organizations including a residency requirement, adding non-voting ex officio board members, and allowing for distributions to any 501(c)19 organization.

Changes were made to the facility audit requirement clarifying that for a licensed subsidiary of a parent company, an audit of the parent company meets the audit requirement.
