### **Drinking Water and Wastewater Operator Certificate Renewal**

The Iowa Department of Natural Resources is reminding all drinking water and wastewater operators that their certificates expire on June 30, 2021. They have until March 31, 2021 to earn their required continuing education credits in order to renew in 2021. The IDNR is aware that conferences, workshop and all "in person" training was postponed or cancelled in mid-March and will likely not resume until June 1st. Fortunately, this was not our renewal year, so we have the time to assess the continuing education opportunities for conferences and workshops. The new "normal" for operator training and conferences may look different but there will still be plenty of accessible training readily available over the next year.

During this time of quarantine and social distancing, there are still many good quality online and virtual training courses offered through our community colleges, state industry associations, national industry associations, EPA, and other state industry partners. Please continue to monitor the <u>lowa DNR's operator certification training calendar</u> and your email for virtual and future "in-person" opportunities.

## Celebrate Iowa Environmental Laboratories -**Keeping Iowans Safe during COVID-19**

lowa has 40 municipal and commercial environmental analytical laboratories that analyze drinking water samples. Lab results inform the operators and regulators if our water is safe to drink.

"Environmental labs play a key role in protecting public health," said Kathy Lee, with the DNR's Laboratory Certification Program. "Like other essential services, these testing facilities have stepped up to the pandemic challenge, and we should celebrate their commitment."

Environmental labs, like many businesses, have changed how they operate to limit personal contact. Laboratories have split their staff into shifts, enforced social distancing, and have added disinfection procedures for the building and samples delivered to the lab. Some labs are making their own disinfectants.

Most commercial labs also analyze samples from wastewater, landfill leachate, and underground storage tank leaks. Many municipal labs analyze wastewater onsite at their treatment plants. So far, there have been no reports of labs needing to shut down or being unable to analyze samples.
