# 2018 Condition of Community Colleges report available



The Division released its Annual Condition of Iowa's Community Colleges 2018 report at the State Board of Education meeting on January 16. The report provides a comprehensive overview, including academic year and trend data on enrollment, credit and noncredit programs, joint enrollment, adult education, online course delivery, student success, human resources, finances, and more. The report also includes success stories that illustrate how community colleges impact Iowans and the economy.

Report highlights include:

- **131,144:** The number of students enrolled in community college credit courses, down slightly from 132,694 the year before.
- 51,001: The number of jointly enrolled students who earned college credit while in high school, up from 49,868 the year before. Jointly enrolled high school students account for 38.8 percent of total community college enrollees and 24.1 percent of total credits.
- 11,060: The number of students enrolled in developmental education courses designed to help academically under-prepared students get ready for college-level coursework, down from 11,967 the year before.
- 22.4%: The percent of community college enrollment represented by racial and ethnic minority groups, which represents a record high.
- 16,747: The number of credit awards earned (associate degrees, certificates, and diplomas), down from 18,115 the previous year.
- 26,005: The number of noncredit program awards, up from 19,261 the year before. The majority of these awards (69.2 percent) were industry-

# Work on universal e-transcript process underway



lowa State University, the Board of Regents State of Iowa, the Iowa Department of Education, and the Iowa College Student Aid Commission are partnering to create a standardized electronic transcript system for all Iowa public secondary schools. Projected benefits of this exciting new initiative include:

- Simplifying the transfer of records from one lowa school district to another.
- Eliminating the burden of manually sending transcripts for lowa high schools.
- Eliminating or significantly reducing admissions office manual processing of transcripts for Iowa's public colleges and universities.
- Providing significant cost savings for lowa's public school districts, colleges, and universities, as some vendors currently charge fees for postsecondary institutions to receive transcripts.
- Automating the use of multiple measures, and thereby improving community college student placement, to enhance student success.

While a detailed implementation timeline is not yet finalized, there are plans for several high schools to pilot the system as early as 2020, with statewide implementation subsequently phased in. E-transcript steering committee representatives will be reaching out to lowa public secondary schools to elicit feedback and advice. Because the transcript format must be compatible with all lowa high schools, a special effort will be made to contact a wide variety of schools, including those transitioning toward a competency-based education/standards-based grading system.

# <u>Department awarded AmeriCorps grant to serve adult learners</u>

The Iowa Commission on Volunteer Service has awarded the Iowa Department of Education (Department) an AmeriCorps state grant to serve adults lacking basic skills. The program will focus on increasing the capacity and quality of adult education



tutoring by providing additional resources to supplement the current offerings of adult literacy instruction, including, but not limited to, reading (phonetics, vocabulary, fluency, and comprehension), writing, health, mathematics, as well as financial, digital, and family literacy.

To lead this work, the Department hired Jayne Smith as the AmeriCorp program director. Jayne previously worked in adult education and literacy (AEL) as an education program consultant for the Department. In her new role, she will develop and oversee the implementation of the program, which includes the recruitment and training of 40 AmeriCorps members who will provide these additional support services at AEL program sites across the state. Jayne will work closely with the lowa Literacy Council, a key partner in the project, as well as other organizations to identify community needs, leverage community support, and position the *Iowa AmeriCorps Educate and Elevate Program* as a strategy for solving community

adult education attainment needs.

# Contract awarded for curricular approval workflow and database system



The Division of Community Colleges and Workforce Preparation (Division) has awarded a contract to DIGARC for managing the state's career and technical education (CTE) program approval workflow and common course numbering management system. Currently, the state of lowa and the 15 community colleges utilize CurrlQunet's software, META, for such purposes.

Per state requirements, the Division issued a Request for Proposal (RFP) this past summer to select a curricular system, as the current contract with CurrlQunet was set to expire. A CurricUNET software version has been in place in lowa to house the community colleges' programs, courses, data reports, and historical changes since 2012.

DIGARC was one of four vendors considered for the new system contract. The company was selected through a formal review by a team that included staff from several community colleges involved in program approval and common course numbering processes. DIGARC has been in existence since 2001 and has almost 600 small and big colleges as curriculum clients. The company uses Curriculog software to meet colleges' curriculum platform, product, and service needs. They also have separate catalog and section (course schedule) products available for colleges that are not a part of this contract.

Next steps include working on finalizing a contract with DIGARC, which will cover the next six years of curricular management for the state. After a contract is finalized and signed, DIGARC will meet with the key users of the system at the Department and each of lowa's 15 community colleges to establish a curricular system conversion timeline for all stakeholders. It is expected that the current system, CurriQunet META, will be in use through summer 2019.

# lowa Skilled Worker and Job Creation Fund reports released



The Division recently released fiscal year (FY) 2018 reports for the Pathways for Career Employment (PACE), Gap Tuition Assistance, Work-Based Learning Intermediary Network, Adult Education and Literacy Programs (AEL), and the Workforce Training and Economic Development Fund (WTED). These programs are funded through the Department's allocation of the Iowa Skilled Worker and Job Creation Fund, which was created to support worker training and job creation efforts with funding from the state's gaming industry receipts.

FY18 report highlights include the following:

• A total of 1,077 applicants were approved for tuition assistance under the Gap Tuition Program with a statewide completion rate of 87.6 percent.

- A total of 3,233 applicants were approved for tuition assistance under PACE. Of those, 432 PACE participants sought education in credit-bearing programs, 465 sought training in noncredit CTE programs, 1,071 earned National Career Readiness Certificates (NCRC), and 1,318 earned third-party credentials.
- The Iowa Work-Based Learning Intermediary Network provided worksite core services to 110,393 educator and student participants.
- Iowa's AEL programs served 16,095 unique participants.
- A total of 75,507 participants and 2,848 businesses benefited from programs funded through the WTED fund.

# **Contract with Emsi Career Coach extended**



As of November 1, 2018, a new contract for Emsi Career Coach and Emsi Analyst subscriptions was entered into through a partnership with the community colleges, the Iowa Department of Education, and Iowa Workforce Development.

<u>Career Coach</u> resides on the Future Ready lowa <u>website</u> and is designed to help lowans find careers by providing the most current local data on wages, employment, job postings, and associated education and training. Emsi Analyst provides community colleges with access to a database containing economic and workforce data that can be customized by region. The data contained in this online tool includes details pertaining to industries, occupations, job postings, skills, programs, and demographics.

Hawkeye Community College will be the fiscal agent for the agreement, which allows unlimited access to the career and employment linkages available through Career Coach, and for each community college to have access to the Emsi Analyst database. This partnership was made possible through the use of the Workforce Training and Economic Development (WTED) Fund allocation.

# Work begins on development of statewide secondary CTE standards

Work is under way to develop, review, and adopt new state standards and benchmarks for career and technical education (CTE) program service areas, as required by HF 2392. This legislation, which is helping shape the future of CTE in lowa, sets new requirements for the lowa State Board of Education (Board) to adopt secondary CTE standards, moves from a voluntary to a mandatory CTE program approval process, and calls for school districts to incorporate the standards into their CTE programs. Similar to how the lowa Core provides statewide academic standards in the areas of mathematics, literacy, science, social studies, and 21st century skills, the secondary CTE standards and benchmarks will set clear and consistent expectations for what students need to learn in high-quality secondary CTE programs across the state.



The Bureau of Career and Technical Education has contracted with Advancing Connections, Inc. to assist with the development and review of the standards and benchmarks for each of the six CTE program service areas: agriculture, food, and natural resources; applied science, technology, engineering, and manufacturing; information solutions; business, finance, marketing, and management; health science; and human services. Once this work is complete, the standards for each of the six service areas will be presented to the Board for final approval and adoption.
