REPORT.

To the Honorable, the General Assembly of the State of Iowa:

THE undersigned has the pleasure to submit herewith the following report of this department of the public service.

At date of my last report the whole number of books in the library, exclusive of pamphlets and duplicates, was 18,157

Additions made since are:

By purchase 1,225

By donation and exchange 1,085

Total additions 2,310

Whole number in library 20,468

A specialty has been made of Iowa books; viz., those written by Iowa authors; those published by Iowa publishers; and all others relating to Iowa, especially histories. A Utility Scrap-book has been placed upon the librarian's table, in which are filed "scraps" of the history, etc., of Iowa, cut from newspapers.

A portfolio of music by Iowa composers has also been added, by donation of the composers.

The life-size illustrations of Audubon's Birds of America, with easel for holding the same, has been placed in the library; also a smaller easel for the support, while in use, of other illustrated works.

A number of old English, as well as the later British Colonial reports, have been imported and the library now has a nearly complete set of English, as well as of American reports. A case of English law text-books has just been received, but too late to appear in the catalogue contained in this report.

To utilize space, time, and patience, many of the pamphlets have been bound, numbered, and indexed in manuscript.

An agricultural department, including horticulture and domestic animals, has been added. In this connection, I would respectfully suggest that a number of copies of the reports of our State Agricultural Society be given the library for distribution to other libraries. I am informed by Mr. Noyes, librarian of the Brooklyn Mercantile Library, that inquiry is made at his office, almost daily, for the agricultural reports of the Western States, by immigrants and others desiring homes in the West; to such inquirers, Iowa is a sealed book.

The crowded condition of the library has been the burden of library reports (as well as of the librarian) for lo, these many years, and what more can be said! Every available foot of space in the library-room and in the duplicate-room down stairs has been filled by additional shelving.

Most of the congressional documents and files of newspapers have been placed in the duplicate-room; persons desiring to consult them have the pleasure of standing edgewise between shelves and boxes and possibly removing one or two rows from the shelf before finding the desired volume. I have known instances of gentlemen losing their reverence for books through such experience, especially when the thermometer stands at 15' below zero. In the library proper, shelving has been placed upon the tops of the cases and crowded with books, at the risk of ruining the bindings and killing or maiming the person who attempts the dangerous ascent of short ladders and narrow shelves to reach them. Much valuable time is wasted in the handling of books, which can be obviated only by more room. We not only lack space, but a place of security against loss by fire, tornadoes, etc. The destruction of this invaluable collection of books, which may occur any windy day, would be a calamity from which our State would not recover for generations, if ever. In view of the many dangers surrounding the library, the want of room and the extra work and waste of time resulting therefrom, the injury to the books, etc., etc., would it not be well to provide that the library-room in the new capitol be finished at once and the library removed thereto?
