INTRODUCTORY.

This Tenth Biennial Report of the Historical Department of Iowa presents its detailed business of the two years ended June 30, 1910. The Ninth detailed the business for the three previous years.

The work of the Department has been carried forward along the lines projected at its beginning. There have been no essential changes in policy and none are in contemplation or desired. There has been no surcease of effort in collecting the source materials of the history of Iowa and the middle west, but additional stress has been put upon the work of making these materials ready for the user. The zeal of all the workers has been unrelaxed, and results are measured by their strength. The petition for help and means will be found to be the principal message of this report, next to the value of the work done.

THE ANNALS OF IOWA.

The third series is in its eighteenth year; it is an eighty-page quarterly devoted primarily to the publication of the original materials upon Iowa and western history and biography. It is a medium of information concerning the Department and its activities, forms an exchange for publications and materials, and is sent cost-free to all Iowa public libraries that desire and preserve it. There are constant demands for complete sets of this most valuable journal. We have been under the necessity of reprinting two numbers during the past year, and there are at least three more that are, or soon will be, out of print. An index for the first ten volumes is imperatively needed, and should at once be provided, in an edition sufficient to supply at least each Iowa public library, and various other activities now receiving and binding the Annals. This, again, is a matter for both assistance and means we are at present without.

LIBRARY.

The library of the Historical Department of Iowa is not a general library, but is devoted to such special subjects as early western history; the North American Indians; the Civil War, particularly

regimental histories; publications of historical societies and kindred institutions. While additions are made in all these departments, especial attention is given to the collection of Iowa publications and Iowa history and genealogical material. In the latter class are included general genealogical works, books on heraldry, separate family histories, histories of towns and counties of the older eastern states, colonial and revolutionary records, vital statistics, etc. An interesting recent acquisition to this department is the Almanach de Gotha, covering the period from 1838 to the present time. Additions are being made in all the classes mentioned as rapidly as our funds will permit. At the present time the genealogical department is one of the strongest in the middle west. It is in constant use by people from all parts of Iowa, as well as outside the State. In the past biennial period 1,148 volumes have been added to our library.

MANUSCRIPTS.

This feature, as, indeed, the institution, began with the private collection of autograph materials of the founder, Mr. Charles Aldrich, and has come to embrace manuscript accumulations. We acquire materials of primary interest to the collector of autographs and are urging the deposit here, especially by Iowa people, of such writings, pamphlets and similar materials as indicate their individual activity and effectiveness during their lives. Thus in the biennial period there have reached us thousands of most interesting and important documents, among the richest of these being the gift of Mr. H. F. Bowers of Clinton, Iowa, several times nominated for President by the American Protective Association. Others are from Hon. John A. Kasson, Col. J. M. Griffiths, Mr. Arthur Hartmann and Gov. S. B. Packard. The materials from Mr. Kasson include notes and manuscripts, letters and pamphlets, bearing upon his studies and official duties as a representative of the United States in various capacities and in different foreign countries. The materials of Gov. Packard are those gathered in his service in command of a Maine regiment during the Civil War; as a Federal official in Louisiana during reconstruction days, and as United States Consul to England. The materials of Col. Griffiths are the regimental records of the 39th Iowa regiment of Volunteer Infantry. Mr. Hartmann is a celebrated violin virtuoso, whose friends are leading artists in the world, and, although he is not a citizen of America, a visit to this institution resulted in his depositing here

some most valuable items, including personal letters, autograph scores, and other materials of the leading musicians of our generation. A detailed list is set out later in this report. These great collections, as also those of Gen. Grenville M. Dodge, referred to in our last Biennial Report, will eventually be placed in suitable binding and be at the service of any responsible person under reasonable restrictions, but now remain unhandled and practically inaccessible for want of help.

IOWA AUTHORS.

An interesting exhibit in the Iowa building at the Louisiana Purchase Exposition at St. Louis in 1904 was a collection of books by Iowa authors. The auxiliary committee of the Iowa Commission, consisting of Mrs. W. H. Bailey of Des Moines, Mrs. Henry J. Howe of Marshalltown and Mrs. H. E. Deemer of Red Oak, made this collection, and a list of these books and others by Iowa authors was prepared by Mrs. Howe, and published by the Iowa Library Commission. At the close of the exposition, this collection was deposited in the Historical Department of Iowa. On account of insufficient help, lack of space, the confusion incident to completing the building, and the pressure of other work, nothing was done to develop this collection until a few months ago, when a case was provided by the Executive Council for exhibiting this special collection. It is our desire to add constantly to these books, and it is hoped that in time a creditable showing may be made of the work of Iowa authors. Additions have been made thus far wholly by gratuitous contributions, and it is hoped the collection may be developed largely in this manner. Many of the books now in the collection contain autograph letters signed by the authors, which greatly add to their value and interest. We ask the co-operation of all Iowa writers and friends of the institution in building up this collection.

NEWSPAPER FILES.

Our newspaper collections have, from the first, been considered one of the most important features of the Department. Files of at least two papers from each county are to be found on our shelves dating from the establishment of the Department in 1893. Many valuable early files have been acquired from time to time, and it is hoped that many others will find their way here. These papers are substantially bound and carefully catalogued. A card index of the leading articles in the daily and weekly papers along the lines of

Iowa history and biography, prominent events of state importance, and notable speeches and addresses by Iowa men, is kept. This makes readily accessible a vast amount of material that would otherwise be lost, or which we could only find after long search. With adequate help, the work of indexing these Iowa newspapers could be extended with great profit. A comprehensive index should be made of all early Iowa papers, and of at least one paper from the beginning. Papers from outside the State are received, an effort being made to have a representative paper from each section of the country, so the activities and enterprises in public and private life of Iowa persons elsewhere may be on record here. All Iowa papers come to the Department in exchange for the *Annals of Iowa*. Aside from the regular newspaper catalogue, in which papers are entered alphabetically by towns, a chronological list has been prepared, making it possible to tell at once which of our papers cover any particular year or period. Among the important acquisitions of early Iowa papers during the past biennial period may be mentioned: *Sioux City Register*, July, 1858, to November, 1870; *Iowa Eagle*, July, 1857, to October, 1859; *Sioux City Times*, June, 1869, to February, 1876, and *Sioux City Journal*, August, 1864, to December, 1878, presented by Miss Susannah Weare of Sioux City, in memory of S. Y. Davis and George Weare; files of early O'Brien county papers, from Mrs. Warren Walker, covering the years 1872-1893. We have received from C. H. Dutton of Wheatland, Iowa, *The Truth Seeker*, New York, Vols. I-XX, with a few volumes of *The Boston Investigator* and *The San Francisco Free Thought*.

PORTRAIT COLLECTIONS.

Appended is a list of the portraits acquired during the biennial period. Our State already ranks well in the amount and value of its collections of materials illustrative of the lives of its officers and builders. In this branch of our work we are strongly influenced by the considerations of the National Portrait Gallery of London, as set forth in their statement: "The rule which the Trustees desire to lay down to themselves in either making purchases or receiving presents, is to look to the celebrity of the person represented rather than to the merit of the artist. They will attempt to estimate that celebrity without any bias to any political or religious party, nor will they consider great faults and errors, even though admitted on all sides, as any sufficient grounds for excluding any portrait which may be valuable as illustrating the civil, ecclesiastical or literary history of the country."

In our autograph cases, in our Black and White room, and in our galleries of oil paintings are thousands of portraits of those who have been most effective in the upbuilding of their community and State, and in every instance we have procured the very best possible in point of art. The result is a collection in which are some most valuable canvases and a gallery unexcelled in beauty, interest and value in any state collection. I especially urge that the State itself take the lead in providing portraits of highest art standard, by appropriating a fund from which the Historical Department may furnish at least a thousand dollars toward the portrait of each Iowa Governor, allowing any one interested to add thereto and share in the selection of the artist and in the criticism of the finished work.

MUSEUM.

This phase of our work has been probably more conspicuous than any other in its rapid transformation to the useful and ideal during the past two years. This is largely due to the splendid equipment furnished us by the Executive Council and the provision for the first time of work room and storage facilities. Show cases of the type desired have been supplied, but occupy less than half of the show room easily available. There have been installed typical collections of prehistoric and recent life not before adequately displayed, it is believed, in a popular museum in Iowa. In our administration we endeavor to educate by suitable specimens, illustration and label-text, precisely as is done in libraries, except we try to make the materials attract the eye of the unskilled and uneducated as well as the thoroughly cultured, and to so provide and display the label accessories as to make these easily and instantly convey their meaning to every one. Nothing morbid, sensational nor of doubtful value is displayed. In thus building a museum our limitations are rather of assistance in making ready than of acquiring specimens. Contrary to the usual thought, it is comparatively easy to gather desirable specimens for a museum, but the expense in time and money of converting these from an unintelligible and meaningless mass of more or less curious objects into a museum with a powerful influence upon the popular mind is the true aim of the museum builder. This influence is being noticed and duly regarded in our State. Popular museum education has recently become seriously advocated everywhere in America, and within five years has been applied in Iowa not only in her great popular agricultural

museum—the Iowa State Fair—but in the traveling museums demonstrative of better agricultural processes, known as “Soils Specials,” or “Seed Corn Specials” and the like. The field for visualizing practical ideas is limitless, and the Historical Department should be equipped in a way commensurate with its opportunities for rapidly perfecting its museum and for responding to appeals for circulating cabinets of selected specimens to be sent to Iowa schools.

ARCHIVES.

Such of the archives of the State offices as are not in use, and are ten years old, are deposited in one of the rooms of the Historical Department. Making these accessible to the public is a work under the direction of the Executive Council, and when the work is finished, they become a part of the collections of the Historical Department. Up to the present time no delivery of finished work has been made. It would seem advantageous to all interested if the work upon the archives as well as their custody were among the duties of the Department so that a proper interchange of interest and information between the historical and archives work might be maintained, and appropriate reports of the work currently embraced with that of the rest of the Department.

SPECIAL FIXTURES.

There has been provided in the main, through the unaided skill and ingenuity of the employes of the Custodian, an inter-communicating telephone system and the substitution of electricity for gas throughout the west wing of the building. Both must have been done at immense saving. The provision of display cases and of a passenger elevator and the equipping of the freight elevator for automatic service remain of the greatest importance of anything yet to be done. The relocating of the steam-heating or tempering coils so as to avoid their freezing, without arresting the free and open ventilation, and the installation of a system of air cleansing which will remove the extraordinary destructive character of the smoke and gas-charged atmosphere, should be done promptly. I feel that all the mechanical work necessary for the last two items could be done by the Custodian and the expense would not equal the amount of injury being suffered or of repairs certain to follow to walls, canvases and books. Thermostatic control of roof ventilators and heating coils should be installed. The wear upon the wood

floors in the portrait galleries and principal museums shows that a different surface is needed. It would be best to have tile floors in these apartments.

SPECIAL CASES.

At least three special collections should be given appropriate cases very soon. These are the collection of Revolutionary items presented and regularly augmented by the Iowa Daughters of the American Revolution; the collection of four beautiful and valuable Royal Chinese scrolls, now necessarily and almost completely inaccessible to the general public, and the map and manuscript collections as yet to some extent stored in shipping boxes and other awkward receptacles. Probably no more important step remains to be taken than that of having the help and the auxiliaries for putting into the reach of the people such things as these. A splendid beginning for a collection of statuary has been made, and the provision of appropriate pedestals and furniture would admit of an excellent display.

HOUSEKEEPING.

This building is now for the first time in finished state, and the extraordinary difficulty of keeping it in order during the intrusions of structural workmen is past. The resulting obligations of keeping every part of the building open and in order proves a greater task than can be done with the present housekeeping force. There is great need of at least two additional janitors, while the services of at least one janitress is most imperative.

There are safekeeping as well as housekeeping problems for solution by the Curator. Therefore all needs for efficiency in locks, tools for small repairs, materials for cleansing floors, and every matter touching surveillance, sanitation and sightliness should be at hand instantly on requisition by the Curator. Accounting and responsibility for these, as a matter of course, should follow, but ends for which these are means sometimes do not admit of either delay or explanations. Union soldiers in the Civil War are, and even without the statute should especially be in this institution, preferred for housekeeping employes, but a fund should be at hand from which to provide escape for these good men from occasional and extraordinary calls without risk to property or visitors' most refined sensi-

bilities. The youngest soldier now employed is 65 and the youngest soldier applicant is 64. But sending these brave men to roofs or walks in zero winds is not right; and jeopardizing property and public comfort is wrong. Spotlessness of floors and furniture, such as is desired in our homes, and is expected in our Department, is much less a matter of muscle than of vision. I would have the soldier-janitor privileged to call on me for help and receive instant, if temporary, response from more youthful hands.

ADMINISTRATIVE CHANGES.

The founder, Mr. Charles Aldrich, who died March 8, 1908, never withheld his warmest praise from his assistant of many years, Miss Mary R. Whitecomb. The singular beauty and strength of her character, her attainments and her inspiring influence were almost indispensable to the present Curator, who as assistant to the Curator, was, after the death of Mr. Aldrich, placed in charge as Acting Curator. Miss Whitecomb survived Mr. Aldrich but a little more than a year, passing away on April 8, 1909. Neither the office of Mr. Aldrich nor that of Miss Whitecomb was filled at once, but upon the expiration by law of the office of assistant to the Curator, held by the present Curator, he was appointed on July 1, 1909, to the vacancy occasioned by the death of Miss Whitecomb, continuing without interruption in responsibility under a resolution of the Board of March 14, 1908, authorizing him to assume the responsibility of Acting Curator. On November 23, 1908, the office of Curator was filled by the appointment of Mr. Benjamin F. Shambaugh, but during his incumbency which terminated by his resignation on April 12, 1909, he did not assume personal charge, directing that the work continue in the identical way that obtained theretofore. The vacancy in the Curatorship continued until October 1, 1909, when the present Curator was appointed and the assistant curatorship immediately filled by the promotion to that place of Miss Alice M. Steele, for twelve years an assistant to Mr. Aldrich. The position made vacant by Miss Steele was assigned to Miss Ida M. Huntington.

ACKNOWLEDGEMENT.

It is but fair to acknowledge that the Curator could not have carried the load and have advanced the work without the assistance and encouragement that has been given throughout the

period by the Board of Trustees and the Executive Council. It must be remembered that our success is inseparable from the custom of voluntary giving. This institution annually receives objects and materials, which, if purchasable, would cost great sums of money. It is not proper to disclose prospects, but it is proper to report that within the biennial period promises have been secured and testamentary conditions arranged which must in the natural course result in the free acquisition of collections of a value not equalled by any heretofore acquired. Influence has been exerted toward the founding of other institutions within the State that can if established, but be of incalculable value to the people. In conference and in correspondence the Curator has invariably advanced the consideration for gifts that he is acting under the advice and support of the chief officials of the State, upon the Board of Trustees, and invariably this consideration has been the moving factor in a favorable decision. In many instances the participation in arrangements by the Board or members thereof has been the determining influence. In the judgment of the Curator only success must attend the institution while it has an unselfish, patriotic and appreciative Board of Trustees, duly cognizant of the principle of gifts.

It is proper here to renew the request of two years ago that the unselfish, patriotic and invaluable services of Charles Aldrich to the State of Iowa should be conspicuously and indelibly commemorated by some suitable sculpture, or inscription on the Historical Building.

ESPECIAL EFFECTIVENESS SOUGHT.

The importance of precisely knowing the amount and character of work done through this institution is recognized. We believe we are serving in a beneficial way numbers not suspected by the general public. There should be a system of turnstiles for counting visitors to the Historical Department and of requisition for and report upon delivery to those who seek them of the newspapers, books, manuscripts, etc. All the activities and the use of all the collections should be accounted for, so that officers and public may know the merit of appeals for equipment, assistance, etc. Such methods are in vogue in the principal institutions of a similar character throughout the country and upon the basis of results thus disclosed are made the awards of public support.

JUSTIFIED REQUEST FOR INCREASE OF MAINTENANCE.

In view of the disappearance of the biennial request for building appropriation, hitherto ranging from a few thousands to many thousands of dollars; of the great number and value of objects and materials on hand and in prospect; of the increasing demands for the use of materials and for the assistance of the officials of this institution, a hope is justified that the employe list may be increased and the maintenance appropriation raised to a sum not less than \$20,000.00 annually, for at least the next two years.
