REPORT.

IOWA STATE BOARD OF DENTAL EXAMINERS,
SECRETARY'S OFFICE,
DUBUQUE. November 15, 1885.

To his Excellency, BUREN R. SHERMAN, Governor of Iowa:

SIR—In accordance with the provisions of section 9, chapter 36, laws of the Nineteenth General Assembly, State of Iowa, I have the honor of presenting this the Third Annual Report of the Iowa State Board of Dental Examiners, together with lists of dental practitioners registered and licensed under the law, statistical tables, and other matters of interest pertaining to the dental profession of our State.

Since the annual report for 1884, the third regular annual meeting of the Board was held at Des Moines, commencing on Tuesday, May 5, 1885, and closing Friday, May 8th, the annual meeting of the Iowa State Dental Society being in session at the same time and place. J. Hardman, of Muscatine, and W. P. Dickinson, of Dubuque, were respectively re-elected President and Secretary for the ensuing year.

Seventeen (17) applicants for license were examined, as to their qualifications. Eleven (11) correctly answered the required per cent of questions, and have received their authority to practice dentistry in Iowa.

Six (6) with percentage of correct answers below the requirements of the Board were rejected.

The Board has abandoned the practice of granting temporary licenses at their meetings, and has raised the per cent to seventy-five (75) in all cases, whether for temporary or permanent license; parties who fail before the Board, are not debarred from applying subsequently to some member of the same, who, upon satisfactory evidence of diligent study and preparation, and re-examination in writing, *may* grant a temporary license, "to remain in force only until the next regular meeting of the Board."

There are now six (6) temporary licenses in force. One (1) of which was issued to a party who was rejected at the meeting in May last.

The total number of registered and licensed dentists in Iowa, as shown by the records of the Board, is four hundred and thirty-four (434), an addition during the year—since November 15, 1884—of twenty-nine (29). Eighteen (18) of whom are graduates of reputable dental colleges. In 1883 an Association of State Examining Boards was organized and is now composed of representatives from nineteen (19) State Boards, ours being of the number. The objects of this Association, are “to secure through the operation of the various State Examining Boards, a high and uniform standard of qualifications for dental practitioners, and so far as practicable, uniformity of methods in the working of these Boards, and of legislation in creating them.” At a meeting of this National organization, held at Minneapolis in August last, in addition to a re-iteration of condemnation of a certain institution, in issuing diplomas, *sine curriculo*, a resolution was adopted, recommending the non recognition of the diplomas of the Royal College of Dental Surgeons of Ontario, for cause, and requesting the State Boards to require an examination of graduates from said college before granting license to practice in their respective States. In accordance with this recommendation we shall pursue such course.

It seems to be quite generally understood by the profession at large, that Iowa has a law regulating dental practice, and the instances during the past year have been few, where dentists have taken up residence in the State without either obtaining license upon their diplomas or submitting to examination for temporary license.

The high ground taken by so many of the States, in enacting laws regulating the practice of dental surgery, has changed public sentiment to a marked degree in relation to dental education, and the young man now who proposes entering the profession sees that the proper entrance is through a regular course of study and graduation from some reputable college. Experience is demonstrating too, that the time is near at hand when none but graduates should be licensed, and in the States now having this requirement the result has been, so far as we can learn, beneficial and eminently satisfactory. We shall hope that in the near future our State will take this advanced step, and be one among the leaders, instead of being with the last to fall into line.

We should have in the meantime an amendment to our present law, whereby the fees for licenses should be at least ten dollars for those granted upon examination, and five dollars upon diplomas. This would be in accord with the fees as required in all the newer enactments of other States, and would give the Board funds for the prosecution of their work with much greater efficiency than is now possible with the limited amount at their command. The Iowa State Dental Society, appreciating our needs, this year again generously donated the sum of fifty dollars, which we gratefully acknowledge. We believe it is understood by the public, so far as they are acquainted with the organization of our Board, that our work is entirely carried on without pecuniary assistance from the State.

We take pleasure in again reporting an increased number of Iowa students in attendance upon lectures in the several Dental Colleges in the country, and we acknowledge the prompt and courteous responses of the Deans of those schools who have furnished us the desired data, to enable us to report that there are during the present session, 1885-6, fifty-six (56) Iowa students so engaged. Of this number forty-seven (47) are in the dental department of the Iowa State University at Iowa City, nine (9) are in other schools. Of the forty-seven (47), four (4) are registered practitioners, and eleven (11) are second course students of the department. Last year we reported thirty-eight (38) in all as attending the several schools.

Practitioners of Dentistry in the State of Iowa," approved March 8, 1882, in the several branches of Anatomy, Physiology, Surgery, Histology, Pathology, Chemistry, Hygiene, Therapeutics, Materia Medica, Theory and Practice of Dentistry, and Operative and Mechanical Dentistry, and he having given evidence of his proficiency in the same, and of his experience, discretion, and good moral character, is hereby authorized to practice dentistry in the State of Iowa.

LAWS.

CHAPTER 36, NINETEENTH GENERAL ASSEMBLY.

AN ACT TO INSURE THE BETTER EDUCATION OF PRACTITIONERS OF DENTISTRY IN THE STATE OF IOWA.

Be it enacted by the General Assembly of the State of Iowa:

SECTION 1. That it shall be unlawful for any person who is not, at the time of the passage of this act, engaged in the practice of dentistry in the State, to commence such practice unless such person shall have received a license from the Board of Examiners, or some member thereof as hereininafter provided, or a diploma from the faculty of some reputable dental college, duly authorized by the laws of the State, or by some other of the United States, or by the laws of some foreign country in which college, or colleges, there was at the time of the issue of such diploma, annually delivered, a full course of lectures and instruction in dental surgery.

SEC. 2. A Board of Examiners is hereby created, whose duty it shall be to carry out the purpose and enforce the provisions of this act. The members of such Board shall be appointed by the Governor, and shall consist of five practicing dentists, who shall have been engaged in the continuous practice of dentistry in the State for five years or over at the time of or prior to the passage of this act. The term for which the members of said Board shall hold their office shall be five years, except that the members of the Board first appointed under this act shall hold their office for one, two, three, four and five years, respectively, and until their successors shall be duly appointed. In case of vacancy occurring in said Board, such vacancy shall be filled by the Governor.

SEC. 3. Said Board shall choose one of its members President, and one the Secretary thereof; and it shall meet at least once in each year, and as much oftener and at such time and place as it may deem necessary. A majority of said Board shall at all times constitute a quorum, and the proceedings thereof shall at all reasonable times be open to public inspection.

SEC. 4. It shall be the duty of every person who is engaged in the practice of dentistry in the State, within six months from the date of the taking effect of this act, to cause his or her name and residence, or place of business, to be registered with the said Board of Examiners, who shall keep a

book for that purpose; and every person who shall so register with said Board as a practitioner of dentistry, may continue to practice the same without incurring any of the liabilities or penalties of this act.

SEC. 5. No person whose name is not registered on the books of said Board as a regular practitioner of dentistry, within the limits prescribed in the preceding section, shall be permitted to practice dentistry in this State until such person shall have been duly examined by said Board and regularly licensed in accordance with the provisions of this act.

SEC. 6. Any and all persons, who shall so desire, may appear before said Board at any of its regular meetings, and be examined with reference to their knowledge and skill in dental surgery, and if such person shall be found, after having been so examined, to possess the requisite qualifications, said Board shall issue a license to such person to practice dentistry in accordance with the provisions of this act. But said Board shall at all times issue a license to any regular graduate of any reputable dental college, without examination, upon the payment by such graduate to the said Board of a fee of one dollar. All licenses issued by said Board shall be signed by the members thereof and be attested by the President and Secretary, and such license shall be *prima facie* evidence of the right of the holder to practice dentistry in the State of Iowa.

SEC. 7. Any member of said Board shall issue a temporary license to any applicant upon the presentation by such applicant of the evidence of the necessary qualification to practice dentistry; and such temporary license shall remain in force until the next regular meeting of said Board, occurring after the date of such temporary license, and no longer.

SEC. 8. Any person who shall violate any of the provisions of this act shall be liable to prosecution, before any court of competent jurisdiction, upon information, and, upon conviction, shall be fined not less than twenty-five dollars nor more than fifty dollars for each and every offense.

SEC. 9. In order to provide the means for carrying out and maintaining the provisions of this act, the said Board of Examiners may charge each person applying to or appearing before them for examination for license to practice dentistry, a fee of two dollars, and out of the funds coming into the possession of the Board from the fee so charged, the members of said Board may receive as compensation, the sum of five dollars for each day actually engaged in the duties of their office. And no part of the salary or other expenses of the Board shall be paid out of the State treasury. All moneys received in excess of said per diem allowance shall be held by the Secretary of said Board, as a special fund for meeting the expenses of said Board, he giving such bond as the Board shall from time to time direct. The said Board shall make an annual report of its proceedings to the Governor, by the fifteenth of November of each year, together with an account of all moneys received and disbursed by them pursuant to this act.

SEC. 10. Any person who shall be licensed by said Board to practice dentistry shall cause his or her license to be registered with the county clerk of any county or counties in which such person may desire to engage in the practice of dentistry; and the county clerks of the several counties in the

State shall charge for registering such license a fee of twenty-five cents for each registration. Any failure, neglect or refusal on the part of any person holding such license to register the same with the county clerk as above directed, for a period of six months, shall work a forfeiture of the license; and no license, when once forfeited, shall be restored except upon the payment to the said Board of Examiners of the sum of twenty-five dollars, as a penalty for such neglect, failure or refusal.

SEC. 11. Nothing in this act shall be construed to prevent persons from extracting teeth.

Approved March 8, 1882.

The policy of this Board is to obtain a willing compliance from every one affected by the law, but where stubborn determination manifests itself to evade its requirements, without any regard to honor or justice, no other course is open to it than to meet such cases with all the force of legal compulsion that the law furnishes, and to that end it is confidently expected that every dentist in the State having the welfare and good name of his profession at heart, will give the Board his hearty and vigilant co-operation. It may be well to remember, however, that the members of the Board are not constituted by the law a corps of detectives or a Board of Prosecution, and that any one has the same power and the duty devolves upon them as much as upon us, to file information before a justice of the peace as when any other breach of the law is brought to their notice. Cases of known violation, however, should be reported at once to the Board, giving full name of the party, where practicing, name and residence of a reliable justice of the peace in whose jurisdiction the law is being violated, and any facts bearing on the case. *No notice will be taken of anonymous communications.*

Dentists holding diplomas from reputable dental colleges and desiring to commence practice in the State, can obtain license by proving their diplomas before any member of the Board and paying the fee of one dollar.

All others must appear for examination. Those wishing to commence practice before the next meeting of the Board must *apply in person* to some member of the same, and answer correctly the per cent of questions used for such purpose, (as stated below,) in order to obtain temporary license; this, if granted, is valid only until the meeting of the Board, when, if the party holding it, desires to continue in practice, he or she must appear before the full Board for final ex-

amination. The fee for examination either for temporary or permanent license is two dollars, not returnable in case of rejection.

Examinations are conducted in writing, and embrace the subjects of Anatomy, Physiology, Pathology, Histology, Surgery, Materia Medica, Therapeutics, Chemistry, Irregularities, Operative Dentistry, and Prosthetic Dentistry, and may, at the discretion of the Board, be supplemented by oral examination and practical demonstrations.

In every case seventy-five (75) per cent of correct answers to the full quota of questions used, is required to entitle an applicant to license.

Dental students or assistants who are entrusted by their employers to render professional service in their absence, either in the office or outside, are expected to procure license, as are first course students of the colleges, who desire to practice between the sessions of the same. The attention of licensees is called to the fact that they are required to have their licenses recorded in every county in which they practice.

All registered and Licensed dentists of Iowa are expected to inform the Secretary of changes in their address, if they desire their names to appear correctly in the yearly reports of active practitioners.

Parties expecting answers to communications to members of the Board, and specially on matters of interest to themselves alone, should not neglect to inclose stamps for return postage.

The regular meetings of the Board are held on the Monday preceding the first Tuesday in May of each year, at such place as the Iowa State Dental Society may meet. The next meeting will take place at Iowa City on Monday, May 3, 1886.
