## SECRETARY'S REPORT.

IOWA STATE BOARD OF DENTAL EXAMINERS, }  
SECRETARY'S OFFICE, }  
TIPTON, November 15, 1890. }

*To his Excellency, HORACE BOIES, Governor of Iowa:*

SIR—In compliance with law, and in obedience to the special instructions of the Iowa State Board of Dental Examiners, I have the honor to submit herewith their eighth annual report.

Since the annual report for the year 1889 was rendered, the board has held two meetings, one at Dubuque in May, 1890, and one at Des Moines in October.

At the annual meeting in May, the members present were Drs. J. T. Abbot, Manchester; E. E. Hughes, Des Moines; E. D. Brower, Le Mars, and S. A. Garber, Tipton. Dr. Joseph Hardman, Muscatine, president of the board, being seriously ill at home. During the meeting, a dispatch was received announcing the death of Dr. Hardman. After passing appropriate resolutions in reference to the death of the president, the board organized by electing Dr. J. T. Abbott, Manchester, president, and Dr. S. A. Garber, secretary, for the following year.

At this meeting eight candidates were examined; three of these were found qualified and duly licensed, the other five failed to obtain the required per cent, and were rejected.

At the special meeting of the board held at Des Moines, October 24 and 25, 1890, complaint was made against four Des Moines dentists, who were reported as practicing dentistry in violation of the law, and upon investigation it was found that the charge made against these parties were sufficient to warrant the board in taking prompt action in the matter. Accordingly information was filed by the board, through its secretary, before Justice Johnson, of Des Moines, and, as it appeared later, these willful infractors of law

combined and employed competent attorneys who filed a demurrer as to the constitutionality of the dental law, and owing to lack of funds the board was compelled to go to trial without competent associate counsel to present the facts in the case, and the result was the law was declared unconstitutional by the justice; the board has appealed to the district court.

In this connection the board feels it a duty it owes to your Excellency, who has appointed some of its members; to the people of the State, in whose interest and for whose welfare they were appointed, and to themselves individually, to call attention to the fact that this board has, since it was created by law in 1882, conscientiously discharged its official duties, practically without a dollar's compensation.

The members hereof, having received no *per diem* as provided by the law, and have defrayed their own expenses of travel and hotel bills in holding meetings. They have in their recent attempt to enforce the law, been compelled to obligate themselves to pay competent counsel to present the case for the people of Iowa, in the board's appeal to the district court. Therefore, we respectfully solicit your Excellency's future co-operation in securing such amended dental legislation as will make ample financial provision for the enforcement of the law which creates such official boards as ours.

At the special meeting held October, 1890, one candidate presented for examination. This party failed to correctly answer the required per cent of questions in use by the board, and was rejected.

Thirty-eight licenses have been issued since last report to holders of diplomas, and three licenses granted upon examination. Thirty-six temporary licenses have been issued upon examination to junior dental students and others; nine of these temporaries remain in force until May, 1891.
