

Buprenorphine Prescriptions

Recent Iowa data suggest that buprenorphine prescriptions for the treatment of opioid use disorder (OUD) continued to climb through 2019. Prescription Monitoring Program data shows that 2019 saw over 37,000 prescriptions filled - an increase of more than 20,000 in five years. Buprenorphine is an opioid agonist/antagonist that blocks other narcotics while reducing withdrawal risk. It is an FDA-approved medication, which is proven to successfully treat OUD and help sustain recovery, especially when accompanied by counseling and behavioral therapies. These numbers are encouraging for the efficacious treatment of OUD in Iowa.

When Coronavirus Pandemic Passes, We'll still face the Opioid Epidemic

In this article, Nicholas Bush describes the effect of the coronavirus pandemic on the opioid epidemic. Not only is the coronavirus pandemic eclipsing coverage on the opioid epidemic, it may be triggering for both developing an opioid use disorder and for those in recovery. As he describes, "there is never going to be a vaccine for the cycle of grief, pain and addiction."

Number of US Opioid Overdose Deaths May Be Higher Than Recent Estimates

A new national analysis of data from the Centers for Disease Control and Prevention (CDC) demonstrates that the actual number of opioid-related overdose deaths in the U.S. may be much higher than the previously estimated 400,000 since 1999. The researchers analyzed more than 630,000 overdose deaths reported to the CDC between 1999 and 2016. They found that opioid overdose deaths in cases where a specific drug was indicated may be 28% higher than previously estimated, and more than double in some states.
