## **Disability Information and Access Line**

In June the United States Health and Human Services (HHS) announced the launch of a national hotline to connect people with disabilities to information and services to improve access to COVID-19 vaccines. The hotline is called the Disability Information and Access Line (DIAL) and will help people with disabilities find vaccination locations in their communities, assist callers with making vaccination appointments, and connect callers to local services as needed to overcome barriers to vaccination.
