Reinstatement of Retroactive Coverage for Individuals Residing in a Nursing Facility at Application

In accordance with Senate File 2418 passed by the lowa Legislature during the 2018 session, the Department of Human Services (DHS) is reinstating the provision of three months of retroactive Medicaid benefits for applicants who are residents of a nursing facility at the time of application and are otherwise Medicaid-eligible.

This revised policy is effective for new Medicaid applications filed on or after July 1, 2018. System changes in alignment with this policy revision will be made effective October 1, 2018.

Iowa Health and Wellness Plan members and Dental Wellness Plan members that receive a monthly billing statement in the mail, can now make their contribution online.

Make a payment online at any time using the Department's new secure website, "ClickPay": <u>https://secureapp.dhs.state.ia.us/clickpay</u>.

Payments may only be made from your checking or savings account. Once you submit your payment information, a receipt will be made for your records.

The ClickPay website does not require you to create an account to make a payment. However, you'll need to enter your statement number, Member ID and the last 4 digits of your Social Security Number to make a payment. (The statement number is located on the front of the statement, in the upperright-hand corner.)

Provider Tools and Resources:

Providers are Encouraged to Verify Eligibility

The Eligibility and Verification Information System (ELVS) line is very busy during the first of the month. The <u>ELVS web portal</u> is another option for providers in lieu of calling the ELVS line but each provider must enroll through the Electronic Data Interchange Support Services (EDISS). The ELVS web portal allows for multiple eligibility checks and batch submission, where as the ELVS phone system only allows for one at a time.
