Level of Care Process-Clarification

The IA Health Link managed care program began on April 1, 2016, with a focus on the provision of services and quality of care in Long Term Care programs. The lowa Medicaid Enterprise (IME) has issued a clarification of the process for submission of Level of Care (LOC) Certification for members in a nursing facility.

As required by federal regulation, facilities must conduct a comprehensive, accurate, standardized, reproducible assessment of each resident's functional ability to determine the appropriate LOC. The results of the assessment are used to develop, review, and revise the resident's comprehensive plan of care, potentially resulting in discharge.

Waiver Provider Requirements: Reminder for Iowa Medicaid Individual Consumer Directed Attendant Care (CDAC) Providers

The IA Health Link program launched on April 1, 2016, and while Managed Care Organizations (MCOs) are administering the program, the policies of the Iowa Medicaid Enterprise (IME) remain consistent with all three MCOs.

All services provided must be approved by the member's Care Manager or Case Manager through a written CDAC Agreement which has been signed by the

IA Health Link Newborn Coverage

In situations where a Managed Care Organization (MCO) enrolled Medicaid member gives birth, the newborn is automatically enrolled with the mother's MCO. The member must notify the MCO of the birth and follow the MCO's policies. Please refer to the MCO training materials and provider manuals on the DHS website under Managed Care Organization (MCO) Specific Materials.

Automatic assignment to the mother's MCO is done only after the Medicaid enrolled mother has completed the necessary enrollment application with the Iowa Department of Human Services (DHS) Income Maintenance Worker. All DHS enrollment processes should continue to be followed.

Once the newborn is determined eligible and the MCO assignment has occurred, the member will also have 90 days to change enrollment if the mother or guardian chooses to change to a different MCO. Choosing a different MCO during this period may be done without cause.

Managed Care Cards and Medicaid ID Numbers

All three Managed Care Organizations (MCOs) include the member's Medicaid ID number on the member's MCO ID card. The Amerigroup of Iowa, Inc. member ID card refers to the number as "Medicaid number." The AmeriHealth Caritas of Iowa, Inc. member ID card refers to the number as "State ID." UnitedHealthcare Plan of the River Valley, Inc. uses the Medicaid ID as the MCO ID number and is referred to on the card as "Member ID."

Verify Eligibility

The Eligibility and Verification Information System (ELVS) line is very busy during the first of the month. The ELVS web portal is another option for providers in lieu of calling the ELVS line but each provider must enroll through the Electronic Data Interchange Support Services (EDISS). The ELVS web portal allows for multiple eligibility checks, where as the ELVS phone system only allows for one at a time.

Login ID and password may be obtained through EDISS by submitting the following <u>Access Request Form</u> to EDISS or calling EDISS at 1-800-967-7902.
