AmeriHealth Caritas is withdrawing from the IA Health Link managed care program effective November 30, 2017. AmeriHealth Caritas members' coverage with their new MCO will begin on December 1, 2017.

Transition Updates:

Provider Enrollment with Managed Care Organizations (MCOs)

During the transition from Amerihealth Caritas, providers currently enrolled with the Iowa Medicaid Enterprise (IME) will be considered to have "deemed enrollment" with both UnitedHealthcare and Amerigroup for the month of December 2017.

"Deemed enrollment" means that Medicaid enrolled providers are provisionally considered credentialed with each MCO to allow for continued access to care.

To continue providing high-quality care to this larger population of lowans, UnitedHealthcare is expanding its team here in central lowa by hiring 70 new case managers.

To fill these positions, the company will hold a job and informational fair on Wednesday, November 15, from 8 a.m. to 3:30 p.m. at the Tuscany Event Center, located at 3901 NW 121st Street in Urbandale, IA.

At the same event, consumer-directed attendant care (CDAC) providers will be able to register with UnitedHealthcare. Those unable to attend can start their registration process by sending an email to lowaCommunityNetwork@UHC.com.

Tiered Rates

Per House File 653, the Department of Human Services (DHS) was directed to implement tiered rates for providers of daily supported community living (SCL), full day-habilitation and full day-adult day care for persons with an intellectual disability under the home- and community-based services (HCBS) waiver program.

Tiered rates aligns reimbursement based on the severity of the individuals' disabilities and will standardize reimbursement for all providers. Approximately 5,000 members will have their services reimbursed using tiered rates.

Tiered rate reimbursement for daily SCL will be phased in over 19 months beginning December 1, 2017. This phased in approach allows providers time to adjust their business practices. For more information view the <u>Tiered Rates</u>

Non Emergency Medical Transportation (NEMT)

AmeriHealth Caritas members should continue scheduling rides with their AmeriHealth Caritas' NEMT broker until December 1, 2017, regardless of the appointment date. AmeriHealth Caritas will transition member information, including NEMT appointment information, to the member's new Managed Care Organization (MCO).

Beginning December 1, 2017, members should contact their new MCOs' NEMT broker to schedule rides.

Verify Eligibility

The Eligibility and Verification Information System (ELVS) line is very busy during the first of the month. The ELVS web portal is another option for providers in lieu of calling the ELVS line but each provider must enroll through the Electronic Data Interchange Support Services (EDISS). The ELVS web portal allows for multiple eligibility checks and batch submission, where as the ELVS phone system only allows for one at a time.
