## **Virtual Medicaid Town Hall Meetings on Thursday**

# Open Choice Period Ends September 30, 2021

Open Choice ends September 30, 2021, for a majority of IA Health Link and Hawki members, as well as children who recently transitioned to the Dental Wellness Plan (DWP) Kids program.

Eligible IA Health Link and Hawki members may change their Managed Care Organization (MCO) for any reason during this time.

Additionally, children who transitioned to the DWP Kids program in July 2021 may switch dental carriers for any reason during this time.

Members wishing to change MCOs, or dental carriers, must submit their request to lowa Medicaid Member Services.
