#### Teaching in Taiwan

The lowa Department of Education has an agreement with the Republic of China (Taiwan) that offers lowa teachers endorsed in kindergarten through sixth grade the opportunity to teach English language instruction for one year in a Taiwanese school.

Through the agreement, up to 10 experienced and/or newly licensed lowa teachers will be given this opportunity for the 2007-2008 school year. The Taiwanese government will provide lowa teachers with orientation training, housing arrangements, and salaries comparable to current lowa teaching salaries. Each participating lowa teacher will be paired with a Taiwanese classroom teacher. In addition to providing English language instruction, the lowa teachers will work with Taiwanese educators to develop curriculum, prepare lesson plans and teaching materials, conduct classes, and evaluate student progress.

#### **LEGISLATIVE UPDATE**

#### Clarification on 4-year-old Preschool Bill

The lowa Department of Education (DE) has been made aware there is a perception in the field by some stakeholders that school districts will "automatically" begin receiving funding for 4-year-old preschool programming via the bill currently moving through the legislature. This is not the case. While the draft legislation will have school districts as the fiscal agents, every preschool program proposal must be approved against the new criteria established by the bill. This means that current fee-based district preschools, as well as any other potential contracting provider collaborating with the school district, must demonstrate that all criteria for this program are met. One of the criteria will be demonstrating the involvement and support of local stakeholders already invested in 4-year-old preschool in some capacity. It is entirely possible that a failure to demonstrate effective collaboration with all stakeholders locally could be a reason why a given proposal is not accepted. The implementation of this proposed legislation will not mean that districts cannot continue to offer fee-based preschool programming. It also does not mean that every private provider will automatically be included in a district's preschool proposal. Any entity interested in participating must "opt in" and this would include providers interested in contracting with the district for the delivery of this preschool programming.

The initial year of funding will be awarded via a competitve grant process. The intent is for the first round of program grants to be operational for the 2007-2008 school year. Additionally, the bill includes a four-year ramp up on access to the program and funding, meaning that it will be some time before universal, statewide access to this programming is available. Participation in this program is voluntary and not enough funding is allocated in the first year of the program for all districts to receive funding in 2007-2008.

The DE is beginning discussions about the grant application process and administrative rules to support the legislation. Once the legislation is passed and signed, the DE will provide grant application materials along with technical assistance. We ask for your patience as we develop these materials. #### **Open Enrollment Update**

The following are reminders of issues related to open enrollment:

- School districts are NOT required to send a copy of open enrollment forms to the lowa Department of Education. All applications (approved or denied) should be kept on file in the local district (resident or receiving).
- When a student rescinds an open enrollment and returns to the student's home district, there *is* a 90-day period of athletic ineligibility.
- "Continuous" enrollment is not available to a parent/guardian of a child entering kindergarten for the first time even if the child has been open enrolled to a preschool program.

#### Iowa Evaluator Approval Renewal Training Level II - Evaluation of Teachers

The lowa Evaluator Approval Renewal Training Program (Level II): Evaluation of Teachers is a two-hour credit course provided to principals and other educational leaders responsible for the evaluation of teachers. The focus of this professional development class is to enhance skills of teacher evaluators. Specific areas of study:

- Application of effective leadership practices in evaluation;
- Development of knowledge and understanding of best practice in writing an individual career development plan;
- Development of knowledge and understanding of best practice in writing an intensive assistance plan;
- Development of skills in the use of effective strategies for formative conferencing; and
- Development of skills in the use of coaching strategies.

This course is 30 contact hours with the trainer. Each area education agency (AEA) will determine registration procedures and schedules for this training. It is highly recommended that educational leaders whose *primary* responsibility is the evaluation of teachers participate in this course. All professionals needing renewal of their evaluator approval licensure should take this course. Evaluator Approval Course (Level I) is a prerequisite to this course. Graduate credit is available.

#### Iowa Evaluator Approval Renewal Training Level II - Evaluation of Administrators

The Iowa Evaluator Approval Training Program II: Evaluation of Administrators is a two-hour renewal course provided to superintendents and other educational leaders responsible for the evaluation of administrators. The focus of this professional development, based on the Iowa Professional Development Model, addresses the following:

- Knowledge, skills, and application of the Iowa Standards for School Leaders;
- Research and recognition of effective principal behaviors that increase student achievement, including
  use of data; alignment of curriculum, instruction, and assessment; and first- and second-order change;
- Research and application of effective superintendent behaviors that increase student achievement;
- · Coaching skills to enhance principals' skills as instructional leaders; and
- Models of principal evaluation processes, including design and use of individual career development plan for principals.

Participants enrolling in Fall 2007 will take the first two modules on Sept.19, 2007, when Dr. Douglas Reeves addresses the participants, followed in the afternoon by an emphasis on the Iowa Standards for School Leaders. All remaining modules take place in each area education agency (AEA) on the dates of the superintendents' meetings. It is recommended that superintendents and other educational leaders whose *primary* responsibility is the evaluation of administrators take this course.

Note: The law currently requires that an administrator complete either lowa Evaluator Approval Training Program II: Evaluation of Administrators OR lowa Evaluator Approval Training Program II: Evaluation of Teachers for renewal. Individuals, however, may choose to take both to complete their required four hours for renewal. Best practice would indicate that an individual would take the course most pertinent in his/her current job description.

#### **Iowa Summer Professional Seminar Grant Support**

The Iowa Department of Education, along with the Iowa Board of Educational Examiners and the Iowa Association of Colleges of Teacher Education, announces a request for proposal for participation in the Iowa Summer Professional Seminar.

#### Responsibility of Districts vis-à-vis Non-accredited Private 'Schools'

There is a scattering of private elementary and even fewer secondary "schools" that are not accredited by the lowa Department of Education (DE). *The students who attend such settings are considered home schooled.* Therefore, all requirements of Competent Private Instruction (CPI) apply. These include the following:

- 1. The parent or guardian of each such student must fill out and file Form A (Report of CPI) with the district of residence.
- 2. The instructors at such settings must be licensed with the Board of Educational Examiners (BoEE) and such licensure must be appropriate to the grade level of the children taught by the instructor. *The exception is for an instructor who teaches only his/her own children.*

The district of residence is responsible for accounting for a Report of CPI from all resident students of compulsory attendance age enrolled in a nonaccredited setting. If a student of compulsory attendance age attends a nonaccredited "school" but has not filed the Report of CPI, the truancy officer for the district of residence should contact the family. If the family declines to file the required report, the district should next contact the county attorney. Failure to file the Report of CPI — as well as failure to fill out all required information on the form — is a truancy violation and has been successfully prosecuted as such.

If the Report of CPI does not indicate that the student's instructor is BoEE-licensed, this is also a violation of the compulsory attendance (truancy) law in Iowa Code chapter 299. The resident district should contact the student's parents and the nonaccredited "school" officials to make them aware of this.

#### **School Assemblies and Faith-based Organizations**

Public school administrators, please be aware that complaints have been made by students, parents, and legislators about school assemblies sponsored by faith-based organizations. While the in-school assemblies make no mention of religion or religious beliefs (focusing on "character" or related issues), districts expose themselves to both public criticism and possible successful lawsuits on claims of violations of the Establishment Clause of the First Amendment by promoting one religion over others. This is because an announcement is generally made during the assembly of a meeting to be held after school hours and not on school premises of an overtly religious nature. Thus, the religion to be promoted at the later meeting is advantaged by the district. Any such advantage is unconstitutional.

Check out thoroughly any group wanting to speak at an in-school assembly to your students (who are, after all, a captive audience). Ask for a list of prior appearances by the group, and then call some schools on the list to see if there were any issues. Make it clear to the sponsoring group that you will not provide them with an opportunity to advertise their religious meeting at your school to your students. If such an announcement is made despite your best preventative efforts, send a note home with students apologizing for the disobedience of the sponsor.

Finally, any student who complains about this is correct to be concerned, and certainly should face no retaliatory actions. The task of educators includes upholding the lawful civil rights of all students.

#### **Nonschool Sponsored High School Athletic Events**

Both the Iowa High School Athletic Association (IHSAA) and the Iowa Girls High School Athletic Union (IGHSAU) are adopting a policy that all high school regular season athletic events that are sponsored by nonschool organizations (service organizations such as Kiwanis Clubs, businesses, universities, e.g.) must be sanctioned prior to the event by either the IHSAA or IGHSAU. The policy is for the protection of students and high schools, and has become necessary because the nonschool sponsors are not aware of the rules that member high schools must comply with, including the limitation on the awards given. The violations of the award rules can adversely impact student eligibility.

Starting with the 2007-2008 school year, nonschool sponsored events MUST be sanctioned by the IHSAA or IGHSAU prior to participation by member schools. A list of sanctioned events will be posted on the IHSAA and IGHSAU websites. Participation by a member school in a non-sanctioned event in violation of this policy will result in forfeiture of contest(s) and potential sanction of school membership.

#### Interscholastic Competition Eligibility For Students with Disabilities

While the academic eligibility rule for students with disabilities who have individualized education programs [36.15(2)"d"] did not change in content, several questions have arisen this year regarding the rule's implementation. Following are the rule language and frequently asked questions:

36.15(2)"d". A student with a disability who has an individualized education program shall not be denied eligibility on the basis of scholarship if the student is making adequate progress, as determined by school officials, towards the goals and objectives on the student's individualized education program.

Q 1: Hasn't this rule been recently amended?

A 1: This rule's recent amendment was technical in nature and did not change its meaning.

**Q 2:** What happens if a competitor with a disability is not eligible under this rule?

**A 2:** The competitor may practice, but may not participate in competition or dress for competition. A local district may provide, however, that ineligible competitors are not permitted to practice.

**Q 3:** May a school set higher requirements for students with disabilities, such as by holding students with disabilities to the "pass all" rule applicable to students without disabilities?

**A 3:** No. So long as the student is making adequate progress toward goals, on the student's individualized education program (IEP), as determined by school officials, the student "<u>shall not be denied</u> eligibility" based on scholarship. What constitutes adequate progress will vary based on the facts of each competitor's case. (See, e.g., Question & Answer 7).

Q 4: Who determines "adequate progress" for an interscholastic competitor with an IEP?

A 4: "School officials" make that determination, not the competitor's IEP team or parents.

**Q 5:** What happens after school officials determine what progress a competitor with disabilities is required to achieve to be eligible for competition?

**A 5:** Those officials must immediately communicate what "adequate progress" constitutes to the competitor and the competitor's parents, teachers, and others who assign grades to or monitor the progress of the competitor.

Q 6: Are competitors with IEPs required to attain their goals to be eligible?

**A 6:** The rule requires adequate progress toward goals, not goal attainment. In some cases, a competitor may make adequate progress toward a goal without necessarily attaining it. In other cases, goal attainment might be the only outcome that would constitute "adequate progress." Whether goal attainment constitutes the required "adequate progress" depends on the facts of each case.

**Q 7:** What if a competitor with an IEP fails a class for which there are no expressed IEP goals and no specially designed instruction?

A 7: Examine the relationship between the IEP goals and the failed course. If there is a close relationship between the IEP goal(s) and the failed course, and the competitor made adequate progress on the IEP's goal(s), then the competitor is eligible. If there is a close relationship and the competitor did not make adequate progress toward an IEP goal, then the competitor is not eligible. If there is little or no relationship between an IEP goal and the course failed, the competitor is not eligible.

**Q 8:** What if a competitor with an IEP passes all classes yet does not make "adequate progress" on IEP goals?

A 8: In this extremely unlikely event, the competitor is eligible.

Q 9: What if an ineligible competitor's IEP provides for "participation" in interscholastic activities?

**A 9:** An ineligible competitor may <u>participate</u> (e.g., practicing, serving as team manager) without competing. An IEP team has no authority to provide that a student with an IEP, who otherwise would be academically ineligible for competition, must be allowed to compete in interscholastic competition.

Q 10: What if a competitor is being currently evaluated for special education?

**A 10:** Until the evaluation is complete, the competitor must meet requirements applicable to students without IEPs. Once the evaluation is complete and an IEP is developed, apply this rule to determine the competitor's eligibility.

Q 11: Does rule 36.15(2)"d" apply to students with only Section 504 accommodation plans?

A 11: No. The rule does not apply to students solely covered by Section 504.

#### **Update on Academic Eligibility Rule Survey**

At its April 19 meeting, the State Board of Education will hear the results of a survey that was sent to all public and accredited nonpublic high schools in lowa. The Board will not take action on that date. The results of the survey, which had a return rate of about 45 percent, will be included in the May School Leader Update.

#### **Obtaining Student Records from Defunct Colleges**

Teachers and administrators who obtained credits or degrees from private institutions of higher education (IHE) that are no longer in operation sometimes find themselves needing transcripts from those former institutions. #### **Reporting of Adequate Yearly Progress**

The lowa Department of Education will conduct an Iowa Communication Network (ICN) broadcast outlining the online Adequate Yearly Progress (AYP) reporting requirements for school districts that administered the Iowa Test of Basic Skills/Iowa Test of Educational Development during the *fall* testing window of the 2006-2007 school year. #### **Grade Range of Content Area Endorsements Updated**

On Nov. 8, 2006, the Board of Educational Examiners (BoEE) repealed the rule commonly called the "2 up 2 down" rule. Prior to this repeal, a person licensed to teach kindergarten through sixth grade in a content area could teach that content in kindergarten through eighth grade with local school board approval. A person who held a seventh through 12<sup>th</sup> grade content endorsement could teach that content in grades five and six with the local school board's approval. Because that information did not appear on the license, many teachers, administrators, and parents thought the teacher was not authorized to teach in those other grades. Thus for clarity, the BoEE changed all of the endorsement grade levels to reflect that authority. The endorsements will now indicate the grade levels that person can teach such as kindergarten through eighth grade math or fifth through 12<sup>th</sup> grade math.

New or renewed licenses printed after Jan. 1, 2007, will accurately reflect what can be taught, so do not assume a person with a kindergarten through eighth grade license can now teach two grade levels higher. All lowa teaching licenses can be viewed with the correct grade levels at the BoEE website (http://www.boee.iowa.gov/).

#### Price Lab School Finalist in "Schools of Character" Program

Price Lab School in Cedar Falls is a finalist in the national Character Education Partnership's (CEP) "Schools of Character" annual recognition program. There are 28 national finalists with 10 possible winners. Every year, CEP names 10 public and private schools and districts (K-12) as National Schools of Character for their outstanding work in improving the behavior and learning of students through character education. In late May, the Blue Ribbon Panel will meet to select the 10 winners and the 2007 winners will be announced. The

Character Education Partnership, based in Washington, D.C., is a nonprofit, nonpartisan, nonsectarian, coalition

of organizations and individuals committed to fostering effective character education in K-12 schools.

#### Student Employees and the Minimum Wage

The Iowa Division of Labor is providing information about the minimum wage increase to the public, including school administrators and counselors, who may have questions about how this change affects working students.

On April 1, Iowa's minimum wage increased to \$6.20 per hour. It will increase again January 1, 2008, to \$7.25 per hour. Many working students will be affected by these changes.

#### Q. Does minimum wage apply to student employees?

A. Yes. The age of the employee is not a concern.

#### Q. Can student employees be paid less than minimum wage?

A. Yes. For the first 90 calendar days of employment any new employee may be paid an "initial employment rate" of \$5.30 per hour before being raised to full minimum wage. It is also possible to apply for a student certificate with the U.S. Department of Labor. This will allow the employer to pay \$5.30 per hour through the length of the permit or until the minimum wage is increased.

#### Q. How does the minimum wage impact student waiters and waitresses?

A. Employers of "tipped employees" (employees that customarily and regularly receive \$30.00 or more each month in tips) are allowed a tip credit of 40 percent. This means the employer must pay the employee at least 60 percent of the minimum wage. Commencing April 1, the employee must be paid at least \$3.72 per hour. On January 1, 2008, the employer must begin paying \$4.35 per hour for each hour worked.

#### Q. What can be done if the employer does not pay the correct wage?

A. If the employee feels wages are owed, a claim for wages form may be filed with the Iowa Division of Labor. These forms can be obtained by calling 1-800-562-4692 or can be downloaded from our website at <a href="https://www.iowaworkforce.org/labor/wage.htm">www.iowaworkforce.org/labor/wage.htm</a>. The employee also has the right to private action.



#### **Advanced Placement Reimbursement for Exams**

### Who is eligible?

Students eligible for free and reduced price lunches, according to the Title I formula, are eligible to receive this reimbursement for exams.

This eligibility applies regardless of whether or not the student is currently receiving such as long as there is evidence they qualify.

#### How will this be verified?

The local school district has free and reduced price lunch information on file. The Iowa Department of Education does not collect the names of those students. However, we can ask the district to show evidence that these students are eligible.

#### How much cost will the reimbursement cover?

The intent is to remove the cost barrier for low-income students to participate in the AP exam opportunity. The \$21,200 will be divided among those schools requesting reimbursement as of May 25, 2007. The reimbursement will total **\$53 per exam**. This is determined by:

\$83.00 - total fee per AP exam

- 22.00 fee reduction provided by The College Board school's responsibility to indicate on order form when ordering tests
- 8.00 administration fee waived by school district
- 53.00 Federal grant fee reimbursement

\$ 00.00 - fee for eligible student

Each exam counts separately, i.e., if an eligible student takes three exams, you may request reimbursement for all three exams.

## When and how do I submit the request?

After the qualifying students take the AP exams, please use one of the following options to request the reimbursement.
