Rare *E. coli* strain uncovered in Eastern Iowa children

Three cases of enterohemorrhagic *E. coli* (EHEC) strain O26 have been identified in an Eastern Iowa county. Symptoms include diarrhea (may or not be bloody) lasting 3 to 10 days, fever, vomiting, nausea and abdominal cramps. No hospitalizations have been reported. Several possible sources of infection, such as splash pads, wading pools, and contact with farm kittens, have been identified; however, at the moment no epidemiological link has been established.

The Iowa Department of Public Health (IDPH) requests that clinicians screen patients suspected of having EHEC or other significant diarrhea illnesses, regardless of exposure history. Providers and hospital laboratories are encouraged to submit clinical specimens to the University Hygienic Laboratory (UHL) for culturing and identification of this organism.

UHL routinely screens stools submitted for Shiga toxin producing *E. coli* (STEC) and conducts extended cultures on those specimens that are STEC/EHEC positive and *E. coli* O157 culture negative. ***Salmonella montevideo* infections due baby chick exposure**

The Centers for Disease Control and Prevention (CDC) is currently coordinating an investigation of *Salmonella montevideo* infections potentially related to exposure to baby chicks. As of June 18, CDC has reported at least 41 cases in 17 states. There are no cases in Iowa. The association of salmonellosis with exposure to baby chicks has been recognized.

Vaccine storage & handling

Appropriate storage and handling of vaccine supply is very important. IDPH recommends the following for standard storage and handling of vaccines in Iowa:

- Dormitory style refrigerator units are **not recommended** for vaccine storage.
- Recommended refrigerator storage temperatures are:
 1. Refrigerator 35 through 46 degrees F, or 2 through 8 degrees C; or an average of 40 degrees F, or 5 degrees C
 2. Freezer less than 5 degrees F, or less than minus 15 degrees C
- It is important to check and record temperatures twice a day.
- Take immediate action when the temperature is outside the recommended range and document the action steps taken.

June 27 is National HIV Testing Day

June 27 is National HIV Testing Day (NHTD). The Centers for Disease Control and Prevention (CDC) estimates that 180,000 to 280,000 people nationwide are HIV-positive but are unaware of their status. HIV counseling and testing enables people with HIV to take steps to protect their own health and that of their partners. The testing programs also help people who test negative get information they need to stay uninfected.

Across the country, thousands of HIV counseling and testing sites, state and local health departments, and community-based HIV/AIDS service providers will participate in NHTD events on June 27. Treatment regimens for “*Neisseria gonorrhoeae*” in Iowa can include Ciprofloxacin

On April 13, the Centers for Disease Control and Prevention (CDC) released new guidelines for treatment of gonococcal infections. Included within the guidelines factors influencing fluoroquinolone resistance of *Neisseria gonorrhoeae* (QRNG) increasing and becoming widespread in the United States. Due to the increased QRNG prevalence rate in recent years (over the 5 percent baseline), CDC decided to change treatment recommendations in defined groups and locations.

IDPH reports that QRNG is below 5 percent prevalence in Iowa. Therefore, a treatment regimen of Ciprofloxacin 500 mg remains the recommended first line treatment of *Neisseria gonorrhoeae* in Iowa. Ceftriaxone 125 mg or Cefixime 400 mg is recommended for treatment in cases where QRNG is suspected or cannot be ruled out.

A surveillance program that continually monitors the prevalence of QRNG in Iowa has long been instituted and continues to monitor the prevalence rate of QRNG. Any treatment failures in regard to Ciprofloxacin should be reported to the IDPH STD Program at 515-281-4936.
