## ICSW Priorities Met

All of the six ICSW legislative priorities were fully or partially met by the General Assembly:

### Child Care

- **State investments in Head Start, Early Head Start and other early childhood programs that emphasize school-readiness.**

HF877 was signed by the Governor on May 10<sup>th</sup> creating a statewide voluntary preschool program for four-year-old children and appropriations of \$15 million for FY2009 and FY2010 and \$16,162,500 for FY2011.

### Economics

- **An increase in the minimum wage.**  
HF1 was signed on January 25<sup>th</sup> and the first raise began on April 1<sup>st</sup> at \$6.20 per hour. The raise to \$7.25 per hour begins January 1, 2008.
- **Legislative proposals addressing predatory lending, including predatory home mortgage lending, payday loans, tax refund anticipation loans and car title loans.**  
HF5 was signed on March 27<sup>th</sup> restricting the car title loans to 21% finance charge. SF137 was signed on April 17<sup>th</sup> that requires registration of real estate appraisers.  
But SF541, which would take predatory lending to even greater restrictions, got stalled in the House after passing the Senate.

## Iowa Women's Hall of Fame

You are cordially invited to attend, free of charge, the Iowa Women's Hall of Fame Ceremony *at 10:30 a.m. on Saturday, August 25, 2007*, to celebrate the induction of four outstanding women. The ceremony will take place at the Iowa State Historical Building, 600 East Locust, Des Moines.

Induction into the Iowa Women's Hall of Fame is one of the highest honors bestowed upon an Iowa woman by the State of Iowa. Ruth Ann Gaines, Des Moines; Dr. Ada Hayden (deceased), Ames; Emma J. Harvat (deceased), Iowa City; and Connie Horton Wimer will be honored for their significant contributions to society.

Ruth Ann Gaines is an educator and artist. Dr. Ada Hayden was the first woman to receive a Ph.D. from Iowa State University and prairie preservationist. Emma J. Harvat was the first woman in the nation to be elected mayor of a city larger than 10,000. Connie Horton Wimer is a business woman and philanthropist. (More complete biographical sketches and photographs will appear in the September/October issue of the *IoWoman*.)

*The Cristine Wilson Medal for Equality and Justice* will also be presented during the Hall of Fame ceremony. This award is given to a distinguished Iowan who has dedicated her/his life to promoting equality and justice. Marilyn O. Murphy of Sioux City will receive this honor. Murphy has been a longtime advocate of women and social justice issues.

Following the induction ceremony, a reception will be held for attendees and family and friends of the award recipients from 11:30 a.m.-12 p.m.

At 12:30 p.m., the *Friends of the ICSW Fundraising Luncheon* will take place at Hotel Fort Des Moines, 1000 Walnut Street, Des Moines. The featured presenter will be Jane Cox portraying Carrie Chapman Catt.

The event is held in conjunction with Women's Equality Day, August 26, which commemorates the day in 1920 when American women first obtained the right to vote.

## Girls' Summit

The Iowa Gender Specific Services Task Force will host a Girls' Summit on October 12<sup>th</sup> in Urbandale, Iowa.

Invited participants will examine the circumstances surrounding and contributing to young women's involvement in the juvenile justice system as well as how these circumstances lead them to the adult corrections system.

Participants will look at state-wide data and institutional data as well as hear from a national expert and young women in the juvenile justice and adult systems themselves.

The group will take this information and their own expertise and work on recommendations for improved responses to these young women once they are involved in the system as well as earlier interventions that may prevent this involvement.

The Girls' Summit will result in a report detailing the status of young women in the juvenile justice system in Iowa. The report will be made public in 2008.

## Equality

- **Amending the Iowa Civil Rights Act to prohibit discrimination on the basis of sexual orientation and gender identity.**

SF427 was signed on May 25<sup>th</sup>. Iowa became the 19<sup>th</sup> state in the nation to expand civil rights protections to include the LGBT community. The bill signing was held at Principal Financial in Des Moines, which has been granting its employees protection and was a leading advocate for this bill during the 2007 legislative session.

## Health

- **Focusing on health care reform until health care coverage is accessible and affordable for all Iowans.**

The Affordable Health Care Commission was established as part of HF909 with an appropriation of \$500,000 to cover costs. The Commission will review, analyze, and make recommendations on issues by December 2007.

## Violence Against Women

- **Increased funding for domestic violence and sexual assault programs in the state budget.** Victim Assistance Grants were increased from \$5,000 to \$150,000, but still fall short of the need.
