December 20 through December 31st the National Highway Traffic Safety Administration (NHTSA) will be placing \$7,000,000 nationally in paid media "Drunk Driving. Over the Limit. Under Arrest." to help with enforcement activities through the 2006 holiday season. There will be at least two planned media events held in conjunction with these efforts. Law enforcement agencies will be provided an announcement package including a sample media release and a report form. The Governor's Traffic Safety Bureau will be asking you to forward data on the types of violations your officers encountered during this time frame.

Sandy was responsible for a major revision of the Bureau's Annual Evaluation Report, a major governing document between the Governor's Traffic Safety Bureau and the National Highway Traffic Safety Administration which provides over \$6 million in highway safety funds to Iowa each year. Thanks to her efforts, the report was shortened from 85 to 28 pages with enhanced graphics and improved readability. These changes resulted in considerable savings in report preparation time for GTSB staff as well as paperwork reduction.

IOWA IS NATIONALLY RECOGNIZED



OLDER DRIVERS

On October 24th and 25th a three member team from the Government Accounting Office (GAO) visited Iowa as part of a Best Practices study concerning older drivers. Other states included in the study are California, Oregon, Maryland, Florida and Michigan. The panel was most interested in Iowa's approach to training of highway safety personnel including traffic engineers, planners and technicians regarding older driver accommodations. The focus of this type of training in Iowa is on signage and pavement markings. Tom McDonald, Iowa's Safety Circuit Rider (GTSB funded) is one of those involved in this training.

A second area of interest was Iowa's licensing approach for older drivers. Iowa's system accommodates older drivers with a variety of restrictions such as speed, night-time driving, routes, time of day and distance from home. These restrictions allow more Iowans to drive longer and safer by maintaining limited driving privileges which serve the basic transportation needs of the individual.

DRUG IMPAIRED DRIVING

NHTSA, working through the Pacific Institute for Research and Evaluation (PIRE), is in Iowa interviewing law enforcement officers in Des Moines and Cedar Rapids to obtain opinions and observations about the effectiveness of Iowa's drug per se law.

SPECIAL TRAFFIC ENFORCEMENT PROGRAM (sTEP)

Iowa's Special Traffic Enforcement Program (sTEP), within the Governor's Traffic Safety Bureau, is being studied on a national level as a model for nationwide traffic programs in the Iowa's sTEP program was originally future. established with a goal to focus on saving lives and reducing serious injury accidents by increasing safety belt use. Waves of concentrated enforcement activity are centered around dates showing high volume traffic fatality and accident levels. Iowa, along with Maryland and Virginia is being evaluated to demonstrate the benefits of year round enforcement and public information and education efforts, to increase safety belt use.

Iowa's law enforcement community will be joining forces across the state urging motorists to buckle up and obey all traffic laws in an effort to make our streets and highways safer during this Thanksgiving Holiday. During November 20-26, 2006 officers all across the state are gearing up for this enforcement effort in order to save lives and reduce serious injury accidents as part of Iowa's Special Traffic Enforcement Program (sTEP) AND THE Iowa State Patrol Combined Accident Reduction (CARE) Program.

Last year, six fatalities were reported in Iowa during the Thanksgiving Holiday weekend, which is four more than the previous year in 2004. From 1995 through 2005, there have been 58 people who have died on Iowa's roadways as a result of Thanksgiving holiday mishaps, with at least 20 of those in crashes involving drinking and impaired drivers.

"We continue to stress the importance of seat belt usage in all motor vehicles, especially in pickup trucks, to help reduce fatalities and serious injury accidents," says J. Michael Laski, the Director of the Governor's Traffic Safety Bureau. In 2005, 184 of Iowa's traffic fatalities were unbelted with approximately one third of those involving pickup truck drivers and their passengers. Even though Iowa has reached a 90% seat belt usage rate, there is still one in ten drivers or front seat passengers that don't buckle up on a daily basis. Seat belts save lives! Take the time to buckle up. Every Trip! Every Time!


