No laboratory-confirmed cases of influenza have been reported to IDPH yet this season.


National activity summary:

Laboratory Data:


Laboratory-confirmed cases are primarily reported by the University Hygienic Laboratory (UHL). UHL also determines the type and strain (AH1, AH3). Influenza is not a required reportable disease. Laboratory data is used to confirm the presence of influenza and the types and strains circulating, not determine the exact number of cases in Iowa.



No rapid positives were confirmed yet.

Sentinel Provider Surveillance:

There are 18 sentinel surveillance sites throughout lowa surveying patient populations for influenza-like illness (ILI).

¹ **No Activity:** No laboratory-confirmed cases of influenza and no reported increase in the number of cases of influenza-like illness (ILI). **Sporadic:** Small numbers of laboratory-confirmed influenza cases or a single influenza outbreak has been reported, but there is no increase in cases of ILI.

Local: Outbreaks of influenza or increases in ILI cases and recent laboratory-confirmed influenza in a single region of the state.

Regional: Outbreaks of influenza or increases in ILI and recent laboratory-confirmed influenza in at least two but less than half the regions of the state.


Widespread: Outbreaks of influenza or increases in ILI cases and recent laboratory-confirmed influenza in at least half the regions of the state.

² Influenza-like illness is defined as fever ≥100°F and cough and/or sore throat.

^{*} Laboratory-confirmed cases do not include rapid influenza positives. Count does not reflect ACTUAL number of flu cases in IA.

Hospital and Long-term Care Facility Surveillance:

There are 29 hospitals participating in influenza surveillance. Hospitals track the total number of patients hospitalized weekly with influenza and/or pneumonia who also have a positive influenza laboratory result. The total number of patients surveyed this week was 4,530.



No cases of influenza were reported in long term care facilities for this reporting week.

<u>School Surveillance:</u>
There are approximately 50 school sites reporting into the IISN. All sites track the average number of students enrolled and the number absent due to illness weekly.
