## Iowans Have Received More Than \$838 Million in Disaster Assistance

Iowa residents and governments have received more than \$838 million in Individual Assistance, Public Assistance, and Small Business Administration disaster loans.

As of November 18, \$838.2 million in disaster assistance has been approved for homeowners, renters, businesses, and government and non-profit entities in the following categories:

### Housing Assistance, \$118.1 million

For rental assistance grants to homeowners and renters who cannot or should not live in their disaster-damaged homes and grants to homeowners to make an owner-occupied structure livable.

## Homeland Security Announces \$3 Billion in FEMA Preparedness Grants for Fiscal Year 2009

In Fiscal Year 2009, the Department of Homeland Security (DHS) will award more than \$3 billion in grants to states, urban areas and transportation authorities under 14 programs to bolster national preparedness capabilities and protect critical infrastructure. FY2009 grant programs provide \$24 million more than last year to enhance the nation's ability to prevent, protect

against, respond to and recover from terrorist attacks, major disasters and other emergencies. This includes the department's two largest grant programs: the Homeland Security Grant Program (HSGP) which totals more than \$1.7 billion, and multiple infrastructure protection programs, totaling more than \$845 million.

## Training Opportunities

### Weapons of Mass Destruction: Terrorism Incident Defensive Operations for Emergency Responders (PER-212)

In this course you will learn about the unique personal protection challenges that emergency responders face during a weapon of mass destruction (WMD)/terrorist incident or a hazardous materials incident. Major course topics include assessing WMD hazards, predicting the likely behavior of WMD materials, effectively operating and communicating in a unified command structure of the Incident Command System, determining detection equipment and personal protective equipment needs, performing emergency decontamination, and identifying defensive strategies for a WMD incident. This course provides the knowledge and skills needed to obtain certification through the National Professional Qualifications System (NPQS/ProBoard) as a Hazardous Materials Operations-level responder.

### Intermediate Incident Command System (ICS) for Expanding Incidents for Operational First Responders (ICS-300)

This course is intended to serve as a vehicle to share proven Incident management strategies and practices as well as to enhance teamwork and coordination among the agency's "mid-level managers and command staff" directly responsible for emergency response to incidents of all types; "all hazards" in which the Incident Command System (ICS) will be employed. The course utilizes scenarios and application exercises to highlight key issues and facilitate discussion. The concluding tabletop exercise is intended to allow participants to apply the information provided during the course in a controlled environment.

- Incident Command System Overview
- Unified Command
- Incident Response Management
- Incident/Event Agency Guidance
- Incident Action Planning with practical application

#### **Other Needs Assistance, \$15.8 million**

For grants to those affected with eligible, disaster-related funeral, dental and medical expenses.

#### **Small Business Administration, \$249.3 million**

For loans to renters, homeowners and businesses of all sizes.

#### **Public Assistance, \$455**

For reimbursement for government related, eligible expenses in the area of emergency response measures, debris removal and repair or restoration of disaster damaged public infrastructure. Certain non-profit organizations providing essential services also may be eligible for reimbursement under this program. Ω

“Several years of investment have taken us largely from capability building to performance-based planning and investment,” said Homeland Security Secretary Michael Chertoff. “This year’s funding priorities are consistent with last year, and reflect a mature and disciplined grants program. We are now in the position of being able to inform high threat urban areas of their target allocations ahead of time, which will go a long way in helping their applications.”

Available Iowa Grants for FY2009:

### Emergency Management Performance Grants (EMPG)

**Iowa share: \$4,087,148**

**Application Deadline: Dec. 19, 2008**

The purpose of the FY 2009 EMPG is to assist state and local governments in enhancing and sustaining all-hazards emergency management capabilities.

### Buffer Zone Protection Program (BZPP)

**Iowa share: \$600,000**

**Application Deadline: Jan. 13, 2009**

The BZPP provides funding to increase the preparedness capabilities of jurisdictions responsible for the safety and security of communities surrounding high-priority pre-designated Tier 1 and Tier 2 critical infrastructure and key resource (CIKR) assets, including chemical facilities, financial institutions, nuclear and electric power plants, dams, stadiums and other high-risk/high-consequence facilities, through allowable planning and equipment acquisition.

### Interoperable Emergency Communications Grant Program (IECGP)

**Iowa share: \$410,885**

**Application Deadline: Jan. 13, 2009**

IECGP provides governance, planning, training and exercise and equipment funding to states, territories, and local and tribal governments to carry out initiatives to improve interoperable emergency communications, including communications in collective response to natural disasters, acts of terrorism and other man-made disasters. According to the legislation that created IECGP, all proposed activities must be integral to interoperable emergency communications and must be aligned with the goals, objectives and initiatives identified in the grantee’s approved statewide Communication Interoperability Plans (SCIP). IECGP will also advance DHS near-term priorities that are deemed critical to improving interoperable emergency communications and are consistent with goals and objectives of the National Emergency Communications Plan. For FY 2009, two priority groups have been identified that are deemed critical for advancing interoperable emergency communications in alignment with the criteria established for the SCIP process: 1) Gaps in Leadership and Governance and Common Operational Planning and Protocols; and 2) Emergency Responder Skills and Capabilities Development Through Training and Exercises.

IECGP has a 75 percent federal and 25 percent state cost share, cash or in-kind, requirement for equipment purchases only.

### State Homeland Security Program (SHSP)

**Iowa share: \$1,515,000**

**Application Deadline: March 20, 2009**

This core assistance program provides funds to build capabilities at the state and local levels and to implement the goals and objectives included in state homeland security strategies and initiatives in the State Preparedness Report.

### Metropolitan Medical Response System Program (MMRS)

**Iowa share: \$321,221**

**Application Deadline: March 20, 2009**

The MMRS program supports the integration of emergency management, health, and medical systems into a coordinated response to mass casualty incidents caused by any hazard. Successful MMRS grantees reduce the consequences of a mass casualty incident during the initial period of a response by having augmented existing local operational response systems before the incident occurs.


### Citizen Corps Program (CCP)

**Iowa share: \$194,673**

**Application Deadline: March 20, 2009**

The Citizen Corps mission is to bring community and government leaders together to coordinate community involvement in emergency preparedness, planning, mitigation, response and recovery.
