## DIRECTOR'S MESSAGE

### Iowa Core Curriculum Podcast Now Available

I would like to invite you, our *School Leader Update* readers, to “tune in” to our most recent podcast.

Now available online at <http://www.iowa.gov/educate/content/category/27/639/1157/> is a 10-minute podcast on the Iowa Core Curriculum. The podcast provides basic information about the Iowa Core Curriculum, explaining what it is and what it isn't.

I invite you to listen to it and then share it with others, such as board members, other administrators in your district, teachers, and parents.

Points covered in the podcast include:

- Teachers and districts have been requesting more detail and assistance. The Iowa Core Curriculum was developed as part of a legislative mandate to provide additional detail and help to teachers and schools.
- The Iowa Core Curriculum helps teachers know *what to teach* by providing them with a progression of identified essential concepts and skills in the areas of literacy, mathematics, science, and social studies in grades K-12. Also included will be 21<sup>st</sup> century skills such as civic literacy, health literacy, technology literacy, financial literacy, and employability skills.
- The Iowa Core Curriculum is aligned with Iowa's core content standards in reading, math, and science.
- The curriculum also provides model units that teachers can review as a resource when determining how to incorporate the identified skills and concepts into their classrooms.
- The Iowa Core Curriculum is not based on or modeled after any specific textbooks. It does not mandate certain textbooks to be used. It does not mandate specific classes be taught.
- When developing the curriculum, working teams of Iowa educators and business leaders drew from a variety of resources. The following sets of expectations were used to develop and were incorporated into the 9-12 literacy, mathematics, and science model core curriculum: ACT's College Readiness Standards; College Board's Standards for College Success; Information provided by Iowa Testing Programs; International Center for Leadership in Education's Curriculum Survey of Essential Skills; NAEP Frameworks in Reading, Writing, Mathematics, and Science; Standards from the National Council of Teachers of English/International Reading Association, National Science Teacher's Association, and the National Council of Teachers of Mathematics; ACHIEVE; 21<sup>st</sup> Century Skills; Reports from the Alliance for Excellent Education; Third International Mathematics and Science Study (TIMSS).
- The Iowa Core Curriculum component and the accompanying professional development around the core curriculum are the critical pieces to actually setting higher expectations and infusing more rigorous content into classroom instruction.
- The initial timeline for implementation for high school implementation is by 2012; and K-8 implementation is by 2014.

### State Board of Education to Meet April 3 & 4

The State Board of Education will hold its next meeting April 3 and April 4 at the Marriott Hotel in West Des Moines.

### **Microsoft Settlement Voucher News**

It was recently determined that, based on free/reduced lunch rates, 75 percent of Iowa's public school buildings will be eligible to participate in the Microsoft class action settlement.

In February 2007, a class action lawsuit filed in Iowa against Microsoft was settled following a three-month trial. According to the settlement, Iowa schools would receive a portion of the funds not claimed by consumers.

The value of the funds will be distributed through vouchers for software and hardware products, as opposed to cash, to eligible attendance centers. All details, including a list of the eligible buildings, will be available early in May. More information will be forthcoming in the May *School Leader Update*.

### **Iowa Named 21<sup>st</sup> Century Leadership State**

The Partnership for 21<sup>st</sup> Century Skills, the nation's leading advocacy organization focused on infusing 21<sup>st</sup> century skills into education, has named Iowa to its State Leadership Initiative.

The announcement makes Iowa the seventh state in the nation to join the Partnership's initiative. The other states include Maine, Massachusetts, North Carolina, South Dakota, West Virginia, and Wisconsin.

### **Carl D. Perkins Career and Technical Education Five-Year State Plan**

Carl D. Perkins Career and Technical Education Act funds are critical to the continued provision of high school and postsecondary career and technical programs in Iowa. Based on a review of data and research, a stakeholder group has recommended a change in how Carl D. Perkins Career and Technical Education funding is allocated among K-12 and community colleges.

The formula used to distribute funds between the two sectors was implemented by the state per the Perkins IV legislation. The formula used to distribute the funds between the two sectors was determined and implemented for Perkins 3; the same formula is used in Perkins IV with the split calculated utilizing most recent data available. The formula for the funds received through Perkins IV was based on input from a taskforce composed of administrators of secondary school districts and community colleges.

Three factors are utilized to determine the distribution of funds received through Section 112 (1)(a) to the two sectors. The factors gave consideration to the enrollments (contact hours) in career and technical education programs in each of the sectors, the costs incurred by each sector to operate the programs, and the factors (population data) utilized by the U.S. Department of Education to distribute Career and Technical Education Assistance to the States.

These factors were selected because together they provided a means to give full consideration to the comprehensive nature of career and technical educational programs and the needed investment of additional resources in both sectors to enable the achievement of the state's vision for its Career and Technical Education system.

Based on these factors, 50.6 percent of the funds received in Section 112(1)(a) has been distributed to the secondary sector and 49.4 percent of the funds has been distributed to the postsecondary sector.

The State Board of Education is scheduled to take final action on the Carl D. Perkins Career and Technical Education Five-Year State Plan on Thursday, April 3.

### **Iowa Schools are Engaged in Authentic Intellectual Work (AIW)**

Currently, nine Iowa schools are engaged in Authentic Intellectual Work (AIW), an initiative focused on student engagement, higher order thinking, disciplined inquiry, deep understanding of rigorous content, and value beyond school.

It also builds collaborative communities of practice among teachers and provides highly motivating professional development.

AIW is research based (Newmann, King, & Carmichael) and complements the work being undertaken to implement the Iowa Core Curriculum.

The Iowa Department of Education is planning on expanding this program during the 2008-2009 academic year. To be identified, schools must complete the application process. ### **"Day of Silence" and "Day of Truth"**

Students and community members have been asked about these observance days. Both days of observance are geared toward students and are voluntary, which is why school administrators may find the following information useful.

Friday, April 25<sup>th</sup> has been designated by the Gay, Lesbian and Straight Network of the United States Student Association as this year's "Day of Silence." This is the 12<sup>th</sup> annual such day, which intends to "bring attention to anti-LGBT name-calling, bullying, and harassment in schools. This year's event is held in memory of Lawrence King, an 8<sup>th</sup> grade student in California who was shot and killed by a classmate because of his sexual orientation."

Monday April 28<sup>th</sup>, has been designated as this year's "Day of Truth" by the Alliance Defense Fund (ADF), a legal alliance "dedicated to defending the right to hear and speak the Truth. More specifically, ADF launched this project in 2005 to ensure the free speech rights of Christian students to prevent an opposing viewpoint to those organizations that promote homosexual behavior in schools."

Students and staff who desire to observe either day may do so if their observance does not create a substantial disruption of the educational environment. Observance usually is marked by wearing a t-shirt with a message supportive of either day and the handing out of cards explaining the purpose behind the day.

Students observing the Day of Silence also sometimes carry with them a card to explain to instructors that the student chooses not to speak voluntarily that day. This most likely does not disrupt the educational environment because students previously scheduled to give classroom oral presentations (either solo or as part of a group) on April 25<sup>th</sup> are still expected to do so.

Teachers' ability to participate may be regulated by their employers. "Speech" includes wearing apparel, ribbon, and pins, and districts may restrict teacher speech in the classroom and while on duty for the district

(such as lunchroom or study hall duty). [The Iowa Department of Education is neither encouraging nor discouraging such regulation within schools; we merely note that such regulation is allowed.]

In summary, do not approve student or teacher participation in just one of these upcoming days to the exclusion of the other. And before barring student participation in both days, check with your school attorney to see if s/he believes that such a move is legally defensible.

### **Guidance Booklet on Athletic Eligibility Rule Changes**

On April 3<sup>rd</sup>, the State Board of Education (barring some unforeseen circumstance) will change the “scholarship rule” regarding high school student participation in interscholastic sports in two ways: (1) no longer will there be a requirement that the student serve his/her period of ineligibility in a sport in which the student is a “bona fide” competitor, and (2) the period of ineligibility is changed from 20 school days to 30 calendar days.

The new language is: “if at the end of any grading period a contestant is given a failing grade in any course for which credit is awarded, the contestant is ineligible to dress for and compete in the next occurring interscholastic athletic contests and competitions in which the contestant is a contestant for 30 consecutive calendar days.”

The document was released at the Iowa High School Athletic Directors Association Spring meeting in Des Moines on March 31<sup>st</sup>. The new guidance will be posted on all the Iowa Department of Education, the Iowa High School Athletic Association, and the Iowa Girls High School Athletic Union websites.

### **Proclamation of Disaster Emergency**

Schools that are in disaster areas, as designated by either Governor Culver or President Bush — or both — are **not** relieved of the obligation to make up days lost to weather conditions. A proclamation of a state or federal disaster merely entitles persons or entities within the affected area to public financial assistance.

### **Copyright of Attendance Cards, Student Records Folders**

Some schools use attendance cards, permanent record folders, or cumulative record folders that were made available years ago by the Iowa Department of Education (DE). These documents have a copyright, so schools call us to get permission to use them when the supply at the school runs out. (A third party printer will not reproduce without our permission when the printer sees the notation of a copyright.)

All Iowa schools have the permission of the Iowa Department of Education to directly or indirectly make as many copies of any of these documents as are needed for educational purposes. Attached to this edition of *School Leaders Update* is written permission on DE letterhead. Any authorized Iowa school official may use the attached permission when trying to get those documents reproduced.

The Statewide Voluntary Preschool Program for Four-Year-Old Children Grant Application awards will be based on the 2008 legislative appropriation. Additional application requirements may be included if legislatively mandated.

The REVISED 2008-2009 Application **MUST BE USED** in applying for funding in Year 2 (2008-2009).



### **Districts Awarded Year 1 Funding (2007-2008)**

The 64 current districts who received grant funds for Year 1 (2007-2008) Statewide Voluntary Preschool Program for Four-Year-Old Children, DO NOT have to re-apply for a grant.

As one of the 64 districts receiving grant funds, the first year grant provided start-up funding for your preschool program plan described in your awarded application. The preschool (four-year-olds) certified enrollment count that you provided to the Iowa Department of Education on October 1, 2007 will sustain your preschool funding for each subsequent year. This is the same process used for districts and the School Foundation Aid Formula only at rate of .60 per pupil cost for the preschoolers. (Only those districts awarded Application Grant Awards submitted certified enrollment for four-year-olds.)

### **Application Packet ICN Technical Assistance**

The research is clear that the school health environment impacts academic learning. Nutrition education programs and the school meal programs help students make healthy food choices; other characteristics of the school environment also play a role.

Dr. Yibo Wood, Nutritionist with the Child Nutrition Division of USDA's Food and Nutrition Service will share examples of successful nutrition education programs in schools April 16<sup>th</sup> from 3-5 p.m. via Iowa Public Television K-12 Connections programming.
