and invite all automotive drivers to exercise caution to make the month devoid of accidents and during the week specified to secure free inspection of their motor vehicles, through the agencies provided by the various units of government, exhibit emblems on their cars testifying to such inspection, and otherwise to do everything possible then, and thereafter, to reduce accidents to the vanishing point.
