EXECUTIVE ORDER

BE IT REMEMBERED THAT:

WHEREAS, the State of Iowa has recently suffered a major flood disaster adversely affecting areas therein of considerable proportions, including areas adjacent to the Missouri River and its tributaries and the area included within the flood plain of the Mississippi River; and

WHEREAS, the President of the United States has determined that the major flood disaster area in the State of Iowa included the areas heretofore described, and has allocated Federal funds to assist in alleviating the hardship and suffering resulting from the flood disaster in the heretofore described areas; and

WHEREAS, on the 15th day of April, 1952, and the 26th day of April, 1952, I, as Governor of the State of Iowa, did enter into agreements with the United States of America, acting by and through the Housing and Home Finance Administrator, pursuant to PL 875, 81st Congress, approved September 30, 1950, PL 70, 82nd Congress, approved July 1, 1951, PL 80, 82nd Congress, approved July 18, 1951, and PL 202, 82nd Congress, approved October 24, 1951, pursuant to which agreement emergency Federal relief funds in the amount of \$637,000.00 were allocated to the State of Iowa, identified as DSP 42-5-1, for emergency disaster repairs to public works in both the Missouri River and Mississippi River Disaster Areas;

NOW, THEREFORE, I, William S. Beardsley, as Governor of the State of Iowa, for the purpose of effectuating the foregoing agreements entered into by me, do hereby order and direct the Treasurer of the State of Iowa to accept on behalf of the State of Iowa, Federal funds allocated to the State of Iowa for assistance in alleviating hardship and suffering in the Missouri River and Mississippi River Flood Disaster Areas, as hereinbefore provided, and to make such disposition of said funds as may be directed by the flood disaster committees, heretofore appointed by me for the purpose of administering said fund, and the Treasurer of the State of Iowa is hereby further ordered and directed to issue and deliver such receipts, certifications, and other instruments as may be required by the United States of America, or its designated agents, with respect to the funds allocated.

IN WITNESS WHEREOF, I have hereunto set my hand and caused the Great Seal of the State of Iowa to be duly affixed.

Approved Land Patent No. 320 issued to W. A. Sheaffer Pen Company of Lee County, conveying a tract of land in Lee County, Iowa, to-wit: "A part of Lots 161a, 167a, 170 and 169 in Section 3, Township 67 North, Range 4 West of the 5th P.M., City of Ft. Madison, Lee County, Iowa, and more particularly described as follows: Beginning at the NW Corner of Lot 161a, thence east 41.6 feet along the north line of said Lot 161a, thence S67°12'W 45.1 feet, thence north 17.5 feet along the west line of said Lot 161a to the point of beginning, containing 0.01 acres, more or less. Also commencing at the SW Corner of Lot 167a, thence north 55.3 feet along the west line of said Lot 167a to the point of beginning, thence north 33.3 feet along the west line of said Lots 167a and 170, thence east 50.0 ft., thence north 25.9 feet along the west line of Lot 169, thence east 50.0 feet, thence south 7.3 feet along the east line of said Lot 169, thence S34°43' W 23.9 feet, thence S69°30' W 92.2 feet to the point of beginning, containing 0.06 acres more or less. Note: The east line of 3rd street is assumed to bear due north."
