Approved Land Patent 346 which reads as follows:

TO ALL TO WHOM THESE PRESENTS SHALL COME, GREETING:

WHEREAS, by legislative enactment, House File 373, Chapter 260 Acts of the Fifty-fifth General Assembly of Iowa, the Governor and Secretary of State of the State of Iowa are authorized to issue a Patent to the City of Des Moines, Iowa for the following described lots situated in the City of Des Moines, County of Polk, State of Iowa,

"All of Lots Forty-three (43) to Fifty-four (54), both inclusive, of the Official Plat of Lot One (1), of the Official Plat of the East one-half (E2) of the Southeast Quarter (SE4) of Section Three (3), Township Seventy-eight (78), Range Twenty-four (24), and the South two hundred thirty-six (236) feet of the West one-half (W2) of Lot Thirty-one (31), Brooks and Company's Addition to the City of Des Moines.

NOW, KNOW YE, That the State of Iowa, in consideration of the premises and in conformity with the several Acts of the General Assembly, in such cases made and provided, has given and granted, and by these presents does give and grant unto the said City of Des Moines, Iowa, and to its successors and assigns the said lots above described to have and to hold the same, together with all rights, privileges, immunities and appurtenances of whatsoever nature thereunto belonging, unto the said City of Des Moines, Iowa and to its successors and assigns forever.
