Cedar Rapids Chamber of Commerce (www.cedarrapids.org)

- Data extrapolated from the Chamber's Job and Small Business Recovery Fund:
 - 594 small businesses (50 or fewer employees) that have uninsured losses totaling \$129,563,297 or an average of \$218,120 per business.
 - According to the U.S. Small Business Administration (SBA), 54% of business applicants in Iowa have received SBA approvals (however, at least 30% of those are at the 8% rate instead of the 4% rate).
 - According to Senator Tom Harkin's office, the number is closer to 42% as many of the small businesses that were offered the 8% loan rate have had to turn it down as they cannot assume that much additional debt.
 - According to the SBA, there is an overall SBA denial rate of 51% which includes residential, business and non-profits.

Federal Emergency Management Agency (www.fema.gov)

- Deadline requests for <u>Public Assistance</u> extended to September 12, 2008.
- Long Term Community Recovery Inter-Agency Coordination Team (IACT) Meeting
 - o *Development Creative Housing Partnerships* was the primary focus of this meeting due to the significant need for housing assistance for lowans impacted by the disaster.
 - Discussion included the need for comprehensive community planning and continuing assessments and updates as recovery partners continue to identify needs and develop collaborative initiatives that require multiple agencies and resources to successfully address critical housing needs.
 - ESF#14 Long Term Community Recovery (LTCR), in partnership with the Rebuild Iowa Office have deployed 7 LTCR Field Teams to 10 Iowa disaster-impacted communities to identify opportunities for a more effective recovery.
 - o IACT continues to encourage participation of those agencies, departments or organizations that can assist with lowa recovery efforts in order to identify opportunities, create partnerships and maximize resources.
 - o Next meeting is Tuesday, September 9 at 9:00 a.m. CDT in Des Moines location pending.

• CIRAS teams continue to offer solutions to assist manufacturers in exceeding pre-disaster production levels. Examples of assistance include facility layout, materials testing, and education on conducting business with federal, state and local agencies along with identifying current and future procurement opportunities for lowa businesses.

Rebuild Iowa Advisory Commission (RIAC)

- Meeting
 - Commissioners met for a two-day work session to review the reports of the nine task forces.
 - The focused their discussion on the results of the task forces' work and what immediate recommendations should be made in the report to Governor Culver.

- Housing, small business assistance, public health, floodplain mapping and funding topped the list. Also of primary concern was ensuring individuals receive the assistance they need, with several members frequently examining how the broader issues have and will affect people directly.
- o Will finalize its initial 45-day report via telephonic public meeting at 4 p.m. Friday, August 29.
 - Commissioners will review and finalize their initial report, which assesses the state's damages caused by this year's tornadoes, storms and flooding and outline initial recovery effort steps.

Report

- Will include an assessment of the storms' impact on the state's people, schools, businesses and private and public infrastructure, with recommendations for initial steps to be taken by the legislative and executive branches to assist in recovery.
- Another report will be presented to the Governor at 120 days as mandated by Executive Order 7.
- The report will be delivered to Governor Chet Culver on Tuesday, and will be made available to the public through the Rebuild Iowa Office at www.rio.iowa.gov or by calling (515) 242-5004.

Declarations

- o Four more counties Howard, Humboldt, Jackson and Poweshiek are now eligible for Individual Assistance.
- 85 of Iowa's 99 counties designated for federal assistance.
 - 78 counties eligible for Individual Assistance
 - 84 eligible for Public Assistance

Rental Housing Program

- Governor Culver announced that the State of Iowa is setting millions of dollars in federal tax credits to aid the development of affordable multifamily housing in counties that were hit hard by this summer's flooding and severe weather.
- Administered through the Iowa Finance Authority (IFA), the Disaster Recovery Set-Aside program will be funded with nearly \$24 million in federal Low-Income Housing Tax Credits (LIHTC).
- This amount represents approximately 40 percent of IFA's annual allocation of tax credits.
- Tax credits from the Disaster Recovery Set-Aside will be available for construction or rehabilitation of multifamily housing in Linn, Louisa, Black Hawk, Johnson, Muscatine, Butler and Bremer counties.
- FEMA has identified at least \$3 million or more of housing needs in these counties.
- o In the last three years the LIHTC program has helped create no more than 500 rental units in each of them
- Approximately \$13 to \$14 million of the total set-aside amount will be awarded to projects in Linn County.

New College Aid Program

- Governor Culver announced that the Iowa College Student Aid Commission (ICSAC) has created a new, one-time, grant program that will help students affected by this year's flooding and natural disasters.
- The Disaster Relief Grant is a one-time, state-funded grant that will provide assistance of up to \$5,000 to students impacted by the weather-related disasters.
- o The State has committed \$500,000 for the program.

U.S. Small Business Administration (SBA) (www.sba.gov/floods/)

SBA Application for Property Damage Deadline – September 29, 2008

- SBA Application for Economic Injury Deadline February 27, 2009
- SBA Customer Service Representatives (CSR) staffing 1 fixed Disaster Recovery Centers (DRCs).
- Operating 8 Disaster Loan Outreach Centers (DLOCs) throughout the state.
 - SBA Customer Services Representatives are available at each location to meet with homeowners, renters, and non-farm businesses of all sizes to provide program information, help applicants complete paperwork and forms, and to close approved SBA disaster loans.
- SBA has staff at the Joint Field Office (JFO) to coordinate all needs with federal, state, and local partners. SBA has Communication Specialists in the Joint Information Center (JIC) and in the field to handle all SBA media and congressional inquiries.
- Continues to sponsor a Business Recovery Center (BRC) at Westdale Mall in Cedar Rapids, where SBA has assisted over **2,600** visitors at the center.
 - Available to answer specific questions about how a disaster loan may help each business and to help owners' complete business loan applications.
 - Sponsors the availability of multiple additional services at the BRC and there is no charge for any of the services.
 - Business owners may obtain assistance in applying for low-interest SBA Disaster Loans, and gain access to government contracts and procurement through SBA Government Contracting.
 - Iowa Small Business Development Center (SBDC) and SCORE "Counselors to America's Small Business" are providing assistance with reconstruction of lost financial records, development of business plans and cash flow projections, how to obtain lost tax returns and submit casualty loss claims on tax returns, adjusting to market changes as a result of the flooding, tornadoes and severe storms, and other post-disaster counseling services. These services are free and available by appointment.
 - The DRCs and the DLOCs have contact information on how businesses may obtain these same counseling services from their local SCORE chapter, regional SBDC office and the lowa Women's Enterprise Center for businesses that may not be located near the Cedar Rapids BRC.

Masters Champion to Headline Disaster Relief Event at University of Iowa's Finkbine Golf Course

- 2007 Masters Champion Zach Johnson will headline an exhibition at the University of Iowa's Finkbine Golf Course on Friday, Sept. 12, that will raise funds for disaster relief across the state of Iowa.
- The Zach Johnson Iowa Disaster Relief Challenge presented by AEGON USA will feature Johnson, a native of Cedar Rapids and a graduate of Drake University in Des Moines, Chris DiMarco, and Quad Cities-area native Todd Hamilton in a nine-hole challenge that will also feature three of professional golf's rising stars.
- Johnson, DiMarco and Hamilton each will be paired with one of the "young guns" of professional golf in a Ryder Cup-like competition that will cover nine holes of the UI's awardwinning facility.
- The competition will begin at 4 p.m. and will start at Finkbine's No. 1 tee.
- Tickets to the exhibition will cost \$10 with 100 percent of the cost being directed to disaster relief.
- Tickets can be purchased in advance online at hawkeyesports.com, the official World Wide Web site of the Iowa Hawkeyes, at the UI Athletics Ticket Office in Carver-Hawkeye Arena, and by telephone by calling 1-800 IA-HAWKS.
- Earlier in the day and immediately prior to the exhibition as many 32 teams of four amateurs will be paired with an Iowa PGA professional in a pro-am event.
- The cost of a foursome is \$5,000 with 100 percent of the total revenue from the sale of proam positions being directed to disaster relief.
- The winners of the event will be invited "inside the ropes" during the exhibition and to a private dinner after the event.
