On Feb. 5, the Department of Homeland Security's (DHS) Federal Emergency Management Agency (FEMA), in coordination with the interagency Long Term Disaster Recovery Working Group, issued a draft of the National Disaster Recovery Framework (NDRF). You can review the docu-

interagency Long Term Disaster Recovery Working Group, established in October 2009 by President Obama and co-chaired by Secretary of Homeland Security Janet Napolitano and Secretary of Housing and Urban Development Shaun Donovan.

Previously, the Recovery Framework was developed based on input from all levels of government, the private sector, academic and emergency management communities, voluntary and non-profit organizations, and a wide array of associations and organizations.

This input was collected through meetings and briefings across the country, online engagement and a series of video teleconferences and stakeholder forums in five key cities.

Individuals and other interested parties who wish to submit comments can obtain a comment form and instructions for submission by visiting www.regulations.gov, in Docket ID: FEMA-2010-0004. The comment period will close **Feb. 26, 2010**.


