Deadline to Apply for Individual Assistance Approaches; DRCs to Close Soon

The deadline is fast approaching for families and business owners to apply for disaster assistance through FEMA.

Wednesday, Oct. 13, 2010, is the deadline for families and business owners to apply for Individual Assistance for damage caused as a result of severe storms, tornadoes and flooding which occurred June 1 through Aug. 31, 2010.

Individuals may register 24/7 online at www.disasterassistance.gov, or by calling 1-800-621-FEMA (3362) or TTY 1-800-462-7585 from 7 a.m. until 10 p.m. local time, seven days a week.

Families and business owners may also visit a Disaster Recovery Center (DRC) to receive information about available assistance, receive referrals to voluntary organizations to help

with immediate unmet needs, learn cost-effective mitigation measures to reduce the impact of future disasters and learn about Internal Revenue Service programs available to those affected by the disaster.

Homeowners, renters and business owners may also get help completing low-interest loan applications from the U.S. Small Business Administration (SBA).

It is highly recommended that registration is completed prior to visiting a DRC.

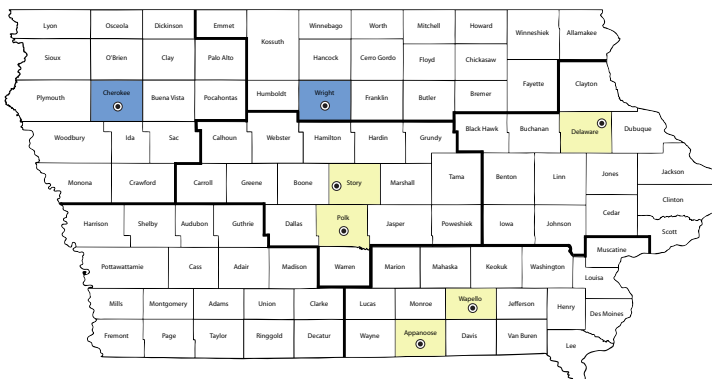
