#### IOWA RECEIVES FEDERAL FUNDS FOR SAFE SCHOOLS

Iowa will receive \$14 million over four years to support efforts to ensure students attend a safe school.

Iowa is one of 11 states to win Safe and Supportive School (S3) grants from the U.S. Department of Education. The grant is to measure school safety at the building level and provide support to schools with the greatest needs. The goal is to create safe and drug-free learning environments, and increase academic success for students in high-risk schools. The funds will be used at targeted high schools to support programs and strategies to improve school safety and student support.

Grant activities include surveys of students, staff and parents to measure a school's safety and environment. The results will lead to School Safety Scores to help the Iowa Department of Education and partner agencies work in collaboration with schools to improve the learning.

### Iowa Core/Common Core use of alignment data

The alignment study between the Common Core State Standards in English/Language Arts and Mathematics and the Iowa Core Essential Concepts/Skill Sets and Details in Literacy and Mathematics, commissioned and completed by the Iowa Department of Education in July 2010, resulted in large data sets. The raw data sets include thousands of rows of information about where the overlaps and gaps between the two documents exist. A summary of the alignment study can be found <u>here</u>. The alignment study was conducted to provide information to:

 Help the lowa State Board of Education make an informed decision about adopting the Common Core State Standards.

• Provide Local Education Agencies and Area Education Agencies with information to help make the transition from their work with the original content of the Essential Concepts/Skill Sets and Details to the Common Core State Standards (i.e., the new, updated version of the Iowa Core for Literacy and Mathematics).

• Assist in identifying a proposal for the "up to 15 percent additional content" to the Common Core, an option that is within the state's purview.



The Iowa State Board of Education subsequently adopted the Common Core State Standards in English/Language Arts and Mathematics, which replaced the original Essential Concepts/Skill Sets and Details of the Iowa Core. Therefore, *spending a lot of time examining the overlaps between the Common Core and the Iowa Core may not be the best use of valuable time and resources.* Primary points to remember about these data are:

• Have confidence that the work you have already started with the Iowa Core is on the right track.

• If you do wish to review the raw data of overlaps, the appropriate use for these data are to explore connections between local district content decisions made within the last two years related to the lowa Core and how that connects with the sections of the Common Core that the lowa Core matches.

The data posted <u>here</u> on the DE website are the unmatched portions of the Common Core and Iowa Core. That is, the content found in the Common Core but not the Iowa Core, as well as the content found in the Iowa Core but not the Common Core. The posted files provide a list of the unmatched content, along with important identifying information (e.g., grade level/ span, strand/discipline information), and are organized by content area. Some important things to keep in mind about the information are:

• It is one of the primary resources being used to determine what, if any, content should be added back to the Iowa Core.

• It may be a helpful resource for districts to use when deciding areas that should no longer be pursued (pending any future adoptions of this content by the lowa State Board of Education).

### **Evaluator Approval Level III**

During the past two years, the Evaluator Advisory Committee represented by schools, area education agencies (AEAs), colleges/universities, School Administrators of Iowa (SAI), Iowa Association of School Boards (IASB), Board of Educational Examiners (BoEE), and the Department of Education (DE) have been meeting to analyze data regarding evaluation, reading and reflecting on research, seeking best practices in evaluation that improve teaching and learning, and designing Evaluator Approval Level III. As the new calendar year approaches, the DE will be unveiling Evaluator Approval Level III for those professionals that will need to renew their administrator/evaluator license and have successfully completed Evaluator Approval Level I and II prior to January 2011. At the same time, the DE will be introducing *iEvaluate* to replace the current Evaluator Approval Level I and II training hosted by the AEAs by combining Levels I and II into an online course.

The training for Evaluator Approval Level III will look somewhat different than the previous training for Evaluator Approval Levels I and II. Beginning January 2012, the four credits required to renew an administrator/evaluator's license will be completed by selecting from a menu of required modules that will enhance the skills necessary to be an effective instructional

leader and evaluator. Each administrator/ evaluator will successfully complete one common learning module - Assessing Academic Rigor – for two required renewal credits.

The additional two credits required to renew an administrative/evaluator license will be earned by selecting from any one of the additional modules: *Fierce Conversations* (currently available in all AEAs), *Increasing the Effectiveness of Leadership Teams* (possible release date Spring 2011), *Employee Discipline/Intensive Assistance* 



Plans, Developing Professional Development Plans that Impact Teaching and Learning, and Leadership Skills for Beating the Odds. Not all modules are fully developed at this time, so it is suggested that individuals watch the DE, SAI, and their respective AEA websites for more information.

The DE does understand that some professionals have already completed two hours of credit toward this renewal and are awaiting information from the DE about future evaluator training to complete the four required renewal credits. To accommodate those individuals, the DE will allow a professional to use hours accumulated prior to December 31, 2011, plus the *Assessing Academic Rigor* module to meet requirements for renewal of administrator/evaluator licensure. Any hours completed after December 31, 2011, other than the required modules may not be used toward renewal.

As of January 2011, the DE will sunset the Level I and II face-to face training for anyone needing an administrator/evaluator license and provide the training through an online course, *iEvaluate – Teacher* or *iEvaluate – Administrator*. The training will continue to focus on the Iowa Teaching Standards, the Iowa Standards for School Leaders, effective evaluation skill sets, the individual professional development plan, ethics, etc. If you are currently in a preparation program at an Iowa college/ university, the necessary training will be a part of your coursework; however, if you are new to Iowa, you will need to complete this newly developed online training that is appropriate to your current position.

### Bullying and discrimination guidance

On October 26, 2010, the federal Department of Education issued guidance, in the form of a "Dear Colleague" letter, to superintendents clarifying when student bullying may also violate federal education anti-discrimination laws. The letter explains educators' legal obligations to protect students from student-on-student racial and national origin harassment, sexual and gender-based harassment, and disability harassment. The letter provides examples of harassment and illustrates how a school should respond in each case.

In August of this year, the Obama administration hosted the first ever National Bullying Summit and launched both the *Stop Bulling Now Campaign* and <u>www.bullyinginfo.org</u>, a national database of effective anti-bullying programs.

#### EdInsight statewide training roll out

EdInsight is the lowa educational data warehouse designed to build a foundation and infrastructure to empower lowa educators to make informed data driven decisions. The Department of Education (DE) will be teaming with the Area Education Associations (AEAs) in a statewide training roll out. Our goal is to get at least one user in each district in lowa trained by the end of the 2010-11 school year, and at least one user in each building trained by the end of the 2011-12 school year.

### 2010-2011 Iowa Demonstration Construction Grant Program

The lowa Department of Education (DE) is pleased to announce the availability of the lowa Demonstration Construction Grant Program (Harkin Grant) in the amount of \$7,287,000 for fire safety and construction which was funded under Catalog of Federal Domestic Assistance (CFDA) number 84.215K, with a budget and project period of October 1, 2010-September 30, 2013.

The grants are awarded on a competitive basis are available to all Iowa public school districts. Applications must be postmarked or received at the Iowa Department of Education by 4:30 p.m., December 17, 2010, for both the Fire Safety and Construction Grant Applications. The DE will hold an ICN session on Wednesday, November 3, 2010 from 10:00 a.m.-12:00 p.m. to review the application process and program.

#### Modified allowable growth for dropout prevention

The application for modified allowable growth for dropout prevention will be available by mid-November on the secure lowa Department of Education EdInfo website. This year, districts will be asked to identify the thresholds/criteria used at a local level to identify potential dropouts. Hopefully, the Proposed Service Summary will look a little different this year. Districts will be asked to identify each program by name, identify the targeted audience and goals/outcomes for each, so that each year districts can track their progress on the Service Summary Report, which is the last form on the application.

#### Iowa Core implementation plans

During August and September, Area Education Agencies (AEAs) and the Iowa Department of Education (DE), supported a process for districts and non-public schools to discuss and review their Iowa Core Implementation Plans with other school leaders. Over 267 districts and non-public schools participated in the process, and 94% of them indicated that the peer review process was helpful. Respondents were also given the opportunity to provide feedback to the AEAs and DE regarding their next steps and what supports they needed. This data will be used to shape future planning with the roll-out of the Iowa Core.

### Positive Behavioral Interventions and Supports (PBIS)

Positive Behavioral Interventions and Supports (PBIS) are a multi-tiered continuum of supports for all students in the school environment. Supported by the Iowa Department of Education, PBIS provides schools with the framework and organizational plan to promote and maximize academic achievement and behavioral competence for all students, including those students needing supplemental or intensive supports.

The Office of Special Education Programs (OSEP) Technical Assistance Center on Positive Behavioral Interventions and Supports (PBIS) indicates there are 13,300 schools implementing PBIS in the United States and other countries including Australia, Ireland, and Canada. Since 2002, PBIS has continued to grow in Iowa and currently over 300 schools are implementing PBIS in 107 districts around the state. #### Environmentally preferable cleaning products mandate

House File 823, signed by Governor Culver on April 23, 2010, is an Act requiring public schools, community colleges, institutions under the control of the state board of regents, and state agencies to comply with an environmentally preferable cleaning and maintenance policy unless specified conditions for noncompliance are satisfied. Environmentally preferable cleaning products protect students and staff by reducing exposure to toxic chemicals, protects ground water systems, and reduces indoor air pollution.

Green cleaning products can be as effective as traditional cleaning products and can be competitively priced to be essentially cost-neutral when compared to their traditional counterparts. Each school district, community college, regents institution, and state agency utilizing a state building shall conduct an evaluation and assessment regarding implementation of an environmentally preferable cleaning policy.

A school district may opt out of compliance to use green cleaning products based upon the evaluation and assessment. School districts should contact their cleaning products vendor about doing an evaluation and assessment of their cleaning and maintenance program.

School districts have until July 1, 2012 to opt out of purchasing only cleaning and maintenance products identified by Iowa Department of Administrative Services (DAS) or meet nationally recognized standards. To opt out of compliance requires an affirmative vote of the school district's board of directors. School districts opting out of compliance need to notify Gary Schwartz at the Iowa Department of Education by submitting school board minutes/ resolution and assessment summary.

### License and endorsements for preschool teachers

All Statewide Voluntary preschool Program (SWVPP) districts must ensure that teachers in all settings and partnerships currently hold an appropriate teacher license including an early childhood endorsement. Some teachers may be licensed and hold a Class B Conditional endorsement for early childhood education. It is important that districts continue to monitor the progress of these teachers in achieving an endorsement. Failure to do so will jeopardize preschool funding and may possibly result in an ethics violation. #### Data requirements for Statewide Voluntary Preschool district

All Statewide Voluntary Preschool Program (SWVPP) districts must ensure that 2010-2011data is entered on the *Early Childhood Application*. This information is submitted through the Iowa Department of Education (DE) Reporting Site or EdInfo. Data provided by districts through this venue addresses assurances delineated in Chapter 16 such as appropriately licensed teacher, a minimum of 10 hours of instruction, collaboration with partners, integration of other preschools and professional development.

Also included in this reporting is confirmation of Head Start Program Performance Standards and National Association for the Education of Young Children Standards and Criteria Accreditation for districts following these two standards. #### Preschool Grant Award newly awarded districts

Districts should anticipate the following steps to occur prior to receipt of the Preschool Grant Award:

- The Iowa Department of Education (DE) will analyze the data from EASIER and the Early Childhood Application.
- In November 2010, an email will be sent to the superintendent and contacts of the newly awarded districts providing the number of children and the amount of funding the districts will receive.
- In November 2010 agreements between the DE and each district will be sent to the district superintendent for signatures. The agreement must be signed by the board president/designee, superintendent, and business manager.
- When the DE has received the signed agreement from the district, a check for one-half of the Preschool Grant Award will be processed and issued.



• In January 2011, the second half of the Preschool Grant Award will be issued.

### Student Health and Nutrition Seasonal influenza at school, 2010-2011

lowa Department of Public Health has resources for use in your school, posting on your website and distribution to the community, school personnel, parents, and students. *Guide for Influenza-Recommendations for Schools* contains facts including information about influenza symptoms, emergency warning signs, infectious period, how to prevent the flu, if you get the flu, vaccination, who should get vaccinated, the nasal vaccination, and what should be done to prevent and reduce flu at school. *Control of Influenza and Other Respiratory Outbreaks in Schools* fact sheet contains information about influenza in schools, infectious period, key intervention measures for schools to reduce transmission and potential outbreaks of influenza and other respiratory diseases, and reporting school absences due to illness 10% and above.

The Centers for Disease Control and Prevention and the U.S. Department of Health and Human Services also provides the *Guidance for School Administrators to Help Reduce the Spread of Seasonal Influenza in K-12 Schools during the 2010-2011 School Year*, which illustrates ways to help reduce the spread of seasonal influenza (flu) among students and staff in K-12 schools during the 2010-2011 school year. *How To Clean and Disinfect Schools To Help Slow the Spread of Flu* provides information on cleaning and disinfecting as part of a broad approach to preventing



infectious diseases in schools. To help slow the spread of influenza (flu), the first line of defense is getting vaccinated. Other measures include covering coughs and sneezes, washing hands, and keeping sick people away from others. ### Bed bugs fact sheet available

An lowa Department of Public Health, Division of Environmental Health fact sheet states, "Bed bugs are small insects without wings. At one time they were almost eliminated from the United States. However, currently are found in all 50 states including lowa. Bed bugs are not known to spread disease. Bed bug bites usually will cause large itchy welts on the skin. These welts may not appear for 24 to 48 hours after the bite." ### Tobacco use-free policy encouraged

A few weeks ago all district superintendents and nonpublic administrators received information from the lowa Department of Public Health (IDPH). This packet contained important information regarding the need for districts and schools to review their local policies on tobacco use. Although the law today requires a district and school properties to be smoke free, it does not make the use of other tobacco products illegal on school property.

The tobacco industry is ever-changing as seen in the products on the market today. For example, no longer does a tobacco user need to get nicotine from a cigarette or chew. Today, a person can pop in a dissolvable nicotine product that looks like a breath strip, toothpick or small candy. Chew can also be contained in a small tea bag-like pouch and hidden in the mouth – no spittoon necessary!

Although your initial reaction may include "what harm does a smoke-free product have to students?" Or "why would we monitor the use of these products by staff, parents or visitors?" The answer is easy if we keep in mind what is best for our students. Not only are these smoke-free products marketed for young adults, but having role models using these products will only encourage their popularity and use with students.

The lowa Department of Education along with IDPH encourages you to review your current policy and change any smokefree policy you have in place to a comprehensive tobacco use-free policy. The information your district received contains a model policy checklist to assist you in the process.

This annual training of Level One investigators of allegations of abuse of students by school employees was held October 4, 2010. Any Level One investigators who missed the training may contact the local Area Education Agency (AEA) for tapes of the session. #### Student Member of State Board of Education

Applications for the student member to the State Board of Education will be available on the Department's Web site within a few weeks. The term of the student member starts May 1, 2011, and ends April 30, 2012. The Board meets approximately seven times each term, with most meetings taking place in the Grimes State Office Building in Des Moines. The deadline for submitting an application with all required documents is February 4, 2011.

Besides being a full-time, regularly enrolled 10<sup>th</sup> or 11<sup>th</sup> grade student in a public high school, the student must meet these requirements:

- Has a GPA of at least 3.0 (4.0 scale) or 3.75 (5.0 scale)
- Has attended his/her present high school at least the past two consecutive semesters (or the equivalent thereof)
- Demonstrates participation in extracurricular and community activities, as well as an interest in serving on the board

The application and all required supporting documentation are available here.

#### And Now, for Something Completely Different

Answers to inquiries frequently received by DE staff:

- The state does not require a specific number of supervisors to watch the students during recess. •
- The state does not regulate whether recess should be supervised by licensed staff.
- The state does not regulate when the temperature is too hot/cold for schools to have outside recess.
- The state does not require schools to provide recess at all. [The Healthy Kids Act, of course, requires that students be • physically active, but nothing in state or federal law requires recess.]
- There is no minimum number of restrooms for students in a school building specified in state or federal law.
- The DE cannot provide a person with a duplicate of the high school diploma that the recipient may have lost. •
- The DE cannot fire local coaches, teachers, administrators,
- There is no "recall" in Iowa for local school board members who do not vote the "right" way.
- There is indeed a word for the process that allows local school board members to vote as they see fit: democracy.
