Budget update

The legislature adjourned on March 30, which means that the IDPH Executive Team is now in the process of working through budget-related issues. We are currently reviewing all final appropriations language, funding, and FTE allocations to determine the potential impacts on services and staff. At this time, I do not know if a reduction in force will need to be considered. However, here's what we do know about the Department's FY2011 budget:

- The department received \$3 million in one-time stimulus funding for FY2010 that is not available in FY2011. The stimulus funding in FY2010 was used to plug gaps in funding for critical public health services and reduce lay-offs.
- The Department's State General Fund appropriations for FY2011 were reduced by \$2,108,366 or 3.58 percent.
- The combined funding reduction, when taking the one-time stimulus funding into account, is \$5,108,366.
- The legislature did not fund salary adjustments in the standings bill. The
 department will have to identify funding within the existing FY2011 budget to
 cover merit increases and cost-of-living adjustments (COLA) for contract
 employees. Language passed in the Standings Bill prohibited merit increases and
 COLA for non-contract employees.

Closely connected to budget, the Governor's Office and the Department of Management are beginning to work with the cost saving strategies outlined in Executive Order 20 and the government reorganization bill. Over the next few weeks, I expect we will have a better understanding as to how the department will be impacted.

More than 30 IDPH retirements expected by June 24

By June 24, the Iowa Department of Public Health (IDPH) anticipates losing 32 employees due to the State Employee Retirement Incentive Program (SERIP). It has been my great pleasure to serve with these individuals, some of whom I have known since I entered the field of public health. Bidding them farewell has been and continues to be especially hard.

While this unprecedented exodus of so many dear friends and colleagues will be difficult, it also presents us with some unique opportunities. In the coming weeks, the Executive Team will be making some tough choices about which positions can be filled. This will no doubt, affect our partners in one way or another. But such is the dynamic nature of public service, and public health in particular. I am confident that this process will make us all stronger and more flexible as we go about our important work of promoting and protecting the health of Iowans.

New program protects environment, prevents drug abuse

A new solution for the disposal of unused or expired medications is appearing in pharmacies across the state. Supported by the Iowa Pharmacy Association, the "TakeAway" program is an important advancement in protecting the health of Iowans. Not only do improperly discarded medicines often find their way into our water supply, but they also pose a danger to those who might abuse them. The Office of National Drug Control Policy reports that prescription medications are the drug of choice among 12- and 13-year olds, while a third of all new abusers of prescription meds are between the ages of 12 and 17.
