Delivery of 2010 – 2012 Iowa WIC Approved Foods Flyers

The 2010-2012 Approved Foods are in production at this time, they will not be delivered until the second or third week of October. A printed listing of the approved foods is available in policy 235.20.

Major Changes to the approved food list include:

- Refrigerated Orange Juice -- <u>NEW item</u>
 - \circ $\;$ Any brand of 100% refrigerated orange juice $\;$
 - o 64-ounce container
- Tofu -- NEW item
 - 12 to 16 ounce packages
 - No Organic product
 - ONLY approved brand is House Foods
- Soy Beverage -- <u>NEW item</u>
 - 64-ounce container (1/2-gallon)
 - o 8th Continent Original Soymilk is the ONLY approved brand
 - UPC code 0-53859-070660-3
- Whole Wheat Bread
 - Additional "brands"
 - Review listing for all approved items.
- Soft Corn (Yellow and White) and Whole Wheat Tortillas
 - Added Whole Wheat Tortillas
 - Review listing for all approved brands
- Peanut Butter
 - Honey roasted is not authorized
 - Reduced fat Peanut Butter is not authorized

REMINDER

- Milk reminder, the Program only issues Whole milk and 1% / Skim reduced fat cows' milk.
 o Iowa does not issue WIC checks for 2% Milk.
- Baby Fruits and Baby Vegetables reminder ONLY the 4-ounce containers are authorized.
 o Iowa WIC DOES NOT allow the purchase of the 3.5 Twin pack.

Training CD's and Clerk's Guides to WIC DVD's have been distributed to Grocery and Special Purpose Vendors. Grocery vendors have also received copies of policy 235.20.

The Program is also creating a multi-color "How to Use Your WIC Check" poster.
