# From the WIC Services Policy and Procedure Manual — 380.01 Nutrition Services Documentation

Documentation provides valuable information for managing and evaluating services delivered to program participants. The policy describes the purpose of nutrition services documentation, elements of quality documentation, and where required nutrition services documentation can be found in a participant's electronic record.

Documentation is the primary means WIC staff use to communicate with each other about services provided and/or planned for individual participants. The purpose is to insure the:

- Quality of nutrition services (identifying risks and/or participant concerns and facilitating followup and community of care), and
- Integrity of program services (documenting data used for eligibility determination and federal reporting requirements).

# SimplyThick: Public Health Notification - Risk of Life-Threatening Bowel Condition

AUDIENCE: Consumers, Pediatrics, Emergency medicine

**ISSUE**: FDA notified parents, caregivers and health care providers not to feed SimplyThick, a thickening agent for management of swallowing disorders, to infants born before 37 weeks. The product may cause necrotizing enterocolitis (NEC), a life-threatening condition characterized by inflammation and death of intestinal tissue.

**BACKGROUND**: FDA first learned of adverse events possibly linked to the product on May 13, 2011. To date, the agency is aware of 15 cases of NEC, including two deaths, involving premature infants who were fed SimplyThick for varying amounts of time. The product was mixed with mothers' breast milk or infant formula. Illnesses have been reported from at least four different medical centers around the country. The illnesses of which FDA is aware involve premature infants. SimplyThick was added to the feeding regimen of those infants, who later developed NEC, to help with swallowing difficulties stemming from complications of premature birth.

The product is sold in packets of individual servings and in 64-ounce dispenser bottles. The product can be purchased from distributors and local pharmacies throughout the United States.

**RECOMMENDATION**: Health care providers should stop administering the product to premature infants. Parents and caregivers who have questions or concerns related to the use of the product and/or who have medical concerns should contact their health care provider. #### Enfamil EnfaCare – Change in Can Size

Enfamil EnfaCare powdered formula will be changing its can size from a 12.8 oz can to a 15.1 oz can. Most stores will probably not have the new size on the shelf until September, however some stores may see the product in August. The food instrument description will change on June 1<sup>st</sup> to the following: Containers 12.8 oz OR 15.1 oz Powder EnfaCare.

#### EBT Update

#### **Michigan EBT Visit**

The State WIC EBT team visited Michigan's online EBT system this week. The team had the opportunity to meet with Michigan state staff, a local WIC clinic, and a couple grocery stores. All state and local Michigan staff had very positive comments regarding the EBT process. Since Michigan is an online EBT state, when a participant uses their EBT card, clinic staff are immediately able to see in their EBT system what benefits the participant has left.
