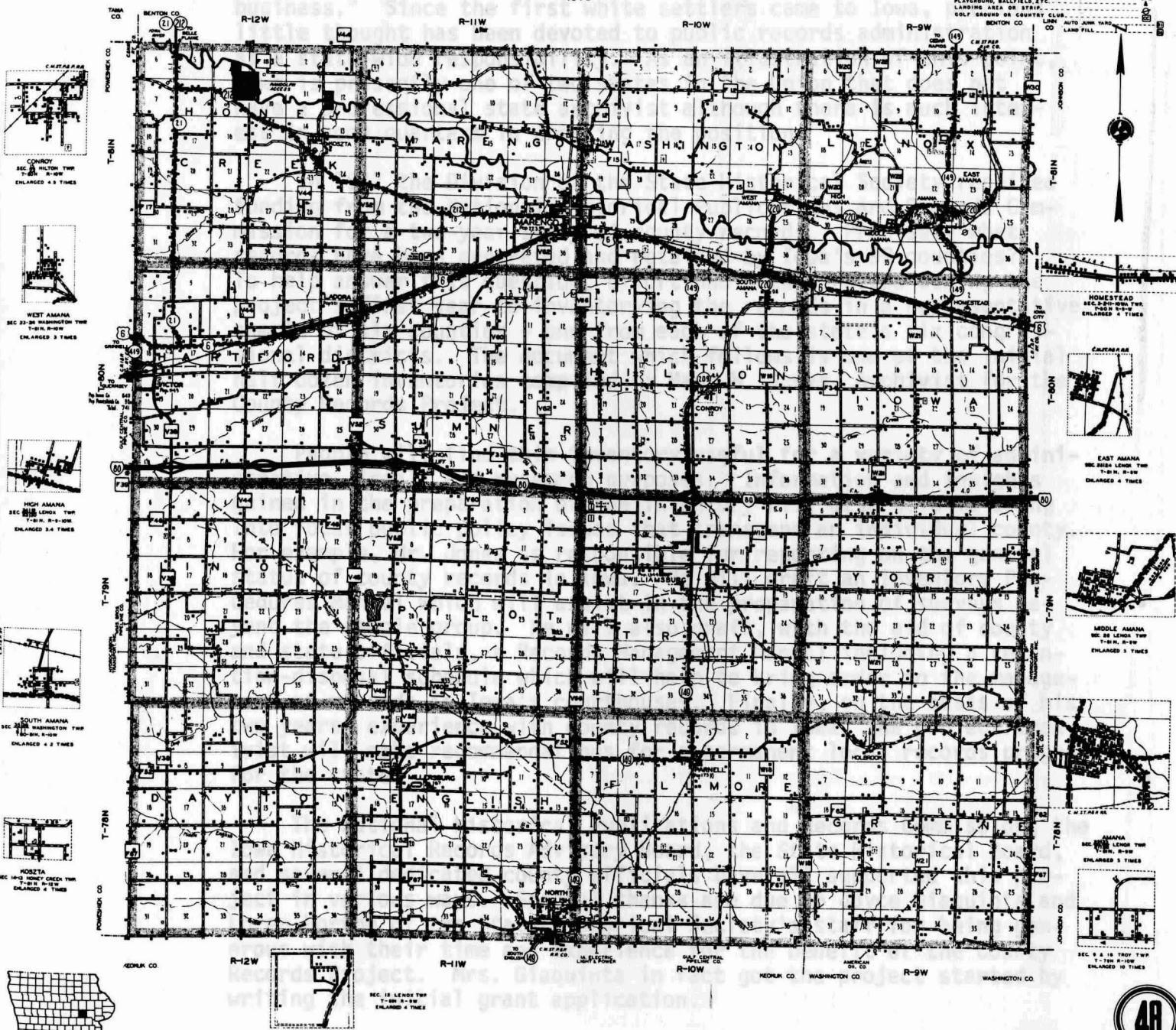

An old saying goes, "What's everybody's business is nobody's business." Since the first white settlers came to Iowa, precious little thought has been devoted to public records administration as a state-wide responsibility. As an illustration of this point, Iowa is presently one of two states in the Union that does not have a professional state archivist although there is much interest in some quarters in creating the position.

In 1977 the Division of the State Historical Society received funding from the National Historical Publications and Records Commission for a two-year study of county records. Precisely what records have been generated and retained by Iowa's 99 counties? To help answer this question, effort has been directed during the project's first year to inventorying the records in a representative sample of six counties - one from each of the state's six congressional districts. The document which follows is one of the initial half dozen inventories compiled by Mark H. Jones, Archivist for the County Records Project.

People will find this inventory useful for a variety of administrative, legal, and research purposes. Information and insights gained in the preparation of the inventory will also help to bring into focus public policy issues that transcend an individual county. For example, Mr. Jones is responsible for reporting on the general status of county records in Iowa. He will draft an Inventory Procedures Manual which will assist in the preparation of surveys beyond the sample group. He will also draft, with the aid of county and state officials, a Records Management Manual including a retention-disposal schedule which will help to bring order to the management of records in Iowa's courthouses. Finally, on the basis of his two years' experience with county records in Iowa, the project archivist will make recommendations for a permanent local records program for the state.

The National Historical Publications and Records Commission, the Iowa Historical Records Advisory Board, the State Historical Board, and several dedicated county officials have all supported this project in various ways. Special thanks are due to Joyce Giaquinta and Loren Horton of the State Historical Society's staff for being generous with their time and experience for the benefit of the County Records Project. Mrs. Giaquinta in fact got the project started by writing the initial grant application.

## Introduction

Iowa County was created in 1843 and organized in 1845.

Marengo is the county seat. County offices and records are located in the courthouse, built in 1892-1893, and in the nearby Assessor's Annex.

Within the courthouse records are stored in the following rooms:

Ground Floor: Clerk's Vault; Sheriff's Office; Auditor's Storage Room.

First Floor: Auditor's Office and Vault; Clerk's Office and Vault; Magistrate's Office; Recorder's Office and Vault; Treasurer's Office and Vault; Treasurer's Vault, Hall.

Second Floor: Engineer's Offices and Drafting Room.

Attic

Only records in the Recorder's Office are currently being placed on microfilm. The Recorder microfilms all current filed instruments with a camera located in his office and sends the reels to Hall and McChesney Inc., Syracuse, New York. Hall and McChesney send back copies of the instruments and store the film as a security copy.

The Recorder recently engaged Hall and McChesney to compile an index of instruments filed. He describes the system in the following paragraph:

The indexing system process begins by typing the information on special forms. The top sheet of the form is mailed to the company. A computer scans the form and the information is entered into the computer. The second page of the form is a series of strips. When the information is on the forms the strips are removed and placed in a temporary bound index. The third part of the form is a triplicate copy that matches what was mailed to the company. If the company has any questions about an instrument, they may call and refer us to the exact point in question.



Under this system, the alphabet is broken into 195 parts. When I ask for my final computer print-out, the company will provide it in a bound volume. It will be in true alphabetical order and the corporations will be separate from peoples names. The information also is stored in the computer. If anything should happen to our records, they could reproduce the information immediately. I can also call for a combined print-out every five years or whatever time period I choose which will also be in alphabetical and chronological order.

The following inventory was taken during the period of January 17-30, 1978. Entries are arranged according to the office of origin with the exception of County Auditor, REPORTS and County Treasurer, TAXATION, SPECIAL ASSESSMENTS, TOWNS AND CITIES. Offices are arranged according to those elected (Auditor, Clerk of Court, Recorder, Sheriff, and Treasurer) and those appointed by the Board of Supervisors (Assessor, Engineer, Medical Examiner). Entries for Auditor are grouped in one section under three broad headings which reflect the legal areas of responsibilities faced by this officer: Auditor; Auditor as Commissioner of Elections; Auditor as Clerk, Board of Supervisors. Within office sections entries are arranged according to alphabetical order except for MISCELLANEOUS, which appears at the end of sections.

Other arrangement problems are handled in the following ways. Entries for the Coroner's records are placed under the Medical Examiner. Magistrate's records are found within the Clerk's section. Records for the defunct Superintendent of Schools are listed in the last section of the inventory. Board of Health Papers fall under County Auditor, REPORTS FROM OTHER OFFICER AND AGENCIES. The Soldier's Relief Commission's Armed Forces Graves Registration Record is found under the county Auditor, MISCELLANEOUS.

The following rules apply to the entries:

1. The first part of an entry represents the actual, latest title found on bindings, drawers, and boxes or within the series. Titles enclosed in brackets were generated by the surveyor. Information within single parantheses ( ) completes the actual title or gives other titles found in the record series. Information within double parantheses (( )) includes explanatory material or titles of several instruments found in the record series.
2. Dates generally represent inclusive filing dates or dates of entry. "ca." before a date indicates an approximation. N.D. means No Date.
3. The third piece of information gives the quantity and/or receptical of the record series. Absolute measurements were not obtained. A record series listed as 1/4 cu. ft., for example, indicates an approximate measure of loose documents. One drawer or three boxes may indicate the total quantity of the record series or that the series is found in these three containers.
4. Index: Within Series means that every volume or box within the record series contains an index. Index: Partial Within Series indicates that only a few volumes contain indexing. Indexes separate from record series are noted by title, dates and quantity.
5. Floor and room locations represent area of storage at the time of the inventory. The following code is used in the entries and appears after the notation of indexing.
